LOCATION.--Lat 33°56'29.05", long 78°11'56.22", Hydrologic Unit 03040207, 1 mi north of Sunset Harbor, and 4.3 mi south of State Highway 211 on Secondary Road 1112. Owner: DENR (North Carolina Department of Environment and Natural Resources).

AQUIFER.--Surficial Aquifer.

WELL CHARACTERISTICS.--Drilled observation well, drilled to 15 ft, diameter 4 in., cased to 10 ft, screened interval from 10 to 15 ft.

INSTRUMENTATION.--Water-level recorder collecting data at 60-minute intervals. Satellite telemetry at station.

DATUM.--Land-surface datum is 28.06 ft above NGVD of 1929 (levels by DENR). Measuring point: Top of collar on casing, 2.65 ft above land-surface datum.

REMARKS.--Well is part of Brunswick County Groundwater project.

PERIOD OF RECORD.--January 1987 to September 1997, October 2000 to current year.

EXTREMES FOR PERIOD OF RECORD.--Highest water level recorded, 0.19 ft above land-surface datum, Sept. 12, 13, 1996; lowest water level recorded, 9.86 ft below land-surface datum, Sept. 23, 2003.
