LOCATION.--Lat 35°31'47.9", long 77°19'35.9", Hydrologic Unit 03020203, 0.2 mi west of State Highway 43 on Secondary Road 1711 at Conley High School, and 6 mi southeast of Greenville. Owner: DENR (North Carolina Department of Environment and Natural Resources).

AQUIFER.--Peedee aquifer of Late Cretaceous age.

WELL CHARACTERISTICS.--Drilled observation well, drilled to 132 ft, diameter 4 in., cased to 122 ft, screened interval from 122 to 132 ft.

INSTRUMENTATION.--Water-level recorder collecting data at 60-minute intervals.

DATUM.--Land-surface datum is 69 ft above NGVD of 1929 (from topographic map). Measuring point: Top of instrument shelf, 3.63 ft above land-surface datum.

REMARKS.--Well is part of areal-effects network.

PERIOD OF RECORD.--June 1984 to current year.

EXTREMES FOR PERIOD OF RECORD.--Highest water level recorded, 17.84 ft below land-surface datum, May 24, 1989; lowest water level recorded, 24.96 ft below land-surface datum, Aug. 25, 2002.
