# THINGS VOTERS KNOW

#### PHOTO ID IS NOW REQUIRED TO VOTE IN PERSON IN ALL TEXAS ELECTIONS

Texas' photo ID requirements are now in effect. Those voting in person, whether voting early or on Election Day, will be required to present one of 7 acceptable forms of photo ID issued by either the Texas Department of Public Safety (DPS) or the United States Government. A list of acceptable forms of identification can be found in "What do I take to the Poll" on page 2 of this *Voters Guide*. Photo ID will not be required in order to vote by mail.

Should you encounter any problems at the poll, remember that you may always cast a Provisional Ballot. You may also contact the County Clerk's office at 713.755.6411, the Texas Secretary of State Election Division at 1.800.252.8683, or the United States Department of Justice at 1.800.253.3931 or Voting.Section@usdoj.gov if you believe that your right to vote is being denied unlawfully.

#### **EARLY VOTING AND BALLOTS-BY-MAIL**

The dates for Early Voting by Personal Appearance are Oct 21 - Nov 1. Early voting polling locations and early voting hours can be found on page 23 of this *Voters Guide*. Any registered Harris County voter may cast an early ballot at any early voting location in Harris County.

Some voters qualify to vote by mail. The request for a mail-in ballot must be received by the County Clerk's office by **October 25**. Except for mail ballots coming from overseas, all voted mail ballots must arrive at the County Clerk's office by 7:00 p.m. on Election Day. For complete details and to see if you qualify, see "When can I vote" on page 2 of this *Voters Guide*.

# SAVE TIME ON ELECTION DAY - CHECK OUT YOUR PRECINCT POLLING PLACE LOCATION BEFORE YOU HEAD TO THE POLL

On Election Day you MUST vote at the location that is designated for your precinct. Although during early voting you may vote at any one of the 40 early voting locations in Harris County, on Election Day, Tuesday, November 5, you MUST vote in your precinct. Your precinct number appears on your Voter Registration Certificate (VRC). To get a list, by precinct, of election day voting locations go to <a href="https://www.harrisvotes.com">www.harrisvotes.com</a> or call the Harris County Clerk's office at 713.755.6965. This information also appears in the Houston Chronicle prior to Election Day.

For more than 90 years, the League's mission has been to support active and informed citizen participation in government. The League believes that voting is a vital part of *Making Democracy Work*.

The League of Women Voters of Houston Education Fund publishes the *Voters Guide* to help each voter cast an informed vote. Inside you will find information about the voting process, the duties and responsibilities of the offices that are included in this election, the names of candidates and their responses to

selected policy questions. This publication also includes ballot issues being offered for voter consideration.

The responses provided by candidates are reproduced without editing or verification. Each candidate is personally and solely responsible for the content of his/her response. Candidates are listed in the order in which they will appear on the ballot. (More about the process used to assemble this *Voters Guide* can be found on page 3.)

No portion of this *Voters Guide* may be reproduced for use in political campaigns or advertising. Other proposed uses are permitted only with advance written authorization of the League of Women Voters of Houston Education Fund.

#### VOTER INFORMATION

#### Can I register to vote?

You are eligible to register to vote if:

- You are a United States citizen;
- You are a resident of the county where you submit the application;
- You must be at least 17 years and 10 months old to register, and you must be 18 years of age by Election Day;
- You are not a convicted felon (you may be eligible to vote if you have completed your sentence, probation, and parole); and,
- You have not been declared by a court exercising probate jurisdiction to be either totally mentally
  incapacitated or partially mentally incapacitated without the right to vote.

#### How do I register to vote?

Each county has a Voter Registrar. In Harris County the Voter Registrar is the County Tax Assessor-Collector. You may register in person at 1001 Preston Avenue — 1st Floor, Room 100, in downtown Houston; any of 16 Tax Office substations throughout the County <a href="http://www.hctax.net/Default">http://www.hctax.net/Default</a>; any Texas Department of Public Safety Office (DPS); or several other state agency offices. Or you can mail in your application to Mike Sullivan, Tax Assessor-Collector and Voter Registrar, P.O. Box 3527, Houston, 77253-3527. Applications are available at all of these locations, online at <a href="https://webservices.sos.state.tx.us/vrapp/index.asp">https://webservices.sos.state.tx.us/vrapp/index.asp</a>, by emailing tax\_office@hctx.net or by calling 713-368-VOTE (8683) to request one via mail. During voter registration drives you can register with a deputized volunteer voter registrar. The last day to register to vote in the November 5, 2013 Uniform Election is October 7, 2013.

After you register, you should receive your Voters Registration Certificate (VRC) within 30 days. Every 2 years you will be mailed a replacement VRC. To maintain your registered status you must notify the Voter Registrar of any address or name change.

#### Where do I vote?

During the Early Voting Period, October 21 — November 1, 2013, you may vote at any of the designated Early Voting Locations. Go to page 23 for a list of these locations. They are posted online at <a href="http://www.harrisvotes.com">http://www.harrisvotes.com</a> or you can call 713.755.6965.

On Election Day, you must vote in the polling location designated for your precinct of residence. Polling locations for each precinct usually are listed in the newspaper the week of the election. Also, they are online at <a href="http://www.harrisvotes.com">http://www.harrisvotes.com</a> or you can call 713.755.6965.

#### Where do I find my Precinct Number?

Your Precinct Number (Pct. No.) is in the middle of the left side of your Voter Registration Certificate (VRC). Check the precinct number on your VRC before going to the polling location. Or, you can contact the Voter Registrar at 713-368-VOTE (8683) or <a href="http://www.hctax.net/voter/Search">http://www.hctax.net/voter/Search</a>. Enter your name in the blank space.

#### New! What identification will be required at the Poll?

A voter will be **required** to show one of the following forms of **photo identification** at the polling location before the voter will be permitted to cast a vote.

- Texas driver license—unexpired or expired less than 60 days issued by the Texas Department of Public Safety (DPS)
- Texas Election Identification Certificate (EIC) issued by DPS. For more information on the EIC application process enter <a href="http://www.txdps.state.tx.us/DriverLicense/electionID.htm">http://www.txdps.state.tx.us/DriverLicense/electionID.htm</a>
- Texas personal identification card issued by DPS—unexpired or expired less than 60 days
- Texas concealed handgun license issued by DPS—unexpired or expired less than 60 days
- United States military identification card containing the person's photograph unexpired or expired less than 60 days
- United States citizenship certificate containing the person's photograph
- United States passport—unexpired or expired less than 60 days

If a voter does not present proper identification, the voter will still be permitted to vote provisionally. The voter will have six (6) days to present proper identification to the county voter registrar for the voter's ballot to be accepted.

Exemption/Exceptions to the photo identification requirements:

Voters with a disability may <u>apply</u> with the county voter registrar for a **permanent exemption**. The application must contain written documentation from either the U.S. Social Security Administration evidencing he or she has been determined to have a disability, or from the U.S. Department of Veterans Affairs evidencing a disability rating of at least 50 percent. In addition, the applicant must state that he or she has no valid form of photo identification. Those who obtain a disability exemption will be allowed to vote by presenting a voter registration certificate reflecting the exemption. Please contact your voter registrar for more details.

Voters who have a consistent **religious objection** to being photographed and voters who do not have any valid form of photo identification as a result of certain natural disasters as declared by the President of the United States or the Texas Governor, may vote a provisional ballot, appear at the voter registrar's office within six (6) calendar days after election day, and sign an <u>affidavit</u> swearing to the religious objection or natural disaster, in order for your ballot to be counted.

#### What else should I take to the Poll?

It's recommended you also take your Voter Registration Certificate issued by the Voter Registrar as it contains useful voter information.

You can take this *Voters Guide* or other written material into the Voting Booth. However, voters are not allowed to display or share any campaign material in the polling place.

# New! What will be the procedures for voting under the new photo identification requirements?

When a voter arrives at a polling location, the voter will be asked to present one of the seven (7) acceptable forms of photo ID. Election officials will now be required by State law to determine whether the voter's name on the identification provided matches the name on the official list of registered voters ("OLRV"). After a voter presents their ID, the election worker will compare it to the OLRV. If the name on the ID matches the name on the list of registered voters, the voter will follow the regular procedures for voting.

If the name does not match exactly but is "substantially similar" to the name on the OLRV, the voter will be permitted to vote as long as the voter signs an affidavit stating that the voter is the same person on the list of registered voters.

If a voter does not have proper identification, the voter will still be permitted to vote provisionally. The voter will have (six) 6 days to present proper identification to the county voter registrar, or the voter's ballot will be rejected.

# What if my name is not on the list of registered voters and the Voter Registrar has no record of my registration but I think I have registered?

If your name is not on the list and you think you have registered, the Precinct Judge will contact the Voter Registrar. If the Voter Registrar cannot verify your registration, you may vote a "provisional ballot." First, you must complete an affidavit stating that you are a registered voter in the precinct in which you are attempting to vote and that you are eligible to vote in this election and you must present valid identification. Your ballot will be counted only if state or local officials determine you are eligible under State law. You will receive a letter after the election notifying you whether your provisional ballot was accepted or rejected.

#### What is "provisional voting"?

#### What can I vote on in this election?

If you are a resident of the City of Houston, you may vote for candidates running for Mayor, Controller, and City Council. If you live in an area zoned to the Houston Independent School District Board or Houston Community College, you may vote for members of their Boards of Trustees. Since not all Board Positions will be voted on in this election, you will have to check your specific ballot. There are also 9 state propositions that will be voted on by voters in all jurisdictions. Two Harris County propositions will be on the ballot. Several Independent School, Municipal Utility and Improvement District elections are on the ballot in their jurisdictions, however, they are not included in this *Voters Guide*. To find out which City Council, HISD or HCC Districts you are in, go to <a href="https://www.hctax.net/voter/Registration">https://www.hctax.net/voter/Registration</a> and on the highlighted bar click Voter Registration. On drop down list, click Voter Registration Search. In blank space enter your name and click highlighted Search button. Scroll down to your information and click your Certificate Number. You will see an image of your VRC and additional information with precinct and district numbers. Or call the Voter Registrar, 713.368.VOTE (8683), or the County Clerk's Voter Information Line, 713.755.6965.

The County Clerk's Elections Office has Your Specific Ballot on line at <a href="http://www.harrisvotes.com">http://www.harrisvotes.com</a>. You may view which races and candidates will be on your specific ballot. See instructions pages 3 and 22. To obtain this information via telephone, call 713.755.6965, the County Clerk's Voter Information Line, during regular hours.

#### When can I vote?

You may vote:

- On Election Day at your assigned precinct's polling place.
- Early at designated times and locations from October 21 November 1, 2013 see schedule on page 23.
- By ballot-by-mail if you are at least age 65, disabled, confined in jail, or if absence from the county will prevent you from voting early or on Election Day. For this election your application to get a ballot-by-mail must be received between September 6 October 25, 2013 (received, not postmarked), and you must follow the requirements for voting by mail. Contact the County Clerk's Office, 713.755.6965 or visit <a href="http://www.harrisvotes.com">http://www.harrisvotes.com</a> to print an application for a ballot-by-mail.

# How does a student who is a registered voter and attends school outside the county vote?

- A student can return home to vote on Election Day or during the Early Voting Period.
- A student can vote absentee by using a ballot-by-mail. For ballot-by-mail instructions, see the answer to the previous question.

#### What do I do if I change my address and still live in Harris County?

Change your address online at <a href="https://txapps.texas.gov/tolapp/sos/SOSACManager">https://txapps.texas.gov/tolapp/sos/SOSACManager</a> or in writing by completing a voter registration application form or by correcting the information on your current Voter Registration Certificate and returning it to the Harris County Voter Registrar. Voter registration application forms also are used for changes and are available from the Voter Registrar, 713.368.VOTE (8683), or the Texas Secretary of State's office, 1.800.252.8683, and online at <a href="http://www.sos.state.tx.us./elections/voter/regvr.shtml">http://www.sos.state.tx.us./elections/voter/regvr.shtml</a>.

You will be able to vote in your new precinct 30 days after your notice has been received by the Voter Registrar. Meanwhile, you may vote a full ballot in your former precinct if your registration has not become effective in your new precinct. You will be required to complete a Statement of Residence form confirming your new address.

#### What do I do if I change my address and move to another county?

You must reregister. Complete an application and mail it or take it in person to the Voter Registrar of your new county. You will be registered 30 days after your application is submitted.

You may be eligible to vote a limited ballot, i.e. on measures in common between your former and new county, in your new county of residence after moving if you were qualified to vote in your former county

at the time you moved, and if your registration in the new county is not yet effective. You must apply for a limited ballot and vote by personal appearance with the early voting clerk conducting the election in your new county during the Early Voting Period — not on Election Day.

#### What does the term "suspense" mean on a voter's record?

The term "suspense" is used to designate those voters for whom the Harris County Voter Registrar does not have a current address. A voter in "suspense" status on the rolls will be allowed to vote after completing a Statement of Residence form. Once the address is corrected, the "suspense" designation will be removed from the voter's record. On November 30 of even-numbered years, the Voter Registrar cancels registrations of suspense list voters if two general elections have occurred since the voter was first listed as a suspense voter and the voter has not submitted an address correction.

#### New! For Military and Overseas Voters

Eligible Military Personnel, Spouses or Dependents of the Military, and Civilians Overseas now have the ability to complete a Federal Post Card Application (FPCA) online. For more information and instructions visit http://www.harrisvotes.com/VotingInfo/MilOverseas.aspx.

- 1. Go to www.harrisvotes.com.
- 2. Click on English, Spanish, Vietnamese or Chinese.

Candidates are advised that their responses to questions are word limited. Replies that exceed the word limit are indicated by slashes (///). Candidates who fail to respond to our invitation to participate in the *Voters Guide* are listed with the notation, "No response received." Candidates without a photo did not submit one.

Candidates are advised that the League of Women Voters reserves the right not to print obscenities, slurs, or egregious personal attacks. All candidates are listed in ballot order. The League of Women Voters does not print responses from unopposed candidates in the of the *Voters Guide*. Names of unopposed candidates are listed, followed by the notation "Unopposed."

# TEXAS NOW REQUIRES ONE OF 7 PHOTO IDS FOR THOSE VOTING IN PERSON: (INCLUDING EARLY VOTING AND ON ELECTION DAY)

- Only the 7 photo IDs listed can be accepted at the polls.
- Other photo IDs including student IDs and employer IDs cannot be accepted.
- Photo ID needs to be current or have expired no more than 60 days before voting (citizenship and naturalization certificates have no expiration date).
- The name on the ID should match the voter registration card. If names don't match, a voter may be accepted if names are "substantially similar." Addresses need not match.
- Voters with a documented disability can apply for a voter registration certificate exempting them from the photo ID requirement.
- Voters without acceptable ID can obtain an Election Identification Certificate (EIC) from Texas DPS at no cost by providing proof of citizenship and identity and registering to vote at DPS or showing a voter registration card.
- Voters who do not show an acceptable ID at the poll can vote a provisional ballot and must show the required photo ID by Tuesday, November 12, 2013.
- Photo ID is not required to vote by mail. Voters may apply for a mail ballot if 65 or older, ill or disabled, or absent from their county during early voting and on election day.

#### TEXAS DEPARTMENT OF PUBLIC SAFETY (DPS) ISSUED:

- -Driver's license
- -Personal identification card
- -Concealed handgun license
- -Election identification certificate (EIC)

#### U.S. GOVERNMENT ISSUED:

- -Military identification card with photograph
- -Citizenship certificate or naturalization certificate with photograph

# STATE OF TEXAS NOVEMBER 5, 2013 ELECTION

#### TEXAS CONSTITUTIONAL AMENDMENT ELECTION

The Texas Constitution is among the longest of state constitutions in the United States. Since its initial adoption in 1876, a total of 653 amendments have been proposed, of which 474 were approved by voters and 179 were rejected. An amendment is proposed in a joint resolution that can originate in either house of the state legislature during a regular or special session. A joint resolution specifies the election date and may contain more than one amendment. The joint resolution must receive a vote of two-thirds of each house before it is presented to the voters. The governor cannot veto a joint resolution.

The governor can, however, veto the enabling legislation, the bill to enact the amendment if it is passed by voters. Not all amendments require enabling legislation. If the voters reject an amendment, the enabling legislation does not take effect. If the amendment fails, the legislature may resubmit it in a future legislative session. Amendments take effect when the official vote canvass confirms statewide voter approval, unless a later date is specified in the joint resolution.

#### **PROPOSITION I**

THE CONSTITUTIONAL AMENDMENT AUTHORIZING THE LEGISLATURE TO PROVIDE FOR AN EXEMPTION FROM AD VALOREM TAXATION OF ALL OR PART OF THE MARKET VALUE OF THE RESIDENCE HOMESTEAD OF THE SURVIVING SPOUSE OF A MEMBER OF THE ARMED SERVICES OF THE UNITED STATES WHO IS KILLED IN ACTION.

The proposed amendment would allow the surviving spouse of a member of the U.S. armed services who was killed in action to be exempt from paying local property taxes based on all or part of the total appraised value of the homestead. This proposed amendment follows prior amendments that have passed, granting property tax exemptions to veterans who are 100% disabled and their surviving spouses

Under Proposition 1 and its enabling bill SB 163, a surviving spouse is eligible if he or she has not remarried since the death of the spouse who served in the armed forces and if the qualifying homestead was the residence of the spouse at the time of death. Upon remarriage, the surviving spouse would lose the property tax exemption. The surviving spouse would be able to transfer the exemption to a new homestead, but it would be limited to the dollar amount of the prior homestead exemption.

#### ☐ ARGUMENTS FOR

- The proposed amendment would allow local governments in Texas to assist surviving spouses of U.S. armed services members who have been killed in action by providing valuable relief during such a difficult time. Surviving spouses who qualify would be able to save money on property taxes and could use this money elsewhere.
- Surviving spouses would be able to transfer the exemption to a new residence if the surviving spouse chose to move within the state.

#### ☐ ARGUMENTS AGAINST

- School districts would receive less revenue from property taxes so the state would have to cover the reduction by pulling from state general revenue, creating a cost to the state.
- Local governments would lose revenue, especially in cities and towns where military families largely populate the area. This would result in a projected yearly loss of up to \$84,000 from counties, \$93,000 from cities, and \$45,000 from school districts by 2018 (SB 163 Fiscal Note). An increase in the number of people who receive property tax exemptions might require local governments to increase taxes for other taxpayers.

#### **PROPOSITION 2**

THE CONSTITUTIONAL AMENDMENT ELIMINATING AN OBSOLETE REQUIREMENT FOR A STATE MEDICAL EDUCATION BOARD AND A STATE MEDICAL EDUCATION FUND. NEITHER OF WHICH IS OPERATIONAL.

#### **EXPLANATION**

In 1952, voters amended the constitution to direct the Texas Legislature to create the State Medical Education Board (SMEB) and a scholarship fund to issue loans to medical students who agreed to practice in rural areas of Texas. In 1973, the Legislature created the SMEB. In 1987, the Legislative Budget Board reported that only 11 percent of loan recipients since 1973 were practicing in rural Texas counties, and only 14 percent of those were in medically underserved areas. No new loans have been issued since January 1988.

In 1989, after a recommendation by the Sunset Advisory Commission, the Legislature attached the SMEB to the Texas Higher Education Coordinating Board (THECB). All existing loans have been serviced or turned over to the attorney general for default collection. Loan repayment programs are now used instead of direct loans to medical students to attract physicians to practice in rural Texas.

The proposed constitutional amendment, and its enabling bill HB 1061, would remove references to these defunct entities in the constitution and state law.

#### ☐ ARGUMENT FOR

Since the SMEB and its education fund are no longer operational, references to them should be removed from the state's unwieldy constitution.

#### ☐ ARGUMENT AGAINST

The SMEB and its education fund are obsolete and no loans have been issued since 1988, so a constitutional amendment to remove references to them is unnecessary.

#### **PROPOSITION 3**

THE CONSTITUTIONAL AMENDMENT TO AUTHORIZE A POLITICAL SUBDIVISION OF THIS STATE TO EXTEND THE NUMBER OF DAYS THAT AIRCRAFT PARTS THAT ARE EXEMPT FROM AD VALOREM TAXATION DUE TO THEIR LOCATION IN THIS STATE FOR A TEMPORARY PERIOD MAY BE LOCATED IN THIS STATE FOR PURPOSES OF QUALIFYING FOR THE TAX EXEMPTION.

#### **EXPLANATION**

Currently, in order to promote economic development in the state, the Texas Constitution allows local taxing authorities to exempt from ad valorem taxation property that is in Texas temporarily. This tax exemption is commonly referred to as a "freeport exemption." Eligible property includes goods, wares, merchandise, other tangible property, and ores, other than oil, natural gas, and other petroleum products. To be eligible for the exemption, the property must be acquired in or imported into Texas for export; detained for assembly, storage, manufacturing, processing, or fabrication; and shipped out of Texas no later than 175 days after acquisition or importation.

Eligible property currently includes aircraft and aircraft parts used for maintenance or repairs by certified air carriers. The proposed amendment and its enabling bill HB 3121 authorize the governing body of a political subdivision that already grants a freeport exemption to extend, up to 730 days (two years) after acquisition or importation, the date when aircraft parts with an exemption have to be transported outside of the state. The extension would apply only to the political subdivision that grants it.

If passed, the amendment would take effect January 1, 2014, and apply only to a tax year that begins on or after that date.

#### ☐ ARGUMENTS FOR

- The proposed extension of the freeport exemption would provide an economic development tool designed to make Texas competitive in the aerospace industry that contributes billions to the state's economy. Texas is one of only a few states with a tax on inventory. Since aerospace suppliers often require inventory to be onsite for much longer than 175 days, at least one aerospace company has moved its storage or operations to another state because of the inventory tax.
- Granting an extension would be totally at the option of each local government already granting an exemption.
- Loss of tax revenue to a school district that grants a freeport exemption may be offset by additional state aid, since the amount of the exemption is subtracted from the market value of inventory or property to determine the taxable value for the taxing authority. Any extra cost to the state could be offset by additional revenues from increased economic development and jobs.

#### ☐ ARGUMENTS AGAINST

- Singling out one group for special tax exemption status raises issues of uniformity in taxation. If the extension is authorized for aircraft parts, similar industries that make specialized parts and have a high portion of idle inventory may seek similar extensions.
- Granting an extension reduces tax revenues for local governments.
- An increase in exemptions by school districts could result in higher costs to the state.

#### **PROPOSITION 4**

THE CONSTITUTIONAL AMENDMENT AUTHORIZING THE LEGISLATURE TO PROVIDE FOR AN EXEMPTION FROM AD VALOREM TAXATION OF PART OF THE MARKET VALUE OF THE RESIDENCE HOMESTEAD OF A PARTIALLY DISABLED VETERAN OR THE SURVIVING SPOUSE OF A PARTIALLY DISABLED VETERAN IF THE RESIDENCE HOMESTEAD WAS DONATED TO THE DISABLED VETERAN BY A CHARITABLE ORGANIZATION.

#### **EXPLANATION**

Currently, the Texas Constitution provides that a 100 percent or totally disabled veteran, or the veteran's surviving spouse, is entitled to an exemption from ad valorem taxation of the market value of the disabled veteran's resident homestead, subject to certain restrictions.

This proposed amendment, and its enabling legislation HB 97, would provide a similar exemption to a partially disabled veteran or surviving spouse, if the homestead has been donated by a charitable

organization at no cost to the veteran. The amount of the exemption would be a percentage of the market value of the residence homestead that is equal to the percentage of disability of the veteran. Proposition 4 would allow the legislature to provide additional eligibility requirements for the exemption, and would not affect whether a qualified disabled veteran was entitled to another exemption for veterans for which he or she may qualify. It also allows partially disabled veterans to be added to the list of individuals authorized to pay property taxes in installments as provided by current law.

#### ☐ ARGUMENTS FOR

- Texas charitable organizations have given homes to disabled veterans, but in some cases the
  veteran is unable to pay the property taxes, resulting in an unintended consequence of foreclosure.
  These veterans have sacrificed for our country and are deserving of help. The cost of the exemption
  is small because only a dozen or so homes per year are donated cost-free to disabled veterans.
- Partially disabled veterans who receive these homes are not likely to return to full employment and need help with their taxes.

#### ☐ ARGUMENTS AGAINST

- Singling out one group for special tax exemption status, even though deserving, raises issues of uniformity in taxation and could open the door to continued erosion of the tax base.
- If the purpose of the bill is to help partially disabled veterans keep their homes while they are unable to pay property taxes, the exemption should not be permanent. It should expire when the veteran can afford to pay property taxes.

#### **PROPOSITION 5**

THE CONSTITUTIONAL AMENDMENT TO AUTHORIZE THE MAKING OF A REVERSE MORTGAGE LOAN FOR THE PURCHASE OF HOMESTEAD PROPERTY AND TO AMEND LENDER DISCLOSURES AND OTHER REQUIREMENTS IN CONNECTION WITH A REVERSE MORTGAGE LOAN.

#### **EXPLANATION**

A "reverse mortgage for purchase" allows a senior aged 62 or older to purchase a new principal residence and obtain a reverse mortgage within a single transaction. Texas is the second largest market in the country for reverse mortgages, but the only state that does not offer the "reverse mortgage for purchase" because it is not authorized in the state constitution.

A reverse mortgage is a form of home equity loan that does not require a monthly payment. During the course of the loan, the debt increases with the addition of various costs such as interest, mortgage

insurance premiums, and servicing fees, while the homeowner's equity decreases. Repayment of the loan is deferred until the borrower dies, sells, or moves out of the residence. While reverse mortgages are a small market nationally, approximately 70,000 originated per year, it could grow dramatically in the decades ahead spurred by an aging baby boomer population.

Proposition 5 would enable Texas seniors to use "reverse mortgages for purchase" to acquire a new residence. It would also require reverse mortgage lenders to expand currently required counseling to borrowers to include disclosure of the specific behaviors that can lead to foreclosure on a property.

#### ☐ ARGUMENTS FOR

- This proposition saves costs for seniors by allowing a reverse mortgage loan to be set up as part of a purchase rather than after a purchase to eliminate duplicative processes.
- Using a "reverse mortgage for purchase," the homeowner can occupy a new residence without
  making a single mortgage payment. This helps seniors relocate to other geographical areas or
  downsize to homes that better meet their needs.
- Reverse mortgage loans are typically easier to qualify for than traditional loans, which have income
  and credit score requirements to support the borrower's ability to meet repayment commitments.

#### ☐ ARGUMENTS AGAINST

- All reverse mortgages are complex financial products. Surveys have found that consumers struggle to understand and make good decisions even after required counseling.
- Homeowners can lose a lifetime of home equity as a result of fraud, scams, misleading advertising, aggressive sales tactics and discriminatory practices sometimes associated with reverse mortgages. This risk increases significantly when state regulation and enforcement are weak.
- As baby boomers consider the reverse mortgage market, their choices may put them at considerable risk at a time in their lives when making a financial recovery is unlikely.

#### **PROPOSITION 6**

THE CONSTITUTIONAL AMENDMENT PROVIDING FOR THE CREATION OF THE STATE WATER IMPLEMENTATION FUND FOR TEXAS AND THE STATE WATER IMPLEMENTATION REVENUE FUND FOR TEXAS TO ASSIST IN THE FINANCING OF PRIORITY PROJECTS IN THE STATE WATER PLAN TO ENSURE THE AVAILABILITY OF ADEQUATE WATER RESOURCES.

#### **EXPLANATION**

The Texas Water Development Board (TWDB) develops a state water plan based on information from each of 16 regional water-planning groups. Existing state funding relies primarily on issuance of general obligation bonds, legislative appropriations, and federal grants that finance loans to local and regional water suppliers. In November 2011, voters approved a constitutional amendment that authorized the TWDB to issue additional general obligation bonds not to exceed \$6 billion at any time. Proposition 6 establishes two funds to finance water plan projects: the State Water Implementation Fund for Texas (SWIFT) and the State Water Implementation Revenue Fund for Texas (SWIRFT). The two funds would receive financial resources for water projects, including revenue authorized by the state legislature, investment earnings and interest, and proceeds from the sale of bonds. The two funds would be part of the state treasury but outside the general revenue fund, a constitutional requirement to give the legislature control over disbursements.

Under Proposition 6, TWDB would have the power to enter into bond enhancement agreements to make bonds more attractive to purchasers. If the legislature provides authorization and the Legislative Budget Board approves, TWDB would have the authority to issue bonds and related credit agreements and to make direct loans for water projects in the state water plan. Repayment of loans would provide a revolving cash flow for additional loans.

HB 1025 authorizes the transfer of \$2 billion from the economic stabilization fund, commonly known as the Rainy Day Fund, if the amendment passes. Money in the fund would be available to provide support for low-interest loans, longer repayment terms for loans, incremental repurchase terms for projects in which the state owns an interest, and deferral of loan payments. The enabling legislation for the proposed amendment, HB 4, prescribes how the funds are to be invested and how they may be apportioned within the state water plan. At least 10 percent of funds would be applied to projects designed to serve rural areas and 20 percent for water conservation or reuse.

#### ☐ ARGUMENTS FOR

- Ensuring an adequate water supply is essential to the public and economic health of Texas.
   These two funds provide a sustainable mechanism for funding water development projects with an initial transfer of \$2 billion from the Rainy Day Fund to seed a revolving cash flow for making loans for water projects.
- Responding to the current drought emergency is an appropriate use of the Rainy Day Fund and will provide a better return on investment than if the money were left in that fund.
- Without the necessary funding for priority projects in the state water plan, Texas stands to lose
  millions of jobs and suffer reduced economic activity and decreased tax revenues.

#### ■ ARGUMENTS AGAINST

- These two new funds are unnecessary as there is already available funding for water development projects administered by TWDB.
- While TWDB needs to proceed with priority projects, taking money from the Rainy Day Fund is inappropriate. Reducing the amount in this fund could reduce the state's excellent credit rating and affect the state's ability to respond to a natural disaster or other emergency situations. The legislature should make a separate appropriation from the general fund.
- The state should not take on the financing of water plan projects. Financing should be provided by those benefiting from the projects.

#### **PROPOSITION 7**

THE CONSTITUTIONAL AMENDMENT AUTHORIZING A HOME-RULE MUNICIPALITY TO PROVIDE IN ITS CHARTER THE PROCEDURE TO FILL A VACANCY ON ITS GOVERNING BODY FOR WHICH THE UNEXPIRED TERM IS 12 MONTHS OR LESS.

#### **EXPLANATION**

Almost all Texas cities of more than 5,000 population have adopted a home rule or an independent city charter. A home rule city can pass any regulations or laws it deems necessary as long as they are consistent with the state constitution and statutes.

Section 11, Article XI of the Texas Constitution prohibits a city with terms of office between two and

four years from filling vacancies by appointment. These cities must fill vacancies by majority vote during a special election held within 120 days after the start of the vacancy.

The proposed constitutional amendment and its enabling bill HB 1372 would authorize a home rule city to provide in its charter a procedure other than a special election to fill a vacancy in its governing body for which the unexpired term is 12 months or less.

#### ☐ ARGUMENTS FOR

- Proposition 7 would cut taxpayer costs. When an elected city official passes away or otherwise
  leaves office, the Constitution requires the city to hold a special election within 120 days even
  if only a few months remain in the term. Taxpayers pay thousands of dollars to hold special
  elections only a few months before a regular election.
- This proposition would provide parity in election regulations. Vacancies for elected city officials
  with terms of office of less than two years can be filled by appointment. This proposition would
  allow vacancies to be filled by the same process for all elected officials. It would preserve
  democratic accountability because cities would have to hold elections as usual after the
  expiration of an appointed official's term.

#### ☐ ARGUMENTS AGAINST

- Proposition 7 might increase the opportunity for corruption by allowing city officials to appoint one another.
- Voting and elections are the best way to ensure democratic accountability. The cost of special
  elections is a small price to pay to ensure accountability.

#### **PROPOSITION 8**

THE CONSTITUTIONAL AMENDMENT REPEALING SECTION 7, ARTICLE IX, TEXAS CONSTITUTION, WHICH RELATES TO THE CREATION OF A HOSPITAL DISTRICT IN HIDALGO COUNTY.

#### **EXPLANATION**

Proposition 8 would remove from the Texas Constitution a 1960 amendment that authorized the creation of a hospital district in Hidalgo County with a maximum tax rate of 10 cents per \$100 valuation of taxable property. This limit is below all other counties in Texas, and no hospital district has been created in Hidalgo County. Repealing the 1960 amendment, which applies only to Hidalgo

County, would allow it to come under Section 4 of the Texas Constitution which provides for hospital districts in all counties, with a maximum tax rate of 75 cents per \$100 valuation of all taxable property. If Proposition 8 is passed, the formation of a hospital district in Hidalgo County and the district's tax rate would require approval from the county's voters during an election.

#### ☐ ARGUMENTS FOR

- Hidalgo is the only county in the state with a tax limitation of 10 cents per \$100 property
  valuation. It is also the largest county without a hospital district. The existing limitation hinders
  its ability to create and operate a sustainable district. Passage of Proposition 8 would allow
  Hidalgo County the same taxing rate that other counties have.
- Hidalgo County has a high rate of uninsured residents, and this proposition could help the county
  establish a hospital district and obtain federal funds for much-needed emergency care for the poor.

#### ☐ ARGUMENTS AGAINST

- Passage of this proposition would likely increase the taxes for property owners in Hidalgo County, since a hospital district could be created with a tax rate as high as 75 cents per \$100 valuation of all property.
- An increase in taxes could hurt the very people this proposition is hoping to serve: the poor.

#### **PROPOSITION 9**

THE CONSTITUTIONAL AMENDMENT RELATING TO EXPANDING THE TYPES OF SANCTIONS THAT MAY BE ASSESSED AGAINST A JUDGE OR JUSTICE FOLLOWING A FORMAL PROCEEDING INSTITUTED BY THE STATE COMMISSION ON JUDICIAL CONTACT.

#### **EXPLANATION**

The State Commission on Judicial Conduct (SCJC) was created in 1965, through a constitutional amendment, to investigate allegations of judicial misconduct or disability and to discipline judges. The SCJC is responsible for ensuring that Texas judges comply with standards of conduct established in the Texas Constitution and by the Texas Supreme Court. Currently, after a formal disciplinary proceeding, the SCJC may issue an order of public censure or recommend removal or retirement of the judge/justice.

During its review of the SCJC, the Sunset Advisory Commission recommended that the SCJC be authorized to use its full range of disciplinary actions following a formal proceeding. If this proposed amendment passes, the SCJC may at its discretion issue a private or public admonition, warning, reprimand, or requirement that the person obtain additional training or education, as well as the censure or formal recommendations of resignation or retirement.

#### ☐ ARGUMENT FOR

Proposition 9 would lead to greater public accountability for judges and justices; continue to
promote public confidence in the integrity, independence, competence, and impartiality of the
judiciary, and encourage judges to maintain high standards of conduct both on and off the bench.

#### ☐ ARGUMENT AGAINST

 Stronger measures than those provided by Proposition 9 are needed to reinforce the SCJC's authority to discipline judges and hold them accountable for judicial misconduct.

If this is not yet enough, the next step is to impose sin taxes targeting those who can afford. An example of this is a 1% tax on alcoholic beverages purchased in night clubs and bars.

City planning is critical to the progress of a city. A mayor should be able to plan for the future expansion of the city to accommodate the influx of new businesses. Critical to these endeavors are the expansion or the building of new roads and infrastructures to the outlying areas of Houston to encourage builders to build more hotels and new communities.





- The name on the ID should match the voter registration card. If names don't match, a voter may be accepted if names are "substantially similar." Addresses need not match
- Voters with a documented disability can apply for a voter registration certificate exempting them from the photo ID requirement.
- Voters without acceptable ID can obtain an Election Identification Certificate (EIC) from Texas DPS at no cost by providing proof of citizenship and identity and registering to vote at DPS or showing a voter registration card.
- Voters who do not show an acceptable ID at the poll can vote a provisional ballot and have 6 days to show the required photo ID.
- Photo ID is not required to vote by mail. Voters may apply for a mail ballot if 65 or older, ill or disabled, or absent from their county during early voting and on election day.



This proposition addresses the future of the Harris County Domed Stadium, popularly known as The Astrodome. This stadium is owned by Harris County taxpayers through the Harris County Sports and Convention Corporation. It has been largely unused since 2009.

The Harris County Sports and Convention Corporation had sought proposals for ways to repurpose the Astrodome. In June 2013, the Corporation announced its own plan to convert the Astrodome to a

modern multipurpose venue that could be used for sporting events, exhibitions and other community events like the Houston Livestock Show and Rodeo.

If approved, this proposition will authorize Harris County to issue up to \$217 million in bonds to finance the redesign and redevelopment of the Astrodome. This proposition will also authorize Harris County to increase taxes, if necessary to pay for these bonds. Planners indicate that the project would take approximately 30 months complete.


