The rate components effective January 1, 2014 are as follows: Applicable to each point the rate components are per Mcf gathering \$1.7681 per Mcf, treating \$0.0799 per Mcf, dehydration \$0.01 per Mcf, compression \$.0665 per stage if applicable to that meter and \$0.4598 per Mcf processing. As of January 1, 2014 and each year the Fees set forth herein shall be automatically increased by 3%. The foregoing Fees shall be effective until December 31, 2004, and thereafter such Fee(s) may be adjusted annually and the adjusted Fee(s), if any, will be effective thereafter. Gatherer will provide Shipper with written notice of any such adjustment to the Fee(s). Shipper will be responsible for its proportionate share of any losses, including but not limited to, Gathering System Fuel, Process Fuel, Process Flare, and any shrink attributable to the recovery of Plant Products, and Gatherer shall have the right to use such portion of Shipper's Gas as is required without any compensation or payment to Shipper.
