If the aggregate quantity of gas received into the system from all sources during any successive six month period (commencing with the first complete month in which deliveries of gas commenced) is less than 1.45 bcf, the initial gathering fee shall be proportionately increased for the next succeeding six month period by the amount required to make up the monetary short fall in the previous six months benchmark; provided, however, in no event will the gathering fee be increased beyond \$.90 per mcf and further, the gathering fee shall be or not be decreased below \$.45 per mcf until the earlier of (1) or (2) mentioned herein occurs.
