If Gas Company receives any refunds of any increased cost of purchased gas that have been passed on under this provision, a refund shall be made to consumers served by this rate schedule. Lost and unaccounted gas expenses shall be limited to the lesser of actual or five percent (5%) of gas purchases pursuant to 16 T.A.C. Section 7.34.
