For motor or mobile fuel installations:

- 1.  The Texas Department of Public Safety; and
- 2.  All CNG loading and unloading facilities utilized by the applicant

LP-Gas Operations may require an applicant to give notice to persons in addition to those listed above if doing so will not prejudice the rights of any entity.
