# MEMORANDUM OF UNDERSTANDING (MOU)

This MOU sets forth the conditions under which CD Global Strategies Group LLC (CDGSG) will provide public relations, strategic communications and outreach services for the Republic of Togo in the United States from September 18, 2014 to December 18, 2015.

### Services

CDGSG will provide a wide range of services, including professional and strategic consulting and public relations services to the Republic of Togo in order to strengthen its relations with the United States in accordance with the strategic plan described in the attached document.

Based on the information and documentation provided by the Government of Togo, CDGSG will provide strategic support and counsel in accordance with the agreed upon work plan.

To this end, CDGSG will advise the Government of Togo and provide services to carry out the services detailed in the appendix to this MOU.

#### Confidentiality

All information and non-public documents, transmitted or produced under this MOU are confidential.

CDGSG will treat as confidential all information provided by the Government of Togo, provided that no information or any document is disclosed to third parties other than those involved in the activities outlined in this MOU without prior approval of the Government of Togo.

#### Compensation

For the services described herein, the Republic of Togo will pay CDGSG a fee of two hundred thousand US dollars (\$200,000.00) for a period of three months.

Compensation for the services described above are to be paid as follows:

- Fifty percent (50%) upon signature of this MOU;
- Twenty-five percent (25%) after 45 days of services provided;
- Twenty-five percent (25%) at the end of the contract.

Payment for the services described herein will be made according to the following terms:

By bank wire transfer to:

- Or in direct payment.

### **Expenses and Fees**

All reasonable additional expenses including travel, printing and regulatory fees, will be billed following the prior written consent of the Republic of Togo.

### Suspension / Termination

The Government of Togo can suspend this MOU, barring any force majeure and noncompliance by CDGSG.

In the event that the suspension, whatever the cause, lasts more than one (1) month, the Government of Togo and CDGSG will work together to agree upon the continuation or termination of this contract.

It will be considered as a force majeure any unforeseen events that are insurmountable and beyond the control of the parties which prevents either or both parties to perform its obligations.

The party that declares a force majeure must promptly notify the other party.

Any force majeure relieves the affected party of the contractual obligations assigned to it. If the execution of this MOU is interrupted or prevented by a force majeure, both parties will be relieved of their contractual obligations for the duration of the force majeure.

The affected party shall undertake all reasonable actions to resume, as soon as possible, the activities described in this contract upon cessation of the force majeure. In the event that the force majeure continues beyond one month, the parties reserve the right to terminate this MOU.

This MOU may be terminated by either party upon a written notice of 30 days.

Upon termination by the Government of Togo or in the case of suspension of more than one (1) month, except in case of force majeure or that CDGSG does not respect its obligations under this contract, the Government of Togo CDGSG will pay as compensation the equivalent to 50% of the outstanding amount.

#### **Entire Agreement**

This MOU constitutes the entire agreement and understanding of the parties of the activities outlined in the attached; this MOU supersedes any prior understanding or agreement. This agreement may be amended in writing and signed by the parties. In the event that a provision of this agreement is deemed illegal or unenforceable, such provision shall be invalidated and the remainder of the agreement shall remain in full force and effect.

All litigation arising from the execution or interpretation of this MOU will be settled amicably, and failing amicable settlement within a period of one (1) month, it shall be adjudicated by the competent courts of the city of Lomé, Togo.

This MOU becomes effective upon the date of its signature and shall be valid for a period of six (06) months.
