Dear Chairman Dingell, Ranking Member Barton, and Members of the Committee on Energy and Commerce:

The undersigned organizations are writing to ask that you reauthorize the State Children's Health Insurance Program (SCHIP) and maintain flexibility for states to cover parents.

There has been bipartisan support for covering parents throughout SCHIP's history since the program was enacted in 1997 to target low-income children in families who did not qualify for Medicaid but could not afford private health insurance. States that met certain benchmarks in covering children were encouraged by both the Clinton and Bush Administrations to expand coverage to low-income parents.

The strategy worked. Currently, SCHIP provides health insurance coverage to approximately 300,000 parents who cannot otherwise access coverage through public insurance or their employers. This represents a small percentage of the program's 7.4 million total enrollees. Yet opponents of family-based coverage in SCHIP have been threatening to deny states flexibility to cover low-income parents, leaving them with no viable alternatives for obtaining health care coverage.

Covering low-income parents through SCHIP not only benefits the parents, it also is critical to ensuring that families stay healthy. Children whose parents have health insurance are more likely to enroll in public health insurance programs, access health care themselves, and take advantage of preventive health care services. Parents with health care are also better able to stay in the work force and have the means to care for their families. Dr. Mark B. McClellan, former Administrator of the Center of Medicaid and Medicare Services (CMS) for the Bush Administration has acknowledged the importance of parents' coverage to children's health: "Extending coverage to parents and caretakers not only serves to cover additional uninsured individuals, but it may also increase the likelihood that they will take the steps necessary to enroll their children." States with family care coverage programs, including New Jersey, Minnesota, and Wisconsin, have shown this to be the case. Research in those states indicates that covered parents enroll their children, ensure that children receive care, and stay enrolled in the program.

Denying states the flexibility to cover parents would represent a major step backward. We ask that you support SCHIP reauthorization and continue to give states the latitude they need to ensure healthy families by allowing parents to receive health insurance coverage under SCHIP. Thank you for your consideration.
