Dear Mr. Secretary:

The Committee is conducting an investigation into why President Bush and other senior Administration officials cited forged evidence, which purported to show that Iraq sought uranium from Niger, in building a case for war against Iraq.

To assist the Committee in its investigation, I request that you provide all documents in the possession or control of the Defense Department, whether classified or unclassified, relating to the claim that Iraq sought uranium from Africa. These documents should include:

- 1. All documents and communications between the Defense Department and the Executive Office of the President, including the National Security Council, the Office of the Vice President, and the White House Iraq Group (collectively, "EOP"), relating to the claim that Iraq sought uranium from Africa, including a February 2002 report by General Carlton W. Fulford, Jr.;
- 2. All documents and communications between the National Intelligence Council and the Defense Department relating to the claim that Iraq sought uranium from Africa, including a National Intelligence Council communication reportedly sent in January 2003;
- 3. All documents and communications relating to the portion of former Secretary of Defense Donald Rumsfeld's press conference on January 29, 2003, that concerned the issue of Iraq seeking uranium in Africa;
- 4. All documents and communications relating to the portion of former Deputy Secretary of Defense Paul Wolfowitz's address to the Council on Foreign Relations on January 23, 2003, that concerned "Iraqi efforts to procure uranium from abroad";

- 5. All communications between State Department official Simon Dodge and Intelligence Community officials relating to the claim that Iraq sought uranium in Africa, including emails sent in January 2003; and
- 6. All documents and communications relating to the portion of the President's 2003 State of the Union Address that noted that "Saddam Hussein recently sought significant quantities of uranium from Africa".

I ask that you provide these documents to the Committee by Friday, May 18, 2007. You should provide all responsive documents in the possession or control of the Defense Department, regardless of whether other offices or agencies may have generated original versions of these documents. I am also sending similar document requests to several federal agencies.

The Committee on Oversight and Government Reform is the principal oversight committee in the House of Representatives and has broad oversight jurisdiction as set forth in House Rule X. An attachment to this letter provides additional information on how to respond to the Committee's request.
