**A BILL**

To reform the intelligence community and the intelligence and intelligence-related activities of the United States Government, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

1 **SEC. 2. DEFINITIONS.**

2 In this Act:

3 (1) The term “intelligence” includes foreign in-  
4 telligence and counterintelligence.

5 (2) The term “foreign intelligence” means in-  
6 formation relating to the capabilities, intentions, or  
7 activities of foreign governments or elements thereof,  
8 foreign organizations, foreign persons, or inter-  
9 national terrorists.

10 (3) The term “counterintelligence” means infor-  
11 mation gathered, and activities conducted, to protect  
12 against espionage, other intelligence activities, sabo-  
13 tage, or assassinations conducted by or on behalf of  
14 foreign governments or elements thereof, foreign or-  
15 ganizations, foreign persons, or international terror-  
16 ists.

17 (4) The term “intelligence community” includes  
18 the following:

19 (A) The National Intelligence Authority.

20 (B) The Central Intelligence Agency.

21 (C) The National Security Agency.

22 (D) The Defense Intelligence Agency.

1           (E) The National Geospatial-Intelligence  
2 Agency.

3           (F) The National Reconnaissance Office.

4           (G) Other offices within the Department of  
5 Defense for the collection of specialized national  
6 intelligence through reconnaissance programs.

7           (H) The intelligence elements of the Army,  
8 the Navy, the Air Force, the Marine Corps, the  
9 Federal Bureau of Investigation, and the De-  
10 partment of Energy.

11           (I) The Bureau of Intelligence and Re-  
12 search of the Department of State.

13           (J) The Office of Intelligence and Analysis  
14 of the Department of the Treasury.

15           (K) The elements of the Department of  
16 Homeland Security concerned with the analysis  
17 of intelligence information, including the Office  
18 of Intelligence of the Coast Guard.

19           (L) Such other elements of any depart-  
20 ment or agency as may be designated by the  
21 President, or designated jointly by the National  
22 Intelligence Director and the head of the de-  
23 partment or agency concerned, as an element of  
24 the intelligence community.

1           (5) The terms “national intelligence” and “in-  
2 intelligence related to the national security”—

3           (A) each refer to intelligence which per-  
4 tains to the interests of more than one depart-  
5 ment or agency of the Government; and

6           (B) do not refer to counterintelligence or  
7 law enforcement activities conducted by the  
8 Federal Bureau of Investigation except to the  
9 extent provided for in procedures agreed to by  
10 the National Intelligence Director and the At-  
11 torney General, or otherwise as expressly pro-  
12 vided for in this title.

13          (6) The term “National Intelligence  
14 Program”—

15           (A)(i) refers to all national intelligence  
16 programs, projects, and activities of the ele-  
17 ments of the intelligence community;

18           (ii) includes all programs, projects, and ac-  
19 tivities (whether or not pertaining to national  
20 intelligence) of the National Intelligence Au-  
21 thority, the Central Intelligence Agency, the  
22 National Security Agency, the National  
23 Geospatial-Intelligence Agency, the National  
24 Reconnaissance Office, the Office of Intelligence  
25 of the Federal Bureau of Investigation, and the

1 Office of Information Analysis of the Depart-  
2 ment of Homeland Security; and

3 (iii) includes any other program, project,  
4 or activity of a department, agency, or element  
5 of the United States Government relating to  
6 national intelligence unless the National Intel-  
7 ligence Director and the head of the depart-  
8 ment, agency, or element concerned determine  
9 otherwise; but

10 (B) does not refer to any program, project,  
11 or activity of the military departments to ac-  
12 quire intelligence solely for the planning and  
13 conduct of tactical military operations by the  
14 United States Armed Forces.

15 (8) The term “congressional intelligence com-  
16 mittees” means—

17 (A) the Select Committee on Intelligence of  
18 the Senate; and

19 (B) the Permanent Select Committee on  
20 Intelligence of the House of Representatives.

1                   **TITLE I—NATIONAL**  
2                   **INTELLIGENCE AUTHORITY**  
3                   **Subtitle A—National Intelligence**  
4                   **Authority**

5   **SEC. 101. NATIONAL INTELLIGENCE AUTHORITY.**

6           (a) INDEPENDENT ESTABLISHMENT.—There is here-  
7 by established as an independent establishment in the ex-  
8 ecutive branch of government the National Intelligence  
9 Authority.

10          (b) COMPOSITION.—The National Intelligence Au-  
11 thority is composed of the following:

12               (1) The Office of the National Intelligence Di-  
13 rector.

14               (2) The elements specified in subtitle D.

15               (3) Such other elements, offices, agencies, and  
16 activities as may be established by law or by the  
17 President or the National Intelligence Director.

18          (c) PRIMARY MISSIONS.—The primary missions of  
19 the National Intelligence Authority are as follows:

20               (1) To unify and strengthen the efforts of the  
21 intelligence community of the United States Govern-  
22 ment.

23               (2) To ensure the organization of the efforts of  
24 the intelligence community of the United States  
25 Government in a joint manner relating to intel-



1 intelligence missions rather than through intelligence col-  
2 lection disciplines.

3 (3) To provide for the operation of the National  
4 Counterterrorism Center and national intelligence  
5 centers under subtitle D.

6 (4) To eliminate barriers that impede coordina-  
7 tion of the counterterrorism activities of the United  
8 States Government between foreign intelligence ac-  
9 tivities located abroad and foreign intelligence activi-  
10 ties located domestically while ensuring the protec-  
11 tion of civil liberties.

12 (5) To establish clear responsibility and ac-  
13 countability for counterterrorism and other intel-  
14 ligence matters relating to the national security of  
15 the United States.

16 (d) SEAL.—The National Intelligence Director shall  
17 have a seal for the National Intelligence Authority. The  
18 design of the seal is subject to the approval of the Presi-  
19 dent. Judicial notice shall be taken of the seal.

20 **SEC. 102. NATIONAL INTELLIGENCE DIRECTOR.**

21 (a) NATIONAL INTELLIGENCE DIRECTOR.—There is  
22 a National Intelligence Director who shall be appointed  
23 by the President, by and with the advice and consent of  
24 the Senate.

1 (b) INDIVIDUALS ELIGIBLE FOR NOMINATION.—Any  
2 individual nominated for appointment as National Intel-  
3 ligence Director shall have extensive national security ex-  
4 pertise.

5 (c) PROHIBITION ON SIMULTANEOUS SERVICE IN  
6 OTHER CAPACITY IN INTELLIGENCE COMMUNITY.—The  
7 individual serving as National Intelligence Director may  
8 not, while so serving, serve in any capacity in any other  
9 element of the intelligence community, except to the extent  
10 that the individual serving as National Intelligence Direc-  
11 tor does so in an acting capacity.

12 (d) PRINCIPAL DUTIES AND RESPONSIBILITIES.—  
13 The National Intelligence Director shall—

14 (1) serve as head of the intelligence community  
15 in accordance with the provisions of this Act, the  
16 National Security Act of 1947 (50 U.S.C. 401 et  
17 seq.), and other applicable provisions of law;

18 (2) act as a principal adviser to the President  
19 for intelligence related to the national security;

20 (3) serve as the head of the National Intel-  
21 ligence Authority; and

22 (4) direct and oversee the National Intelligence  
23 Program.

24 (e) GENERAL RESPONSIBILITIES AND AUTHORI-  
25 TIES.—In carrying out the duties and responsibilities set

1 forth in subsection (c), the National Intelligence Director  
2 shall have the responsibilities set forth in section 112 and  
3 the authorities set forth in section 113 and other applica-  
4 ble provisions of law.

5 **Subtitle B—Responsibilities and**  
6 **Authorities of National Intel-**  
7 **ligence Director**

8 **SEC. 111. PROVISION OF NATIONAL INTELLIGENCE.**

9 (a) IN GENERAL.—The National Intelligence Direc-  
10 tor shall be responsible for providing national  
11 intelligence—

12 (1) to the President;

13 (2) to the heads of other departments and  
14 agencies of the executive branch;

15 (3) to the Chairman of the Joint Chiefs of Staff  
16 and senior military commanders;

17 (4) where appropriate, to the Senate and House  
18 of Representatives and the committees thereof; and

19 (5) to such other persons or entities as the  
20 President shall direct.

21 (b) NATIONAL INTELLIGENCE.—Such national intel-  
22 ligence should be timely, objective, independent of political  
23 considerations, and based upon all sources available to the  
24 intelligence community.

1 **SEC. 112. RESPONSIBILITIES OF NATIONAL INTELLIGENCE**

2 **DIRECTOR.**

3 (a) IN GENERAL.—The National Intelligence Direc-  
4 tor shall—

5 (1) determine the annual budget for the intel-  
6 ligence and intelligence-related activities of the  
7 United States by—

8 (A) providing to the heads of the depart-  
9 ments containing agencies or elements within  
10 the intelligence community and that have one or  
11 more programs, projects, or activities within the  
12 National Intelligence program, and to the heads  
13 of such agencies and elements, guidance for de-  
14 velopment the National Intelligence Program  
15 budget pertaining to such agencies or elements;

16 (B) developing and presenting to the Presi-  
17 dent an annual budget for the National Intel-  
18 ligence Program after consultation with the  
19 heads of agencies or elements, and the heads of  
20 their respective departments, under subpara-  
21 graph (A);

22 (C) providing budget guidance to each ele-  
23 ment of the intelligence community that does  
24 not have one or more program, project, or ac-  
25 tivity within the National Intelligence Program

1           regarding the intelligence and intelligence-re-  
2           lated activities of such element; and

3                   (D) participating in the development by  
4           the Secretary of Defense of the annual budgets  
5           for the military intelligence programs, projects,  
6           and activities not included in the National In-  
7           telligence Program;

8           (2) manage and oversee the National Intel-  
9           ligence Program, including—

10                   (A) the execution of funds within the Na-  
11           tional Intelligence Program;

12                   (B) the reprogramming of funds appro-  
13           priated or otherwise made available to the Na-  
14           tional Intelligence Program; and

15                   (C) the transfer of funds and personnel  
16           under the National Intelligence Program;

17           (3) establish the requirements and priorities to  
18           govern the collection, analysis, and dissemination of  
19           national intelligence by elements of the intelligence  
20           community;

21                   (4) establish collection and analysis require-  
22           ments for the intelligence community, determine col-  
23           lection and analysis priorities, issue and manage col-  
24           lection and analysis tasking, and resolve conflicts in  
25           the tasking of elements of the intelligence commu-

1 nity within the National Intelligence Program, ex-  
2 cept as otherwise agreed with the Secretary of De-  
3 fense pursuant to the direction of the President;

4 (5) provide advisory tasking on the collection of  
5 intelligence to elements of the United States Govern-  
6 ment having information collection capabilities that  
7 are not elements of the intelligence community;

8 (6) manage and oversee the National  
9 Counterterrorism Center under section 143, and es-  
10 tablish, manage, and oversee national intelligence  
11 centers under section 144;

12 (7) establish requirements and priorities for for-  
13 eign intelligence information to be collected under  
14 the Foreign Intelligence Surveillance Act of 1978  
15 (50 U.S.C. 1801 et seq.), and provide assistance to  
16 the Attorney General to ensure that information de-  
17 rived from electronic surveillance or physical  
18 searches under that Act is disseminated so it may be  
19 used efficiently and effectively for foreign intel-  
20 ligence purposes, except that the Director shall have  
21 no authority to direct, manage, or undertake elec-  
22 tronic surveillance or physical search operations pur-  
23 suant to that Act unless otherwise authorized by  
24 statute or Executive order;

1           (8) develop and implement, in consultation with  
2           the heads of other agencies or elements of the intel-  
3           ligence community, and the heads of their respective  
4           departments, personnel policies and programs appli-  
5           cable to the intelligence community that—

6                   (A) encourage and facilitate assignments  
7                   and details of personnel to the National  
8                   Counterterrorism Center under section 143, to  
9                   national intelligence centers under section 144,  
10                  and between elements of the intelligence com-  
11                  munity;

12                  (B) set standards for education, training,  
13                  and career development of personnel of the in-  
14                  telligence community;

15                  (C) encourage and facilitate the recruit-  
16                  ment and retention by the intelligence commu-  
17                  nity of highly qualified individuals for the effec-  
18                  tive conduct of intelligence activities;

19                  (D) ensure that the personnel of the intel-  
20                  ligence community is sufficiently diverse for  
21                  purposes of the collection and analysis of intel-  
22                  ligence through the recruitment and training of  
23                  women, minorities, and individuals with diverse  
24                  ethnic, cultural, and linguistic backgrounds;

1 (E) make service in more than one element  
2 of the intelligence community a condition of  
3 promotion to such positions within the intel-  
4 ligence community as the Director shall specify;

5 (F) ensure the effective management of in-  
6 telligence community personnel who are respon-  
7 sible for intelligence community-wide matters;

8 (G) provide for the effective management  
9 of human capital within the intelligence commu-  
10 nity, including—

11 (i) the alignment of human resource  
12 policies and programs of the elements of  
13 the intelligence community with the mis-  
14 sions, goals, and organizational objectives  
15 of such elements and of the intelligence  
16 community overall;

17 (ii) the assessment of workforce char-  
18 acteristics and future needs and the estab-  
19 lishment of workforce development strate-  
20 gies to meet those needs based on relevant  
21 organizational missions and strategic  
22 plans;

23 (iii) the sustainment of a culture that  
24 encourages and allows for the development  
25 of a high performing workforce; and



1 (iv) the alignment of expectations for  
2 personnel performance with relevant orga-  
3 nizational missions and strategic plans;

4 (H) are consistent with the public employ-  
5 ment principles of merit and fitness set forth  
6 under section 2301 of title 5, United States  
7 Code; and

8 (I) include the enhancements required  
9 under section 114;

10 (9) promote and evaluate the utility of national  
11 intelligence to consumers within the United States  
12 Government;

13 (10) ensure that appropriate officials of the  
14 United States Government and other appropriate in-  
15 dividuals have access to a variety of intelligence as-  
16 sessments and analytical views;

17 (11) protect intelligence sources and methods  
18 from unauthorized disclosure;

19 (12) establish requirements and procedures for  
20 the classification of intelligence information and for  
21 access to classified intelligence information;

22 (13) establish requirements and procedures for  
23 the dissemination of classified information by ele-  
24 ments of the intelligence community;

1           (14) establish intelligence reporting guidelines  
2           that maximize the dissemination of information  
3           while protecting intelligence sources and methods;

4           (15) develop, in consultation with the heads of  
5           appropriate departments and agencies of the United  
6           States Government, an integrated communications  
7           network that provides interoperable communications  
8           capabilities among all elements of the intelligence  
9           community and such other entities and persons as  
10          the Director considers appropriate;

11          (16) establish standards for information tech-  
12          nology and communications for the intelligence com-  
13          munity;

14          (17) ensure that the intelligence community  
15          makes efficient and effective use of open-source in-  
16          formation and analysis;

17          (18) ensure compliance by elements of the intel-  
18          ligence community with the Constitution and all  
19          laws, regulations, Executive orders, and imple-  
20          menting guidelines of the United States applicable to  
21          the intelligence and intelligence-related activities of  
22          the United States Government, including the provi-  
23          sions of the Constitution and all laws, regulations,  
24          Executive orders, and implementing guidelines of the

1 United States applicable to the protection of the pri-  
2 vacy and civil liberties of United States persons;

3 (19) eliminate waste and unnecessary duplica-  
4 tion within the intelligence community; and

5 (20) perform such other functions as the Presi-  
6 dent may direct.

7 (b) UNIFORM PROCEDURES FOR SENSITIVE COM-  
8 PARTMENTED INFORMATION.—The President, acting  
9 through the National Intelligence Director, shall establish  
10 uniform standards and procedures for the grant to sen-  
11 sitive compartmented information in accordance with sec-  
12 tion 115.

13 (c) PERFORMANCE OF COMMON SERVICES.—(1) The  
14 National Intelligence Director shall, in consultation with  
15 the heads of departments and agencies of the United  
16 States Government containing elements within the intel-  
17 ligence community and with the Director of the Central  
18 Intelligence Agency, direct and coordinate the perform-  
19 ance by the elements of the intelligence community within  
20 the National Intelligence Program of such services as are  
21 of common concern to the intelligence community, which  
22 services the National Intelligence Director determines can  
23 be more efficiently accomplished in a consolidated manner.

1           (2) The services performed under paragraph (1) shall  
2 include research and development on technology for use  
3 in national intelligence missions.

4           (d) REGULATIONS.—The National Intelligence Direc-  
5 tor may prescribe regulations relating to the discharge and  
6 enforcement of the responsibilities of the Director under  
7 this section.

8 **SEC. 113. AUTHORITIES OF NATIONAL INTELLIGENCE DI-**  
9 **RECTOR.**

10          (a) ACCESS TO INTELLIGENCE.—Unless otherwise di-  
11 rected by the President, the National Intelligence Director  
12 shall have access to all intelligence related to the national  
13 security which is collected by any department, agency, or  
14 other element of the United States Government.

15          (b) DETERMINATION OF BUDGETS FOR NIP AND  
16 OTHER INTELLIGENCE ACTIVITIES.—The National Intel-  
17 ligence Director shall determine the annual budget for the  
18 intelligence and intelligence-related activities of the United  
19 States Government under section 112(a)(1) by—

20               (1) providing to the heads of the departments  
21 containing agencies or elements within the intel-  
22 ligence community and that have one or more pro-  
23 grams, projects, or activities within the National In-  
24 telligence program, and to the heads of such agen-  
25 cies and elements, guidance for development the Na-

1 tional Intelligence Program budget pertaining to  
2 such agencies or elements;

3 (2) developing and presenting to the President  
4 an annual budget for the National Intelligence Pro-  
5 gram after consultation with the heads of agencies  
6 or elements, and the heads of their respective de-  
7 partments, under paragraph (1), including, in fur-  
8 therance of such budget, the review, modification,  
9 and approval of budgets of the agencies or elements  
10 of the intelligence community with one or more pro-  
11 grams, projects, or activities within the National In-  
12 telligence Program utilizing the budget authorities in  
13 subsection (c)(1);

14 (3) providing guidance on the development of  
15 annual budgets for each element of the intelligence  
16 community that does not have any program, project,  
17 or activity within the National Intelligence Program  
18 utilizing the budget authorities in subsection (c)(2);

19 (4) participating in the development by the Sec-  
20 retary of Defense of the annual budget for military  
21 intelligence programs and activities outside the Na-  
22 tional Intelligence Program;

23 (4) receiving the appropriations for the Na-  
24 tional Intelligence Program as specified in sub-  
25 section (d) and allotting and allocating funds to

1 agencies and elements of the intelligence community;  
2 and

3 (5) managing and overseeing the execution by  
4 the agencies or elements of the intelligence commu-  
5 nity, and, if necessary, the modification of the an-  
6 nual budget for the National Intelligence Program,  
7 including directing the reprogramming and transfer  
8 of funds, and the transfer of personnel, among and  
9 between elements of the intelligence community  
10 within the National Intelligence Program utilizing  
11 the authorities in subsections (f) and (g).

12 (c) BUDGET AUTHORITIES.—(1)(A) In developing  
13 and presenting an annual budget for the elements of the  
14 intelligence community within the National Intelligence  
15 Program under subsection (b)(1), the National Intel-  
16 ligence Director shall coordinate, prepare, and present to  
17 the President the annual budgets of those elements, in  
18 consultation with the heads of those elements.

19 (B) If any portion of the budget for an element of  
20 the intelligence community within the National Intel-  
21 ligence Program is prepared outside the Office of the Na-  
22 tional Intelligence Director, the Director—

23 (i) shall approve such budget before submission  
24 to the President; and

1           (ii) may require modifications of such budget to  
2           meet the requirements and priorities of the Director  
3           before approving such budget under clause (i).

4           (C) The budget of an agency or element of the intel-  
5           ligence community with one or more programs, projects,  
6           or activities within the National Intelligence Program may  
7           not be provided to the President unless the Director has  
8           first approved such budget.

9           (2)(A) The Director shall provide guidance for the  
10          development of the annual budgets for each agency or ele-  
11          ment of the intelligence community that does not have any  
12          program, project, or activity within the National Intel-  
13          ligence Program.

14          (B) The heads of the agencies or elements of the in-  
15          telligence community, and the heads of their respective de-  
16          partments, referred to in subparagraph (A) shall coordi-  
17          nate closely with the Director in the development of the  
18          budgets of such agencies or elements, before the submis-  
19          sion of their recommendations on such budgets to the  
20          President.

21          (d) JURISDICTION OF FUNDS UNDER NIP.—(1) Not-  
22          withstanding any other provision of law and consistent  
23          with section 504 of the National Security Act of 1947 (50  
24          U.S.C. 414), any amounts appropriated or otherwise made  
25          available for the National Intelligence Program shall be

1 appropriated to, and, pursuant to subsection (e), under  
2 the direct jurisdiction of, the National Intelligence Direc-  
3 tor.

4 (2) The Director shall manage and oversee the execu-  
5 tion by each element of the intelligence community of any  
6 amounts appropriated or otherwise made available to such  
7 element under the National Intelligence Program.

8 (e) ACCOUNTS FOR ADMINISTRATION OF NIP  
9 FUNDS.—(1) The Secretary of the Treasury shall, in con-  
10 sultation with the National Intelligence Director, establish  
11 accounts for the funds under the jurisdiction of the Direc-  
12 tor under subsection (d) for purposes of carrying out the  
13 responsibilities and authorities of the Director under this  
14 Act with respect to the National Intelligence Program.

15 (2) The National Intelligence Director shall—

16 (A) control and manage the accounts estab-  
17 lished under paragraph (1); and

18 (B) with the concurrence of the Director of the  
19 Office of Management and Budget, establish proce-  
20 dures governing the use (including transfers and  
21 reprogrammings) of funds in such accounts.

22 (3)(A) Notwithstanding any other provision of law,  
23 a certifying official shall follow the procedures established  
24 under paragraph (2)(B) with regard to each account es-  
25 tablished under paragraph (1). Disbursements from any



1 such account shall only be made against a valid obligation  
2 of such account.

3 (B) In this paragraph, the term “certifying official”,  
4 with respect to an element of the intelligence community,  
5 means an employee of the element who has responsibilities  
6 specified in section 3528(a) of title 31, United States  
7 Code.

8 (4) The National Intelligence Director shall allot  
9 funds deposited in an account established under para-  
10 graph (1) directly to the head of the elements of the intel-  
11 ligence community concerned in accordance with the pro-  
12 cedures established under paragraph (2)(B).

13 (5) Each account established under paragraph (1)  
14 shall be subject to chapters 13 and 15 of title 31, United  
15 States Code, other than sections 1503 and 1556 of that  
16 title.

17 (6) Nothing in this subsection shall be construed to  
18 impair or otherwise affect the authority granted by sub-  
19 section (g)(3) or by section 5 or 8 of the Central Intel-  
20 ligence Agency Act of 1949 (50 U.S.C. 403f, 403j).

21 (f) ROLE IN REPROGRAMMING OR TRANSFER OF NIP  
22 FUNDS BY ELEMENTS OF INTELLIGENCE COMMUNITY.—

23 (1) No funds made available under the National Intel-  
24 ligence Program may be reprogrammed or transferred by  
25 any agency or element of the intelligence community with-

1 out the prior approval of the National Intelligence Direc-  
2 tor except in accordance with procedures issued by the Di-  
3 rector.

4 (2) The head of the department concerned shall con-  
5 sult with the Director before reprogramming or transfer-  
6 ring funds appropriated or otherwise made available to an  
7 agency or element of the intelligence community that does  
8 not have any program, project, or activity within the Na-  
9 tional Intelligence Program.

10 (3) The Director shall consult with the appropriate  
11 committees of Congress regarding modifications of exist-  
12 ing procedures to expedite the reprogramming of funds  
13 within the National Intelligence Program.

14 (g) TRANSFER OR REPROGRAMMING OF FUNDS AND  
15 TRANSFER OF PERSONNEL WITHIN NIP.—(1) In addi-  
16 tion to any other authorities available under law for such  
17 purposes, the National Intelligence Director, with the ap-  
18 proval of the Director of the Office of Management and  
19 Budget and after consultation with the heads of the de-  
20 partments containing agencies or elements within the in-  
21 telligence community to the extent their subordinate agen-  
22 cies or elements are affected, with the heads of such subor-  
23 dinate agencies or elements, and with the Director of the  
24 Central Intelligence Agency to the extent the Central In-  
25 telligence Agency is affected, may—

1 (A) transfer or reprogram funds appropriated  
2 for a program within the National Intelligence Pro-  
3 gram to another such program;

4 (B) review, and approve or disapprove, any pro-  
5 posal to transfer or reprogram funds from appro-  
6 priations that are not for the National Intelligence  
7 program to appropriations for the National Intel-  
8 ligence Program;

9 (C) in accordance with procedures to be devel-  
10 oped by the National Intelligence Director, transfer  
11 personnel of the intelligence community funded  
12 through the National Intelligence Program from one  
13 element of the intelligence community to another ele-  
14 ment of the intelligence community; and

15 (D) in accordance with procedures to be devel-  
16 oped by the National Intelligence Director and the  
17 heads of the departments and agencies concerned,  
18 transfer personnel of the intelligence community not  
19 funded through the National Intelligence Program  
20 from one element of the intelligence community to  
21 another element of the intelligence community.

22 (2) A transfer of funds or personnel may not be made  
23 under this subsection if the transfer involves a transfer  
24 of funds to the Reserve for Contingencies of the National  
25 Intelligence Director.

1           (3) Funds transferred under this subsection shall re-  
2 main available for the same period as the appropriations  
3 account to which transferred.

4           (4) Any transfer of funds under this subsection shall  
5 be carried out in accordance with existing procedures ap-  
6 plicable to reprogramming notifications for the appro-  
7 priate congressional committees. Any proposed transfer  
8 for which notice is given to the appropriate congressional  
9 committees shall be accompanied by a report explaining  
10 the nature of the proposed transfer and how it satisfies  
11 the requirements of this subsection. In addition, the con-  
12 gressional intelligence committees shall be promptly noti-  
13 fied of any transfer of funds made pursuant to this sub-  
14 section in any case in which the transfer would not have  
15 otherwise required reprogramming notification under pro-  
16 cedures in effect as of October 24, 1992.

17           (5)(A) The National Intelligence Director shall  
18 promptly submit to the appropriate committees of Con-  
19 gress a report on any transfer of personnel made pursuant  
20 to this subsection. The Director shall include in any such  
21 report an explanation of the nature of the transfer and  
22 how it satisfies the requirements of this subsection.

23           (B) In this paragraph, the term “appropriate com-  
24 mittees of Congress” means—

1 (i)(I) the Committee on Appropriations and the  
2 Select Committee on Intelligence of the Senate; and

3 (II) the Committee on Appropriations and the  
4 Permanent Select Committee on Intelligence of the  
5 House of Representatives;

6 (ii) in the case of a transfer of personnel to or  
7 from the Department of Defense—

8 (I) the committees and select committees  
9 referred to in clause (i);

10 (II) the Committee on Armed Services of  
11 the Senate; and

12 (III) the Committee on Armed Services of  
13 the House of Representatives; and

14 (iii) in the case of a transfer of personnel to or  
15 from the Federal Bureau of Investigation—

16 (I) the committees and select committees  
17 referred to in clause (i);

18 (II) the Committee on the Judiciary of the  
19 Senate; and

20 (III) the Committee on the Judiciary of  
21 the House of Representatives.

22 (h) INFORMATION TECHNOLOGY AND COMMUNICA-  
23 TIONS.—(1) In conforming with section 205, in carrying  
24 out section 112(a)(16), the National Intelligence Director  
25 shall—

1 (A) establish standards for information tech-  
2 nology and communications across the intelligence  
3 community;

4 (B) develop an integrated information tech-  
5 nology network and enterprise architecture for the  
6 intelligence community, including interface stand-  
7 ards for interoperability to enable automated infor-  
8 mation-sharing among elements of the intelligence  
9 community;

10 (C) maintain an inventory of critical informa-  
11 tion technology and communications systems, and  
12 eliminate unnecessary or duplicative systems;

13 (D) establish contingency plans for the intel-  
14 ligence community regarding information technology  
15 and communications; and

16 (E) establish policies, doctrine, training, and  
17 other measures necessary to ensure that the intel-  
18 ligence community develops an integrated informa-  
19 tion technology and communications network that  
20 ensures information-sharing.

21 (2) Consistent with section 205, the Director shall  
22 take any action necessary, including the setting of stand-  
23 ards for information technology and communications  
24 across the intelligence community, to develop an inte-  
25 grated information technology and communications net-

1 work that ensures information-sharing across the intel-  
2 ligence community.

3 (i) COORDINATION WITH FOREIGN GOVERN-  
4 MENTS.—In a manner consistent with section 207 of the  
5 Foreign Service Act of 1980 (22 U.S.C. 3927), the Na-  
6 tional Intelligence Director shall oversee and direct the Di-  
7 rector of the Central Intelligence Agency in coordinating,  
8 under section 103(f) of the National Security Act of 1947,  
9 the relationships between elements of the intelligence com-  
10 munity and the intelligence or security services of foreign  
11 governments on all matters involving intelligence related  
12 to the national security or involving intelligence acquired  
13 through clandestine means.

14 (j) OPEN SOURCE INFORMATION COLLECTION.—The  
15 National Intelligence Director shall establish and maintain  
16 within the intelligence community an effective and effi-  
17 cient open-source information collection capability.

18 (k) ACCESS TO INFORMATION.—Except as otherwise  
19 directed by the President, the head of each element of the  
20 intelligence community shall promptly provide the Na-  
21 tional Intelligence Director such information in the posses-  
22 sion or under the control of such element as the Director  
23 may request in order to facilitate the exercise of the au-  
24 thorities and responsibilities of the Director under this  
25 Act.

1 **SEC. 114. ENHANCED PERSONNEL MANAGEMENT.**

2 (a) REWARDS FOR SERVICE IN CERTAIN POSI-  
3 TIONS.—(1) The National Intelligence Director shall pre-  
4 scribe regulations to provide incentives for service on the  
5 staff of the national intelligence centers, on the staff of  
6 the National Counterterrorism Center, and in other posi-  
7 tions in support of the intelligence community manage-  
8 ment functions of the Director.

9 (2) Incentives under paragraph (1) may include fi-  
10 nancial incentives, bonuses, and such other awards and  
11 incentives as the Director considers appropriate.

12 (b) ENHANCED PROMOTION FOR SERVICE UNDER  
13 NID.—Notwithstanding any other provision of law, the  
14 National Intelligence Director shall ensure that personnel  
15 of an element of the intelligence community who are as-  
16 signed or detailed to service under the National Intel-  
17 ligence Director shall be promoted at rates equivalent to  
18 or better than personnel of such element who are not so  
19 assigned or detailed.

20 (c) JOINT CAREER MATTERS.—(1) In carrying out  
21 section 112(a)(8), the National Intelligence Director shall  
22 prescribe mechanisms to facilitate the rotation of per-  
23 sonnel of the intelligence community through various ele-  
24 ments of the intelligence community in the course of their  
25 careers in order to facilitate the widest possible under-



1 standing by such personnel of the variety of intelligence  
2 requirements, methods, and disciplines.

3 (2) The mechanisms prescribed under paragraph (1)  
4 may include the following:

5 (A) The establishment of special occupational  
6 categories involving service, over the course of a ca-  
7 reer, in more than one element of the intelligence  
8 community.

9 (B) The provision of rewards for service in posi-  
10 tions undertaking analysis and planning of oper-  
11 ations involving two or more elements of the intel-  
12 ligence community.

13 (C) The establishment of requirements for edu-  
14 cation, training, service, and evaluation that involve  
15 service in more than one element of the intelligence  
16 community.

17 (3) It is the sense of Congress that the mechanisms  
18 prescribed under this subsection should, to the extent  
19 practical, seek to duplicate within the intelligence commu-  
20 nity the joint officer management policies established by  
21 the Goldwater–Nichols Department of Defense Reorga-  
22 nization Act of 1986 (Public Law 99–433) and the amend-  
23 ments on joint officer management made by that Act.

1 **SEC. 115. SECURITY CLEARANCES.**

2 (a) IN GENERAL.—The President, in consultation  
3 with the National Intelligence Director, the department,  
4 agency, or element selected under (b), and other appro-  
5 priate officials shall—

6 (1) establish uniform standards and procedures  
7 for the grant of access to classified information for  
8 employees and contractor personnel of the United  
9 States Government who require access to such infor-  
10 mation;

11 (2) ensure the consistent implementation of the  
12 standards and procedures established under para-  
13 graph (1) throughout the departments, agencies, and  
14 elements of the United States Government and  
15 under contracts entered into by such departments,  
16 agencies, and elements;

17 (3) ensure that an individual who is granted or  
18 continued eligibility for access to classified informa-  
19 tion is treated by each department, agency, or ele-  
20 ment of the executive branch as eligible for access to  
21 classified information at that level for all purposes  
22 of each such department, agency, or element, re-  
23 gardless of which department, agency, or element of  
24 the executive branch granted or continued the eligi-  
25 bility of such individual for access to classified infor-  
26 mation;

1           (4) establish uniform requirements and stand-  
2           ards, including security requirements for security  
3           questionnaires and financial disclosure and stand-  
4           ards for administering polygraph examinations, to be  
5           utilized for the performance of security clearance in-  
6           vestigations, including by the contractors conducting  
7           such investigations; and

8           (5) ensure that the database established under  
9           subsection (b)(2)(B) meets the needs of the intel-  
10          ligence community.

11          (b) PERFORMANCE OF SECURITY CLEARANCE INVES-  
12          TIGATIONS.—(1) Not later than 45 days after the date of  
13          the enactment of this Act, the President shall select a sin-  
14          gle department, agency, or element of the executive branch  
15          to conduct all security clearance investigations of employ-  
16          ees and contractor personnel of the United States Govern-  
17          ment who require access to classified information and to  
18          provide and maintain all security clearances of such em-  
19          ployees and contractor personnel.

20          (2) The department, agency, or element selected  
21          under paragraph (1) shall—

22                  (A) take all necessary actions to carry out  
23                  the requirements of this section, including en-  
24                  tering into a memorandum of understanding  
25                  with any agency carrying out responsibilities re-

1           lating to security clearances or security clear-  
2           ance investigations before the date of the enact-  
3           ment of this Act;

4           (B) as soon as practicable, establish and  
5           maintain a single database for tracking security  
6           clearance applications, security clearance inves-  
7           tigations, and determinations of eligibility for  
8           security clearances; and

9           (C) ensure that security clearance inves-  
10          tigations are conducted in accordance with uni-  
11          form standards and requirements established  
12          under subsection (a)(4), including uniform se-  
13          curity questionnaires and financial disclosure  
14          requirements.

15 **SEC. 116. NATIONAL INTELLIGENCE RESERVE CORPS.**

16          (a) **ESTABLISHMENT.**—The National Intelligence Di-  
17          rector may provide for the establishment and training of  
18          a National Intelligence Reserve Corps (in this section re-  
19          ferred to as “National Intelligence Reserve Corps”) for the  
20          temporary reemployment on a voluntary basis of former  
21          employees of elements of the intelligence community dur-  
22          ing periods of emergency, as determined by the Director.

23          (b) **ELIGIBLE INDIVIDUALS.**—An individual may par-  
24          ticipate in the National Intelligence Reserve Corps only

1 if the individual previously served as a full time employee  
2 of an element of the intelligence community.

3 (c) LIMITATION ON MEMBERSHIP.—The total num-  
4 ber of individuals who are members of the National Intel-  
5 ligence Reserve Corps at any given time may not exceed  
6 200 individuals.

7 (d) TERMS OF PARTICIPATION.—The National Intel-  
8 ligence Director shall prescribe the terms and conditions  
9 under which eligible individuals may participate in the Na-  
10 tional Intelligence Reserve Corps.

11 (e) EXPENSES.—The National Intelligence Director  
12 may provide members of the National Intelligence Reserve  
13 Corps transportation and per diem in lieu of subsistence  
14 for purposes of participating in any training that relates  
15 to service as a member of the Reserve Corps.

16 (f) TREATMENT OF ANNUITANTS.—(1) If an annu-  
17 itant receiving an annuity from the Civil Service Retire-  
18 ment and Disability Fund becomes temporarily reem-  
19 ployed pursuant to this section, such annuity shall not be  
20 discontinued thereby.

21 (2) An annuitant so reemployed shall not be consid-  
22 ered an employee for the purposes of chapter 83 or 84  
23 of title 5, United States Code.

24 (g) TREATMENT UNDER NATIONAL INTELLIGENCE  
25 AUTHORITY PERSONNEL CEILING.—A member of the Na-

1 tional Intelligence Reserve Corps who is reemployed on a  
2 temporary basis pursuant to this section shall not count  
3 against any personnel ceiling applicable to the National  
4 Intelligence Authority.

5 **SEC. 117. APPOINTMENT AND TERMINATION OF CERTAIN**  
6 **OFFICIALS RESPONSIBLE FOR INTEL-**  
7 **LIGENCE-RELATED ACTIVITIES.**

8       (a) **RECOMMENDATION OF NID IN CERTAIN AP-**  
9 **POINTMENT.**—In the event of a vacancy in the position  
10 of Director of the Central Intelligence Agency, the Na-  
11 tional Intelligence Director shall recommend to the Presi-  
12 dent an individual for nomination to fill the vacancy.

13       (b) **CONCURRENCE OF SECRETARY OF DEFENSE IN**  
14 **CERTAIN APPOINTMENTS RECOMMENDED BY NID.**—(1)  
15 In the event of a vacancy in a position referred to in para-  
16 graph (2), the National Intelligence Director shall obtain  
17 the concurrence of the Secretary of Defense before recom-  
18 mending to the President an individual for nomination to  
19 fill such vacancy. If the Secretary does not concur in the  
20 recommendation, the Director may make the recommenda-  
21 tion to the President without the concurrence of the Sec-  
22 retary, but shall include in the recommendation a state-  
23 ment that the Secretary does not concur in the rec-  
24 ommendation.

25       (2) Paragraph (1) applies to the following positions:

1           (A) The Director of the National Security  
2 Agency.

3           (B) The Director of the National Reconnaissance Office.

5           (C) The Director of the National Geospatial-Intelligence Agency.

7           (c) CONCURRENCE OF NID IN CERTAIN APPOINTMENTS.—(1) In the event of a vacancy in a position referred to in paragraph (2), the head of the department or agency having jurisdiction over the position shall obtain the concurrence of the National Intelligence Director before appointing an individual to fill the vacancy or recommending to the President an individual to be nominated to fill the vacancy. If the Director does not concur in the recommendation, the head of the department or agency concerned may fill the vacancy or make the recommendation to the President (as the case may be) without the concurrence of the Director, but shall notify the President that the Director does not concur in appointment or recommendation (as the case may be).

21          (2) Paragraph (1) applies to the following positions:

22           (A) The Under Secretary of Defense for Intelligence.

24           (B) The Assistant Secretary of Homeland Security for Information Analysis.

1 (C) The Director of the Defense Intelligence  
2 Agency.

3 (D) The Executive Assistant Director for Intel-  
4 ligence of the Federal Bureau of Investigation.

5 (d) RECOMMENDATION OF NID ON TERMINATION OF  
6 SERVICE.—The National Intelligence Director may rec-  
7 ommend to the President or the head of the department  
8 or agency concerned the termination of service of any indi-  
9 vidual serving in any position covered by this section.

10 **SEC. 118. RESERVE FOR CONTINGENCIES OF THE NA-**  
11 **TIONAL INTELLIGENCE DIRECTOR.**

12 (a) ESTABLISHMENT.—There is hereby established  
13 on the books of the Treasury an account to be known as  
14 the Reserve for Contingencies of the National Intelligence  
15 Director.

16 (b) ELEMENTS.—The Reserve shall consist of the fol-  
17 lowing elements:

18 (1) Amounts authorized to be appropriated to  
19 the Reserve.

20 (2) Any amounts authorized to be transferred  
21 to or deposited in the Reserve by law.

22 (c) AVAILABILITY.—Amounts in the Reserve shall be  
23 available for such purposes as are provided by law.

24 (d) TRANSFER OF FUNDS OF RESERVE FOR CONTIN-  
25 GENCIES OF CIA.—There shall be transferred to the Re-



1 serve for Contingencies of the National Intelligence Direc-  
2 tor all unobligated balances of the Reserve for Contin-  
3 gencies of the Central Intelligence Agency as of the date  
4 of the enactment of this Act.

5 **Subtitle C—Office of the National**  
6 **Intelligence Director**

7 **SEC. 121. OFFICE OF THE NATIONAL INTELLIGENCE DIREC-**  
8 **TOR.**

9 (a) OFFICE OF NATIONAL INTELLIGENCE DIREC-  
10 TOR.—There is within the National Intelligence Authority  
11 an Office of the National Intelligence Director.

12 (b) FUNCTION.—The function of the Office of the  
13 National Intelligence Director is to assist the National In-  
14 telligence Director in carrying out the duties and respon-  
15 sibilities of the Director under this Act, the National Secu-  
16 rity Act of 1947 (50 U.S.C. 401 et seq.), and other appli-  
17 cable provisions of law, and to carry out such other duties  
18 as may be prescribed by the President or by law.

19 (c) COMPOSITION.—The Office of the National Intel-  
20 ligence Director is composed of the following:

21 (1) The Principal Deputy National Intelligence  
22 Director.

23 (2) Any Deputy National Intelligence Director  
24 appointed under section 122(b).

25 (3) The National Intelligence Council.

1           (4) The General Counsel of the National Intel-  
2           ligence Authority.

3           (5) The Intelligence Comptroller.

4           (6) The Officer for Civil Rights and Civil Lib-  
5           erties of the National Intelligence Authority.

6           (7) The Privacy Officer of the National Intel-  
7           ligence Authority.

8           (8) The Chief Information Officer of the Na-  
9           tional Intelligence Authority.

10          (9) The Chief Human Capital Officer of the  
11          National Intelligence Authority.

12          (10) The National Counterintelligence Execu-  
13          tive (including the Office of the National Counter-  
14          intelligence Executive).

15          (11) Such other offices and officials as may be  
16          established by law or the Director may establish or  
17          designate in the Office.

18          (d) STAFF.—(1) To assist the National Intelligence  
19          Director in fulfilling the duties and responsibilities of the  
20          Director, the Director shall employ and utilize in the Of-  
21          fice of the National Intelligence Director a professional  
22          staff having an expertise in matters relating to such duties  
23          and responsibilities, and may establish permanent posi-  
24          tions and appropriate rates of pay with respect to that  
25          staff.

1           (2) The staff of the Office of the National Intelligence  
2 Director under paragraph (1) shall include the staff of the  
3 Office of the Deputy Director of Central Intelligence for  
4 Community Management that is transferred to the Office  
5 of the National Intelligence Director under section 321.

6           (e) PROHIBITION ON CO-LOCATION WITH OTHER  
7 ELEMENTS OF INTELLIGENCE COMMUNITY.—Com-  
8 mencing as of October 1, 2006, the Office of the National  
9 Intelligence Director may not be co-located with any other  
10 element of the intelligence community.

11 **SEC. 122. DEPUTY NATIONAL INTELLIGENCE DIRECTORS.**

12           (a) PRINCIPAL DEPUTY NATIONAL INTELLIGENCE  
13 DIRECTOR.—(1) There is a Principal Deputy National In-  
14 telligence Director who shall be appointed by the Presi-  
15 dent, by and with the advice and consent of the Senate.

16           (2) In the event of a vacancy in the position of Prin-  
17 cipal Deputy National Intelligence Director, the National  
18 Intelligence Director shall recommend to the President an  
19 individual for appointment as Principal Deputy National  
20 Intelligence Director.

21           (3) Any individual nominated for appointment as  
22 Principal Deputy National Intelligence Director shall have  
23 extensive national security experience and management  
24 expertise.

1           (4) The individual serving as Principal Deputy Na-  
2 tional Intelligence Director may not, while so serving,  
3 serve in any capacity in any other element of the intel-  
4 ligence community, except to the extent that the individual  
5 serving as Principal Deputy National Intelligence Director  
6 is doing so in an acting capacity.

7           (5) The Principal Deputy National Intelligence Di-  
8 rector shall assist the National Intelligence Director in  
9 carrying out the duties and responsibilities of the Director.

10          (6) The Principal Deputy National Intelligence Di-  
11 rector shall act for, and exercise the powers of, the Na-  
12 tional Intelligence Director during the absence or dis-  
13 ability of the National Intelligence Director or during a  
14 vacancy in the position of National Director of Intel-  
15 ligence.

16          (b) DEPUTY NATIONAL INTELLIGENCE DIREC-  
17 TORS.—(1) There may be not more than four Deputy Na-  
18 tional Intelligence Directors who shall be appointed by the  
19 President.

20          (2) In the event of a vacancy in any position of Dep-  
21 uty National Intelligence Director established under this  
22 subsection, the National Intelligence Director shall rec-  
23 ommend to the President an individual for appointment  
24 to such position.

1           (3) Each Deputy National Intelligence Director ap-  
2 pointed under this subsection shall have such duties, re-  
3 sponsibilities, and authorities as the National Intelligence  
4 Director may assign or are specified by law.

5 **SEC. 123. NATIONAL INTELLIGENCE COUNCIL.**

6           (a) NATIONAL INTELLIGENCE COUNCIL.—There is a  
7 National Intelligence Council.

8           (b) COMPOSITION.—(1) The National Intelligence  
9 Council shall be composed of senior analysts within the  
10 intelligence community and substantive experts from the  
11 public and private sector, who shall be appointed by, re-  
12 port to, and serve at the pleasure of, the National Intel-  
13 ligence Director.

14           (2) The Director shall prescribe appropriate security  
15 requirements for personnel appointed from the private sec-  
16 tor as a condition of service on the Council, or as contrac-  
17 tors of the Council or employees of such contractors, to  
18 ensure the protection of intelligence sources and methods  
19 while avoiding, wherever possible, unduly intrusive re-  
20 quirements which the Director considers to be unnecessary  
21 for this purpose.

22           (c) DUTIES AND RESPONSIBILITIES.—(1) The Na-  
23 tional Intelligence Council shall—

24                   (A) produce national intelligence estimates for  
25                   the United States Government, including alternative

1 views held by elements of the intelligence community  
2 and other information as specified in paragraph (2);

3 (B) evaluate community-wide collection and  
4 production of intelligence by the intelligence commu-  
5 nity and the requirements and resources of such col-  
6 lection and production; and

7 (C) otherwise assist the National Intelligence  
8 Director in carrying out the responsibilities of the  
9 Director under section 111.

10 (2) The National Intelligence Director shall ensure  
11 that the Council satisfies the needs of policymakers and  
12 other consumers of intelligence by ensuring that each na-  
13 tional intelligence estimate under paragraph (1)—

14 (A) states separately, and distinguishes be-  
15 tween, the intelligence underlying such estimate and  
16 the assumptions and judgments of analysts with re-  
17 spect to such intelligence and such estimate;

18 (B) describes the quality and reliability of the  
19 intelligence underlying such estimate;

20 (C) presents and explains alternative conclu-  
21 sions, if any, with respect to the intelligence under-  
22 lying such estimate and such estimate; and

23 (D) characterizes the uncertainties, if any, and  
24 confidence in such estimate.

1 (d) SERVICE AS SENIOR INTELLIGENCE ADVISERS.—  
2 Within their respective areas of expertise and under the  
3 direction of the National Intelligence Director, the mem-  
4 bers of the National Intelligence Council shall constitute  
5 the senior intelligence advisers of the intelligence commu-  
6 nity for purposes of representing the views of the intel-  
7 ligence community within the United States Government.

8 (e) AUTHORITY TO CONTRACT.—Subject to the di-  
9 rection and control of the National Intelligence Director,  
10 the National Intelligence Council may carry out its respon-  
11 sibilities under this section by contract, including con-  
12 tracts for substantive experts necessary to assist the  
13 Council with particular assessments under this section.

14 (f) STAFF.—The National Intelligence Director shall  
15 make available to the National Intelligence Council such  
16 staff as may be necessary to permit the Council to carry  
17 out its responsibilities under this section.

18 (g) AVAILABILITY OF COUNCIL AND STAFF.—(1)  
19 The National Intelligence Director shall take appropriate  
20 measures to ensure that the National Intelligence Council  
21 and its staff satisfy the needs of policymaking officials and  
22 other consumers of intelligence.

23 (2) The Council shall be readily accessible to policy-  
24 making officials and other appropriate individuals not oth-  
25 erwise associated with the intelligence community.

1 (h) SUPPORT.—The heads of the elements of the in-  
2 telligence community shall, as appropriate, furnish such  
3 support to the National Intelligence Council, including the  
4 preparation of intelligence analyses, as may be required  
5 by the National Intelligence Director.

6 **SEC. 124. GENERAL COUNSEL OF THE NATIONAL INTEL-**  
7 **LIGENCE AUTHORITY.**

8 (a) GENERAL COUNSEL OF NATIONAL INTEL-  
9 LIGENCE AUTHORITY.—There is a General Counsel of the  
10 National Intelligence Authority who shall be appointed  
11 from civilian life by the President, by and with the advice  
12 and consent of the Senate.

13 (b) PROHIBITION ON DUAL SERVICE AS GENERAL  
14 COUNSEL OF ANOTHER AGENCY.—The individual serving  
15 in the position of General Counsel of the National Intel-  
16 ligence Authority may not, while so serving, also serve as  
17 the General Counsel of any other department, agency, or  
18 element of the United States Government.

19 (c) SCOPE OF POSITION.—The General Counsel of  
20 the National Intelligence Authority is the chief legal offi-  
21 cer of the National Intelligence Authority.

22 (d) FUNCTIONS.—The General Counsel of the Na-  
23 tional Intelligence Authority shall perform such functions  
24 as the National Intelligence Director may prescribe.



1 **SEC. 125. INTELLIGENCE COMPTROLLER.**

2 (a) INTELLIGENCE COMPTROLLER.—There is an In-  
3 telligence Comptroller who shall be appointed from civilian  
4 life by the National Intelligence Director.

5 (b) SUPERVISION.—The Intelligence Comptroller  
6 shall report directly to the National Intelligence Director.

7 (c) DUTIES.—The Intelligence Comptroller shall—

8 (1) assist the National Intelligence Director in  
9 the preparation and execution of the budget of the  
10 elements of the intelligence community within the  
11 National Intelligence Program;

12 (2) assist the Director in participating in the  
13 development by the Secretary of Defense of the an-  
14 nual budget for military intelligence programs and  
15 activities outside the National Intelligence Program;

16 (3) provide unfettered access to the Director to  
17 financial information under the National Intelligence  
18 Program;

19 (4) perform such other duties as may be pre-  
20 scribed by the Director or specified by law.

21 **SEC. 126. OFFICER FOR CIVIL RIGHTS AND CIVIL LIB-**  
22 **ERTIES OF THE NATIONAL INTELLIGENCE**  
23 **AUTHORITY.**

24 (a) OFFICER FOR CIVIL RIGHTS AND CIVIL LIB-  
25 ERTIES OF NATIONAL INTELLIGENCE AUTHORITY.—  
26 There is an Officer for Civil Rights and Civil Liberties

1 of the National Intelligence Authority who shall be ap-  
2 pointed by the President.

3 (b) SUPERVISION.—The Officer for Civil Rights and  
4 Civil Liberties of the National Intelligence Authority shall  
5 report directly to the National Intelligence Director.

6 (c) DUTIES.—The Officer for Civil Rights and Civil  
7 Liberties of the National Intelligence Authority shall—

8 (1) assist the National Intelligence Director in  
9 ensuring that the protection of civil rights and civil  
10 liberties, as provided in the Constitution, laws, regu-  
11 lations, and Executive orders of the United States,  
12 is appropriately incorporated in—

13 (A) the policies and procedures developed  
14 for and implemented by the National Intel-  
15 ligence Authority;

16 (B) the policies and procedures regarding  
17 the relationships among the elements of the in-  
18 telligence community within the National Intel-  
19 ligence Program; and

20 (C) the policies and procedures regarding  
21 the relationships between the elements of the  
22 intelligence community within the National In-  
23 telligence Program and the other elements of  
24 the intelligence community;

1           (2) oversee compliance by the Authority, and in  
2           the relationships described in paragraph (1), with  
3           requirements under the Constitution and all laws,  
4           regulations, Executive orders, and implementing  
5           guidelines relating to civil rights and civil liberties;

6           (3) review, investigate, and assess complaints  
7           and other information indicating possible abuses of  
8           civil rights or civil liberties, as provided in the Con-  
9           stitution, laws, regulations, and Executive orders of  
10          the United States, in the administration of the pro-  
11          grams and operations of the Authority, and in the  
12          relationships described in paragraph (1), unless, in  
13          the determination of the Inspector General of the  
14          National Intelligence Authority, the review, inves-  
15          tigation, or assessment of a particular complaint or  
16          information can better be conducted by the Inspec-  
17          tor General;

18          (4) coordinate with the Privacy Officer of the  
19          National Intelligence Authority to ensure that pro-  
20          grams, policies, and procedures involving civil rights,  
21          civil liberties, and privacy considerations are ad-  
22          dressed in an integrated and comprehensive manner;  
23          and

24          (5) perform such other duties as may be pre-  
25          scribed by the Director or specified by law.

1 **SEC. 127. PRIVACY OFFICER OF THE NATIONAL INTEL-**  
2 **LIGENCE AUTHORITY.**

3 (a) PRIVACY OFFICER OF NATIONAL INTELLIGENCE  
4 AUTHORITY.—There is a Privacy Officer of the National  
5 Intelligence Authority who shall be appointed by the Na-  
6 tional Intelligence Director.

7 (b) DUTIES.—(1) The Privacy Officer of the National  
8 Intelligence Authority shall have primary responsibility for  
9 the privacy policy of the National Intelligence Authority  
10 (including in the relationships among the elements of the  
11 intelligence community within the National Intelligence  
12 Program and the relationships between the elements of the  
13 intelligence community within the National Intelligence  
14 Program and the other elements of the intelligence com-  
15 munity).

16 (2) In discharging the responsibility under paragraph  
17 (1), the Privacy Officer shall—

18 (A) assure that the use of technologies sustain,  
19 and do not erode, privacy protections relating to the  
20 use, collection, and disclosure of personal informa-  
21 tion;

22 (B) assure that personal information contained  
23 in Privacy Act systems of records is handled in full  
24 compliance with fair information practices as set out  
25 in the Privacy Act of 1974;

1 (C) conduct privacy impact assessments when  
2 appropriate or as required by law; and

3 (D) coordinate with the Officer for Civil Rights  
4 and Civil Liberties of the National Intelligence Au-  
5 thority to ensure that programs, policies, and proce-  
6 dures involving civil rights, civil liberties, and pri-  
7 vacy considerations are addressed in an integrated  
8 and comprehensive manner.

9 **SEC. 128. CHIEF INFORMATION OFFICER OF THE NATIONAL**  
10 **INTELLIGENCE AUTHORITY.**

11 (a) CHIEF INFORMATION OFFICER OF NATIONAL IN-  
12 TELLIGENCE AUTHORITY.—There is a Chief Information  
13 Officer of the National Intelligence Authority who shall  
14 be appointed by the National Intelligence Director.

15 (b) DUTIES.—The Chief Information Officer of the  
16 National Intelligence Authority shall—

17 (1) assist the National Intelligence Director in  
18 implementing the responsibilities and executing the  
19 authorities related to information technology under  
20 paragraphs (15) and (16) of section 112(a) and sec-  
21 tion 113(h); and

22 (2) perform such other duties as may be pre-  
23 scribed by the Director or specified by law.

1 **SEC. 129. CHIEF HUMAN CAPITAL OFFICER OF THE NA-**  
2 **TIONAL INTELLIGENCE AUTHORITY.**

3 (a) CHIEF HUMAN CAPITAL OFFICER OF NATIONAL  
4 INTELLIGENCE AUTHORITY.—There is a Chief Human  
5 Capital Officer of the National Intelligence Authority who  
6 shall be appointed by the National Intelligence Director.

7 (b) DUTIES.—The Chief Human Capital Officer of  
8 the National Intelligence Authority shall—

9 (1) have the functions and authorities provided  
10 for Chief Human Capital Officers under sections  
11 1401 and 1402 of title 5, United States Code, with  
12 respect to the National Intelligence Authority; and

13 (2) advise and assist the National Intelligence  
14 Director in exercising the authorities and respon-  
15 sibilities of the Director with respect to the work-  
16 force of the intelligence community as a whole.

17 **SEC. 130. NATIONAL COUNTERINTELLIGENCE EXECUTIVE.**

18 (a) NATIONAL COUNTERINTELLIGENCE EXECU-  
19 TIVE.—The National Counterintelligence Executive under  
20 section 902 of the Counterintelligence Enhancement Act  
21 of 2002 (title IX of Public Law 107–306; 50 U.S.C. 402b  
22 et seq.), as amended by section 309 of this Act, is a com-  
23 ponent of the Office of the National Intelligence Director.

24 (b) DUTIES.—The National Counterintelligence Ex-  
25 ecutive shall perform the duties provided in the Counter-  
26 intelligence Enhancement Act of 2002, as so amended,

1 and such other duties as may be prescribed by the Na-  
2 tional Intelligence Director or specified by law.

3 **Subtitle D—Additional Elements of**  
4 **National Intelligence Authority**

5 **SEC. 141. INSPECTOR GENERAL OF THE NATIONAL INTEL-**  
6 **LIGENCE AUTHORITY.**

7 (a) OFFICE OF INSPECTOR GENERAL OF NATIONAL  
8 INTELLIGENCE AUTHORITY.—There is within the Na-  
9 tional Intelligence Authority an Office of the Inspector  
10 General of the National Intelligence Authority.

11 (b) PURPOSE.—The purpose of the Office of the In-  
12 spector General of the National Intelligence Authority is  
13 to—

14 (1) create an objective and effective office, ap-  
15 propriately accountable to Congress, to initiate and  
16 conduct independently investigations, inspections,  
17 and audits relating to—

18 (A) the programs and operations of the  
19 National Intelligence Authority;

20 (B) the relationships among the elements  
21 of the intelligence community within the Na-  
22 tional Intelligence Program; and

23 (C) the relationships between the elements  
24 of the intelligence community within the Na-

1            tional Intelligence Program and the other ele-  
2            ments of the intelligence community;

3            (2) recommend policies designed—

4                    (A) to promote economy, efficiency, and ef-  
5            fectiveness in the administration of such pro-  
6            grams and operations, and in such relation-  
7            ships; and

8                    (B) to prevent and detect fraud and abuse  
9            in such programs, operations, and relationships;

10           (3) provide a means for keeping the National  
11           Intelligence Director fully and currently informed  
12           about—

13                    (A) problems and deficiencies relating to  
14           the administration of such programs and oper-  
15           ations, and to such relationships; and

16                    (C) the necessity for, and the progress of,  
17           corrective actions; and

18           (4) in the manner prescribed by this section,  
19           ensure that the congressional intelligence committees  
20           are kept similarly informed of—

21                    (A) significant problems and deficiencies  
22           relating to the administration of such programs  
23           and operations, and to such relationships; and

24                    (B) the necessity for, and the progress of,  
25           corrective actions.



1 (c) INSPECTOR GENERAL OF NATIONAL INTEL-  
2 LIGENCE AUTHORITY.—(1) There is an Inspector General  
3 of the National Intelligence Authority, who shall be the  
4 head of the Office of the Inspector General of the National  
5 Intelligence Authority, who shall be appointed by the  
6 President, by and with the advice and consent of the Sen-  
7 ate.

8 (2) The nomination of an individual for appointment  
9 as Inspector General shall be made—

10 (A) without regard to political affiliation;

11 (B) solely on the basis of integrity, compliance  
12 with the security standards of the National Intel-  
13 ligence Authority, and prior experience in the field  
14 of intelligence or national security; and

15 (C) on the basis of demonstrated ability in ac-  
16 counting, financial analysis, law, management anal-  
17 ysis, public administration, or auditing.

18 (3) The Inspector General shall report directly to and  
19 be under the general supervision of the National Intel-  
20 ligence Director.

21 (4) The Inspector General may be removed from of-  
22 fice only by the President. The President shall imme-  
23 diately communicate in writing to the congressional intel-  
24 ligence committees the reasons for the removal of any indi-  
25 vidual from the position of Inspector General.

1 (d) DUTIES AND RESPONSIBILITIES.—It shall be the  
2 duty and responsibility of the Inspector General of the Na-  
3 tional Intelligence Authority—

4 (1) to provide policy direction for, and to plan,  
5 conduct, supervise, and coordinate independently,  
6 the investigations, inspections, and audits relating to  
7 the programs and operations of the National Intel-  
8 ligence Authority, the relationships among the ele-  
9 ments of the intelligence community within the Na-  
10 tional Intelligence Program, and the relationships  
11 between the elements of the intelligence community  
12 within the National Intelligence Program and the  
13 other elements of the intelligence community to en-  
14 sure they are conducted efficiently and in accordance  
15 with applicable law and regulations;

16 (2) to keep the National Intelligence Director  
17 fully and currently informed concerning violations of  
18 law and regulations, violations of civil liberties and  
19 privacy, and fraud and other serious problems,  
20 abuses, and deficiencies that may occur in such pro-  
21 grams and operations, and in such relationships, and  
22 to report the progress made in implementing correc-  
23 tive action;

24 (3) to take due regard for the protection of in-  
25 telligence sources and methods in the preparation of

1 all reports issued by the Inspector General, and, to  
2 the extent consistent with the purpose and objective  
3 of such reports, take such measures as may be ap-  
4 propriate to minimize the disclosure of intelligence  
5 sources and methods described in such reports; and

6 (4) in the execution of the duties and respon-  
7 sibilities under this section, to comply with generally  
8 accepted government auditing standards.

9 (e) LIMITATIONS ON ACTIVITIES.—(1) The National  
10 Intelligence Director may prohibit the Inspector General  
11 of the National Intelligence Authority from initiating, car-  
12 rying out, or completing any investigation, inspection, or  
13 audit if the Director determines that such prohibition is  
14 necessary to protect vital national security interests of the  
15 United States.

16 (2) If the Director exercises the authority under  
17 paragraph (1), the Director shall submit an appropriately  
18 classified statement of the reasons for the exercise of such  
19 authority within seven days to the congressional intel-  
20 ligence committees.

21 (3) The Director shall advise the Inspector General  
22 at the time a report under paragraph (1) is submitted,  
23 and, to the extent consistent with the protection of intel-  
24 ligence sources and methods, provide the Inspector Gen-  
25 eral with a copy of such report.

1           (4) The Inspector General may submit to the con-  
2 gressional intelligence committees any comments on a re-  
3 port of which the Inspector General has notice under para-  
4 graph (3) that the Inspector General considers appro-  
5 priate.

6           (f) AUTHORITIES.—(1) The Inspector General of the  
7 National Intelligence Authority shall have direct and  
8 prompt access to the National Intelligence Director when  
9 necessary for any purpose pertaining to the performance  
10 of the duties of the Inspector General.

11           (2)(A) The Inspector General shall have access to any  
12 employee, or any employee of a contractor, of the National  
13 Intelligence Authority, and of any other element of the in-  
14 telligence community within the National Intelligence Pro-  
15 gram, whose testimony is needed for the performance of  
16 the duties of the Inspector General.

17           (B) The Inspector General shall have direct access  
18 to all records, reports, audits, reviews, documents, papers,  
19 recommendations, or other material which relate to the  
20 programs and operations with respect to which the Inspec-  
21 tor General has responsibilities under this section.

22           (C) The level of classification or compartmentation  
23 of information shall not, in and of itself, provide a suffi-  
24 cient rationale for denying the Inspector General access  
25 to any materials under subparagraph (B).

1 (D) Failure on the part of any employee or contractor  
2 of the National Intelligence Authority to cooperate with  
3 the Inspector General shall be grounds for appropriate ad-  
4 ministrative actions by the Director, including loss of em-  
5 ployment or the termination of an existing contractual re-  
6 lationship.

7 (3) The Inspector General is authorized to receive  
8 and investigate complaints or information from any person  
9 concerning the existence of an activity constituting a viola-  
10 tion of laws, rules, or regulations, or mismanagement,  
11 gross waste of funds, abuse of authority, or a substantial  
12 and specific danger to the public health and safety. Once  
13 such complaint or information has been received from an  
14 employee of the Federal government—

15 (A) the Inspector General shall not disclose the  
16 identity of the employee without the consent of the  
17 employee, unless the Inspector General determines  
18 that such disclosure is unavoidable during the course  
19 of the investigation or the disclosure is made to an  
20 official of the Department of Justice responsible for  
21 determining whether a prosecution should be under-  
22 taken; and

23 (B) no action constituting a reprisal, or threat  
24 of reprisal, for making such complaint may be taken  
25 by any employee in a position to take such actions,

1 unless the complaint was made or the information  
2 was disclosed with the knowledge that it was false  
3 or with willful disregard for its truth or falsity.

4 (4) The Inspector General shall have authority to ad-  
5 minister to or take from any person an oath, affirmation,  
6 or affidavit, whenever necessary in the performance of the  
7 duties of the Inspector General, which oath, affirmation,  
8 or affidavit when administered or taken by or before an  
9 employee of the Office of the Inspector General of the Na-  
10 tional Intelligence Authority designated by the Inspector  
11 General shall have the same force and effect as if adminis-  
12 tered or taken by or before an officer having a seal.

13 (5)(A) Except as provided in subparagraph (B), the  
14 Inspector General is authorized to require by subpoena the  
15 production of all information, documents, reports, an-  
16 swers, records, accounts, papers, and other data and docu-  
17 mentary evidence necessary in the performance of the du-  
18 ties and responsibilities of the Inspector General.

19 (B) In the case of departments, agencies, and other  
20 elements of the United States Government, the Inspector  
21 General shall obtain information, documents, reports, an-  
22 swers, records, accounts, papers, and other data and evi-  
23 dence for the purpose specified in subparagraph (A) using  
24 procedures other than by subpoenas.

1 (C) The Inspector General may not issue a subpoena  
2 for or on behalf of any other element or component of the  
3 Authority.

4 (D) In the case of contumacy or refusal to obey a  
5 subpoena issued under this paragraph, the subpoena shall  
6 be enforceable by order of any appropriate district court  
7 of the United States.

8 (g) STAFF AND OTHER SUPPORT.—(1) The Inspec-  
9 tor General of the National Intelligence Authority shall be  
10 provided with appropriate and adequate office space at  
11 central and field office locations, together with such equip-  
12 ment, office supplies, maintenance services, and commu-  
13 nications facilities and services as may be necessary for  
14 the operation of such offices.

15 (2)(A) Subject to applicable law and the policies of  
16 the National Intelligence Director, the Inspector General  
17 shall select, appoint and employ such officers and employ-  
18 ees as may be necessary to carry out the functions of the  
19 Inspector General.

20 (B) In making selections under subparagraph (A),  
21 the Inspector General shall ensure that such officers and  
22 employees have the requisite training and experience to  
23 enable the Inspector General to carry out the duties of  
24 the Inspector General effectively.

1 (C) In meeting the requirements of this paragraph,  
2 the Inspector General shall create within the Office of the  
3 Inspector General of the National Intelligence Authority  
4 a career cadre of sufficient size to provide appropriate con-  
5 tinuity and objectivity needed for the effective perform-  
6 ance of the duties of the Inspector General.

7 (3)(A) Subject to the concurrence of the Director, the  
8 Inspector General may request such information or assist-  
9 ance as may be necessary for carrying out the duties and  
10 responsibilities of the Inspector General from any depart-  
11 ment, agency, or other element of the United States Gov-  
12 ernment.

13 (B) Upon request of the Inspector General for infor-  
14 mation or assistance under subparagraph (A), the head  
15 of the department, agency, or element concerned shall, in-  
16 sofar as is practicable and not in contravention of any ex-  
17 isting statutory restriction or regulation of the depart-  
18 ment, agency, or element, furnish to the Inspector Gen-  
19 eral, or to an authorized designee, such information or as-  
20 sistance.

21 (h) REPORTS.—(1)(A) The Inspector General of the  
22 National Intelligence Authority shall, not later than Janu-  
23 ary 31 and July 31 of each year, prepare and submit to  
24 the National Intelligence Director a classified semiannual  
25 report summarizing the activities of the Office of the In-



1 spector General of the National Intelligence Authority  
2 during the immediately preceding six-month periods end-  
3 ing December 31 (of the preceding year) and June 30,  
4 respectively.

5 (B) Each report under this paragraph shall include,  
6 at a minimum, the following:

7 (i) A list of the title or subject of each inves-  
8 tigation, inspection, or audit conducted during the  
9 period covered by such report.

10 (ii) A description of significant problems,  
11 abuses, and deficiencies relating to the administra-  
12 tion of programs and operations of the National In-  
13 telligence Authority identified by the Inspector Gen-  
14 eral during the period covered by such report.

15 (iii) A description of the recommendations for  
16 corrective action made by the Inspector General dur-  
17 ing the period covered by such report with respect  
18 to significant problems, abuses, or deficiencies iden-  
19 tified in clause (ii).

20 (iv) A statement whether or not corrective ac-  
21 tion has been completed on each significant rec-  
22 ommendation described in previous semiannual re-  
23 ports, and, in a case where corrective action has  
24 been completed, a description of such corrective ac-  
25 tion.

1           (v) An assessment of the effectiveness of all  
2           measures in place in the Authority for the protection  
3           of civil liberties and privacy of United States per-  
4           sons.

5           (vi) A certification whether or not the Inspector  
6           General has had full and direct access to all infor-  
7           mation relevant to the performance of the functions  
8           of the Inspector General.

9           (vii) A description of the exercise of the sub-  
10          poena authority under subsection (f)(5) by the In-  
11          spector General during the period covered by such  
12          report.

13          (viii) Such recommendations as the Inspector  
14          General considers appropriate for legislation to pro-  
15          mote economy and efficiency in the administration of  
16          programs and operations undertaken by the Author-  
17          ity, and to detect and eliminate fraud and abuse in  
18          such programs and operations.

19          (C) Not later than the 30 days after the date of re-  
20          ceipt of a report under subparagraph (A), the Director  
21          shall transmit the report to the congressional intelligence  
22          committees together with any comments the Director con-  
23          siders appropriate.

24          (2)(A) The Inspector General shall report imme-  
25          diately to the Director whenever the Inspector General be-

1 comes aware of particularly serious or flagrant problems,  
2 abuses, or deficiencies relating to the administration of  
3 programs or operations of the Authority, a relationship be-  
4 tween the elements of the intelligence community within  
5 the National Intelligence Program, or a relationship be-  
6 tween an element of the intelligence community within the  
7 National Intelligence Program and another element of the  
8 intelligence community.

9 (B) The Director shall transmit to the congressional  
10 intelligence committees each report under subparagraph  
11 (A) within seven calendar days of receipt of such report,  
12 together with such comments as the Director considers ap-  
13 propriate.

14 (3) In the event that—

15 (A) the Inspector General is unable to resolve  
16 any differences with the Director affecting the exe-  
17 cution of the duties or responsibilities of the Inspec-  
18 tor General;

19 (B) an investigation, inspection, or audit car-  
20 ried out by the Inspector General should focus on  
21 any current or former Authority official who holds  
22 or held a position in the Authority that is subject to  
23 appointment by the President, by and with the ad-  
24 vice and consent of the Senate, including such a po-  
25 sition held on an acting basis;

1 (C) a matter requires a report by the Inspector  
2 General to the Department of Justice on possible  
3 criminal conduct by a current or former official de-  
4 scribed in subparagraph (B);

5 (D) the Inspector General receives notice from  
6 the Department of Justice declining or approving  
7 prosecution of possible criminal conduct of any cur-  
8 rent or former official described in subparagraph  
9 (B); or

10 (E) the Inspector General, after exhausting all  
11 possible alternatives, is unable to obtain significant  
12 documentary information in the course of an inves-  
13 tigation, inspection, or audit,  
14 the Inspector General shall immediately notify and submit  
15 a report on such matter to the congressional intelligence  
16 committees.

17 (4) Pursuant to title V of the National Security Act  
18 of 1947 (50 U.S.C. 413 et seq.), the Director shall submit  
19 to the congressional intelligence committees any report or  
20 findings and recommendations of an investigation, inspec-  
21 tion, or audit conducted by the office which has been re-  
22 quested by the Chairman or Ranking Minority Member  
23 of either committee.

24 (5)(A) An employee of the Authority, an employee of  
25 an entity other than the Authority who is assigned or de-

1 tailed to the Authority, or an employee of a contractor  
2 to the Authority who intends to report to Congress a com-  
3 plaint or information with respect to an urgent concern  
4 may report such complaint or information to the Inspector  
5 General.

6 (B) Not later than the end of the 14-calendar day  
7 period beginning on the date of receipt from an employee  
8 of a complaint or information under subparagraph (A),  
9 the Inspector General shall determine whether the com-  
10 plaint or information appears credible. Upon making such  
11 a determination, the Inspector General shall transmit to  
12 the Director a notice of that determination, together with  
13 the complaint or information.

14 (C) Upon receipt of a transmittal from the Inspector  
15 General under subparagraph (B), the Director shall, with-  
16 in seven calendar days of such receipt, forward such trans-  
17 mittal to the congressional intelligence committees, to-  
18 gether with any comments the Director considers appro-  
19 priate.

20 (D)(i) If the Inspector General does not find credible  
21 under subparagraph (B) a complaint or information sub-  
22 mitted under subparagraph (A), or does not transmit the  
23 complaint or information to the Director in accurate form  
24 under subparagraph (B), the employee (subject to clause  
25 (ii)) may submit the complaint or information to Congress

1 by contacting either or both of the congressional intel-  
2 ligence committees directly.

3 (ii) An employee may contact the intelligence commit-  
4 tees directly as described in clause (i) only if the  
5 employee—

6 (I) before making such a contact, furnishes to  
7 the Director, through the Inspector General, a state-  
8 ment of the employee's complaint or information and  
9 notice of the employee's intent to contact the con-  
10 gressional intelligence committees directly; and

11 (II) obtains and follows from the Director,  
12 through the Inspector General, direction on how to  
13 contact the intelligence committees in accordance  
14 with appropriate security practices.

15 (iii) A member or employee of one of the congres-  
16 sional intelligence committees who receives a complaint or  
17 information under clause (i) does so in that member or  
18 employee's official capacity as a member or employee of  
19 such committee.

20 (E) The Inspector General shall notify an employee  
21 who reports a complaint or information to the Inspector  
22 General under this paragraph of each action taken under  
23 this paragraph with respect to the complaint or informa-  
24 tion. Such notice shall be provided not later than three  
25 days after any such action is taken.

1 (F) An action taken by the Director or the Inspector  
2 General under this paragraph shall not be subject to judi-  
3 cial review.

4 (G) In this paragraph, the term “urgent concern”  
5 means any of the following:

6 (i) A serious or flagrant problem, abuse, viola-  
7 tion of law or Executive order, or deficiency relating  
8 to the funding, administration, or operations of an  
9 intelligence activity involving classified information,  
10 but does not include differences of opinions con-  
11 cerning public policy matters.

12 (ii) A false statement to Congress, or a willful  
13 withholding from Congress, on an issue of material  
14 fact relating to the funding, administration, or oper-  
15 ation of an intelligence activity.

16 (iii) An action, including a personnel action de-  
17 scribed in section 2302(a)(2)(A) of title 5, United  
18 States Code, constituting reprisal or threat of re-  
19 prisal prohibited under subsection (f)(3)(B) of this  
20 section in response to an employee’s reporting an ur-  
21 gent concern in accordance with this paragraph.

22 (H) In support of this paragraph, Congress makes  
23 the findings set forth in paragraphs (1) through (6) of  
24 section 701(b) of the Intelligence Community Whistle-

1 blower Protection Act of 1998 (title VII of Public Law  
2 105–272; 5 U.S.C. App. 8H note).

3 (6) In accordance with section 535 of title 28, United  
4 States Code, the Inspector General shall report to the At-  
5 torney General any information, allegation, or complaint  
6 received by the Inspector General relating to violations of  
7 Federal criminal law that involve a program or operation  
8 of the Authority, consistent with such guidelines as may  
9 be issued by the Attorney General pursuant to subsection  
10 (b)(2) of such section. A copy of each such report shall  
11 be furnished to the Director.

12 (i) SEPARATE BUDGET ACCOUNT.—The National In-  
13 telligence Director shall, in accordance with procedures to  
14 be issued by the Director in consultation with the congres-  
15 sional intelligence committees, include in the National In-  
16 telligence Program budget a separate account for the Of-  
17 fice of Inspector General of the National Intelligence Au-  
18 thority.

19 **SEC. 142. OMBUDSMAN OF THE NATIONAL INTELLIGENCE**  
20 **AUTHORITY.**

21 (a) OMBUDSMAN OF NATIONAL INTELLIGENCE AU-  
22 THORITY.—There is within the National Intelligence Au-  
23 thority an Ombudsman of the National Intelligence Au-  
24 thority who shall be appointed by the National Intelligence  
25 Director.



1 (b) SCOPE OF POSITION.—The Ombudsman of the  
2 National Intelligence Authority serves as an independent,  
3 informal, and confidential counselor for those who have  
4 complaints about politicization, biased reporting, or lack  
5 of objective analysis within the National Intelligence Au-  
6 thority.

7 (c) DUTIES.—The Ombudsman of the National Intel-  
8 ligence Authority shall—

9 (1) counsel, arbitrate, or offer recommendations  
10 on, and have the authority to initiate inquiries into,  
11 real or perceived problems of politicization, biased  
12 reporting, or lack of objective analysis within the  
13 National Intelligence Authority; and

14 (2) monitor the effectiveness of measures taken  
15 to deal with real or perceived politicization, biased  
16 reporting, or lack of objective analysis within the  
17 Authority.

18 (d) ACCESS TO INFORMATION.—In order to carry out  
19 the duties specified in subsection (c), the Ombudsman of  
20 the National Intelligence Authority shall, unless otherwise  
21 directed by the President, have access to all analytic prod-  
22 ucts, field reports, and raw intelligence of any element of  
23 the intelligence community, and to any reports or other  
24 material of an Inspector General, that might be pertinent  
25 to a matter under consideration by the Ombudsman.

1 (e) ANNUAL REPORTS.—The Ombudsman of the Na-  
2 tional Intelligence Authority shall submit to the National  
3 Intelligence Director and the congressional intelligence  
4 committees on an annual basis a report that includes—

5 (1) the assessment of the Ombudsman of the  
6 current level of politicization, biased reporting, or  
7 lack of objective analysis within the National Intel-  
8 ligence Authority;

9 (2) such recommendations for remedial meas-  
10 ures as the Ombudsman considers appropriate; and

11 (3) an assessment of the effectiveness of reme-  
12 dial measures previously taken within the Authority  
13 on matters addressed by the Ombudsman.

14 **SEC. 143. NATIONAL COUNTERTERRORISM CENTER.**

15 (a) NATIONAL COUNTERTERRORISM CENTER.—  
16 There is within the National Intelligence Authority a Na-  
17 tional Counterterrorism Center.

18 (b) DIRECTOR OF NATIONAL COUNTERTERRORISM  
19 CENTER.—(1) There is a Director of the National  
20 Counterterrorism Center, who shall be the head of the Na-  
21 tional Counterterrorism Center, and who shall be ap-  
22 pointed by the President, by and with the advice and con-  
23 sent of the Senate.

24 (2) Any individual nominated for appointment as the  
25 Director of the National Counterterrorism Center shall

1 have significant expertise in matters relating to the na-  
2 tional security of the United States and matters relating  
3 to terrorism that threatens the national security of the  
4 United States.

5 (3) The individual serving as the Director of the Na-  
6 tional Counterterrorism Center may not, while so serving,  
7 serve in any capacity in any other element of the intel-  
8 ligence community, except to the extent that the individual  
9 serving as Director of the National Counterterrorism Cen-  
10 ter is doing so in an acting capacity.

11 (c) SUPERVISION.—(1) The Director of the National  
12 Counterterrorism Center shall report to the National In-  
13 telligence Director on—

14 (A) the budget and programs of the National  
15 Counterterrorism Center; and

16 (B) the activities of the Directorate of Intel-  
17 ligence of the National Counterterrorism Center  
18 under subsection (g).

19 (2) The Director of the National Counterterrorism  
20 Center shall report to the President, through the National  
21 Security Council, on the planning and progress of joint  
22 counterterrorism operations.

23 (d) PRIMARY MISSIONS.—The primary missions of  
24 the National Counterterrorism Center shall be as follows:

1           (1) To develop and unify strategy for the civil-  
2           ian and military counterterrorism efforts of the  
3           United States Government.

4           (2) To integrate counterterrorism intelligence  
5           activities of the United States Government, both in-  
6           side and outside the United States.

7           (3) To conduct planning for counterterrorism  
8           operations that involve more than one department,  
9           agency, or element in the executive branch.

10          (4) To ensure that the collection of  
11          counterterrorism intelligence, and the conduct of  
12          counterterrorism operations, by the United States  
13          Government are informed by the analysis of all-  
14          source intelligence.

15          (e) DUTIES AND RESPONSIBILITIES OF DIRECTOR OF  
16          NATIONAL COUNTERTERRORISM CENTER.—Notwith-  
17          standing any other provision of law, at the direction of  
18          the President, the National Security Council, and the Na-  
19          tional Intelligence Director, the Director of the National  
20          Counterterrorism Center shall—

21                 (1) serve as the principal adviser to the Presi-  
22                 dent, through the National Security Council, on  
23                 joint operations relating to counterterrorism;

24                 (2) provide unified strategic direction for the ci-  
25                 vilian and military counterterrorism efforts of the

1 United States Government and for the effective inte-  
2 gration and deconfliction of counterterrorism intel-  
3 ligence and operations across agency boundaries,  
4 both inside and outside the United States;

5 (3) advise the President, through the National  
6 Security Council, on the extent to which the  
7 counterterrorism program recommendations and  
8 budget proposals of the departments, agencies, and  
9 elements of the United States Government conform  
10 to the priorities established by the President and the  
11 National Security Council;

12 (4) in accordance with subsection (f), concur in,  
13 or advise the President on, the selections of per-  
14 sonnel to head the operating entities of the United  
15 States Government with principal missions relating  
16 to counterterrorism; and

17 (5) perform such other duties as the National  
18 Intelligence Director may prescribe or are prescribed  
19 by law.

20 (f) ROLE OF DIRECTOR OF NATIONAL  
21 COUNTERTERRORISM CENTER IN CERTAIN APPOINT-  
22 MENTS.—(1) In the event of a vacancy in a position re-  
23 ferred to in paragraph (2), the head of the department  
24 or agency having jurisdiction over the position shall obtain  
25 the concurrence of the Director of the National

1 Counterterrorism Center before appointing an individual  
2 to fill the vacancy or recommending to the President an  
3 individual for nomination to fill the vacancy. If the Direc-  
4 tor does not concur in the recommendation, the head of  
5 the department or agency concerned may fill the vacancy  
6 or make the recommendation to the President (as the case  
7 may be) without the concurrence of the Director, but shall  
8 notify the President that the Director does not concur in  
9 the appointment or recommendation (as the case may be).

10 (2) Paragraph (1) applies to the following positions:

11 (A) The Director of the Central Intelligence  
12 Agency's Counterterrorist Center.

13 (B) The Assistant Director of the Federal Bu-  
14 reau of Investigation in charge of the  
15 Counterterrorism Division.

16 (C) The Coordinator for Counterterrorism of  
17 the Department of State.

18 (D) The head of such other operating entities  
19 of the United States Government having principal  
20 missions relating to counterterrorism as the Presi-  
21 dent may designate for purposes of this subsection.

22 (3) The President shall notify Congress of the des-  
23 ignation of an operating entity of the United States Gov-  
24 ernment under paragraph (2)\*D) not later than 30 days  
25 after the date of such designation.

1 (g) DIRECTORATE OF INTELLIGENCE.—(1) The Di-  
2 rector of the National Counterterrorism Center shall es-  
3 tablish and maintain within the National  
4 Counterterrorism Center a Directorate of Intelligence.

5 (2) The Directorate shall utilize the capabilities of the  
6 Terrorist Threat Integration Center (TTIC) transferred  
7 to the Directorate by section 323 and such other capabili-  
8 ties as the Director of the National Counterterrorism Cen-  
9 ter considers appropriate.

10 (3) The Directorate shall have primary responsibility  
11 within the United States Government for analysis of ter-  
12 rorism and terrorist organizations from all sources of in-  
13 telligence, whether collected inside or outside the United  
14 States.

15 (4) The Directorate shall—

16 (A) be the principal repository within the  
17 United States Government for all-source information  
18 on suspected terrorists, their organizations, and  
19 their capabilities;

20 (B) propose intelligence collection requirements  
21 for action by elements of the intelligence community  
22 inside and outside the United States;

23 (C) have primary responsibility within the  
24 United States Government for net assessments and  
25 warnings about terrorist threats, which assessments

1 and warnings shall be based on a comparison of ter-  
2 rorist intentions and capabilities with assessed na-  
3 tional vulnerabilities and countermeasures; and

4 (D) perform such other duties and functions as  
5 the Director of the National Counterterrorism Cen-  
6 ter may prescribe.

7 (h) DIRECTORATE OF OPERATIONS.—(1) The Direc-  
8 tor of the National Counterterrorism Center shall estab-  
9 lish and maintain within the National Counterterrorism  
10 Center a Directorate of Operations.

11 (2)(A) The Directorate shall have primary responsi-  
12 bility within the United States Government for providing  
13 guidance and plans, including strategic plans, for joint  
14 counterterrorism operations conducted by the United  
15 States Government.

16 (B) For purposes of subparagraph (A), joint  
17 counterterrorism operations are counterterrorism oper-  
18 ations that—

19 (i) involve, or are likely to involve, more than  
20 one executive agency of the United States Govern-  
21 ment, including the Armed Forces of the United  
22 States; or

23 (ii) are designated as joint operations by the  
24 Director of the National Counterterrorism Center.

25 (3) The Directorate shall—



1           (A) provide guidance, and develop strategy and  
2 plans for operations, to counter terrorist activities  
3 based on policy objectives and priorities established  
4 by the National Security Council;

5           (B) develop plans under subparagraph (A) uti-  
6 lizing input from personnel in other departments,  
7 agencies, and elements of the United States Govern-  
8 ment who have expertise in the priorities, functions,  
9 assets, programs, capabilities, and operations of  
10 such departments, agencies, and elements with re-  
11 spect to counterterrorism;

12           (C) assign responsibilities for counterterrorism  
13 operations to the departments, agencies, and ele-  
14 ments of the United States Government (including  
15 the Department of Defense and the Armed Forces,  
16 the Central Intelligence Agency, the Federal Bureau  
17 of Investigation, the Department of Homeland Secu-  
18 rity, and other departments, agencies, and elements  
19 of the United States Government), consistent with  
20 the authorities of such departments, agencies, and  
21 elements;

22           (D) monitor the implementation of operations  
23 assigned under subparagraph (C) and update plans  
24 for such operations as necessary;

1           (E) report to the President and the National  
2 Intelligence Director on the compliance of the de-  
3 partments, agencies, and elements of the United  
4 States with the plans developed under subparagraph  
5 (A); and

6           (F) perform such other duties and functions as  
7 the Director of the National Counterterrorism Cen-  
8 ter may prescribe.

9           (4) The Directorate may not direct the execution of  
10 operations assigned under paragraph (3).

11          (i) STAFF.—(1) The National Intelligence Director  
12 may appoint deputy directors of the National  
13 Counterterrorism Center to oversee such portions of the  
14 operations of the Center as the National Intelligence Di-  
15 rector considers appropriate.

16          (2) To assist the Director of the National  
17 Counterterrorism Center in fulfilling the duties and re-  
18 sponsibilities of the Director of the National  
19 Counterterrorism Center under this section, the National  
20 Intelligence Director shall employ in the National  
21 Counterterrorism Center a professional staff having an ex-  
22 pertise in matters relating to such duties and responsibil-  
23 ities.

24          (3) In providing for a professional staff for the Na-  
25 tional Counterterrorism Center under paragraph (2), the

1 National Intelligence Director may establish as positions  
2 in the excepted service such positions in the Center as the  
3 National Intelligence Director considers appropriate.

4 (4) The National Intelligence Director shall ensure  
5 that the analytical staff of the National Counterterrorism  
6 Center is comprised primarily of experts from elements in  
7 the intelligence community and from such other personnel  
8 in the United States Government as the National Intel-  
9 ligence Director considers appropriate.

10 (5)(A) In order to meet the requirements in para-  
11 graph (4), the National Intelligence Director shall, from  
12 time to time—

13 (i) specify the transfers, assignments, and de-  
14 tails of personnel funded within the National Intel-  
15 ligence Program to the National Counterterrorism  
16 Center from any other element of the intelligence  
17 community that the National Intelligence Director  
18 considers appropriate; and

19 (ii) in the case of personnel from a department,  
20 agency, or element of the United States Government  
21 and not funded within the National Intelligence Pro-  
22 gram, request the transfer, assignment, or detail of  
23 such personnel from the department, agency, or  
24 other element concerned.

1 (B)(i) The head of an element of the intelligence com-  
2 munity shall promptly effect any transfer, assignment, or  
3 detail of personnel specified by the National Intelligence  
4 Director under subparagraph (A)(i).

5 (ii) The head of a department, agency, or element of  
6 the United States Government receiving a request for  
7 transfer, assignment, or detail of personnel under sub-  
8 paragraph (A)(ii) shall, to the extent practicable, approve  
9 the request.

10 (6) Personnel employed in or assigned or detailed to  
11 the National Counterterrorism Center under this sub-  
12 section shall be under the authority, direction, and control  
13 of the Director of the National Counterterrorism Center  
14 on all matters for which the Center has been assigned re-  
15 sponsibility and for all matters related to the accomplish-  
16 ment of the missions of the Center.

17 (7) Performance evaluations of personnel assigned or  
18 detailed to the National Counterterrorism Center under  
19 this subsection shall be undertaken by the supervisors of  
20 such personnel at the Center.

21 (8) The supervisors of the staff of the National  
22 Counterterrorism Center may, with the approval of the  
23 National Intelligence Director, reward the staff of the  
24 Center for meritorious performance by the provision of

1 such performance awards as the National Intelligence Di-  
2 rector shall prescribe.

3 (9) The National Intelligence Director may delegate  
4 to the Director of the National Counterterrorism Center  
5 any responsibility, power, or authority of the National In-  
6 telligence Director under paragraphs (1) through (8).

7 (10) The National Intelligence Director shall ensure  
8 that the staff of the National Counterterrorism Center has  
9 access to all databases maintained by the elements of the  
10 intelligence community that are relevant to the duties of  
11 the Center.

12 (j) SUPPORT AND COOPERATION OF OTHER AGEN-  
13 CIES.—(1) The elements of the intelligence community  
14 and the other departments, agencies, and elements of the  
15 United States Government shall support, assist, and co-  
16 operate with the National Counterterrorism Center in car-  
17 rying out its missions under this section.

18 (2) The support, assistance, and cooperation of a de-  
19 partment, agency, or element of the United States Govern-  
20 ment under this subsection shall include, but not be lim-  
21 ited to—

22 (A) the implementation of plans for operations,  
23 whether foreign or domestic, that are developed by  
24 the National Counterterrorism Center in a manner  
25 consistent with the laws and regulations of the

1 United States and consistent with the limitation in  
2 subsection (h)(4);

3 (B) cooperative work with the Director of the  
4 National Counterterrorism Center to ensure that on-  
5 going operations of such department, agency, or ele-  
6 ment do not conflict with joint operations planned  
7 by the Center;

8 (C) reports, upon request, to the Director of the  
9 National Counterterrorism Center on the progress of  
10 such department, agency, or element in imple-  
11 menting responsibilities assigned to such depart-  
12 ment, agency, or element through joint operations  
13 plans; and

14 (D) the provision to the analysts of the Na-  
15 tional Counterterrorism Center electronic access in  
16 real time to information and intelligence collected by  
17 such department, agency, or element that is relevant  
18 to the missions of the Center.

19 (3)(A) In the event of a disagreement between the  
20 National Counterterrorism Center and the head of a de-  
21 partment, agency, or element of the United States Govern-  
22 ment on a plan developed or responsibility assigned by the  
23 Center under this subsection, the Director of the National  
24 Counterterrorism Center may either accede to the head

1 of the department, agency, or element concerned or notify  
2 the National Security Council of the disagreement.

3 (B) The President shall resolve each disagreement of  
4 which the Council is notified under subparagraph (A).

5 **SEC. 144. NATIONAL INTELLIGENCE CENTERS.**

6 (a) NATIONAL INTELLIGENCE CENTERS.—(1) The  
7 National Intelligence Director may establish within the  
8 National Intelligence Authority one or more centers (to  
9 be known as “national intelligence centers”) to address  
10 intelligence priorities established by the National Security  
11 Council.

12 (2) Each national intelligence center established  
13 under this section shall be assigned an area of intelligence  
14 responsibility.

15 (3) National intelligence centers shall be established  
16 at the direction of the President, as prescribed by law,  
17 or upon the initiative of the National Intelligence Director.

18 (b) ESTABLISHMENT OF CENTERS.—(1) In estab-  
19 lishing a national intelligence center, the National Intel-  
20 ligence Director shall assign lead responsibility for admin-  
21 istrative support for such center to an element of the intel-  
22 ligence community selected by the Director for that pur-  
23 pose.

24 (2) The Director shall determine the structure and  
25 size of each national intelligence center.

1           (3) The Director shall notify Congress of the estab-  
2 lishment of each national intelligence center before the  
3 date of the establishment of such center.

4           (c) DIRECTORS OF CENTERS.—(1) Each national in-  
5 telligence center shall have as its head a Director who  
6 shall be appointed by the National Intelligence Director  
7 for that purpose.

8           (2) The Director of a national intelligence center  
9 shall serve as the principal adviser to the National Intel-  
10 ligence Director on intelligence matters with respect to the  
11 area of intelligence responsibility assigned to the center.

12          (3) In carrying out duties under paragraph (2), the  
13 Director of a national intelligence center shall—

14               (A) manage the operations of the center;

15               (B) coordinate the provision of administration  
16 and support by the element of the intelligence com-  
17 munity with lead responsibility for the center under  
18 subsection (b)(1);

19               (C) submit budget and personnel requests for  
20 the center to the National Intelligence Director;

21               (D) seek such assistance from other depart-  
22 ments, agencies, and elements of the United States  
23 Government as is needed to fulfill the mission of the  
24 center; and



1           (E) advise the National Intelligence Director of  
2           the information technology, personnel, and other re-  
3           quirements of the center for the performance of its  
4           mission.

5           (4) The National Intelligence Director shall ensure  
6           that the Director of a national intelligence center has suf-  
7           ficient authority, direction, and control to effectively ac-  
8           complish the mission of the center.

9           (d) MISSION OF CENTERS.—Pursuant to the direc-  
10          tion of the National Intelligence Director, each national  
11          intelligence center shall, in the area of intelligence respon-  
12          sibility assigned to the center by the Director pursuant  
13          to intelligence priorities established by the National Secu-  
14          rity Council—

15               (1) have primary responsibility for providing  
16               all-source analysis of intelligence based upon foreign  
17               intelligence gathered both abroad and domestically;

18               (2) have primary responsibility for identifying  
19               and proposing to the National Intelligence Director  
20               intelligence collection and analysis requirements;

21               (3) have primary responsibility for net assess-  
22               ments and warnings;

23               (4) ensure that appropriate officials of the  
24               United States Government and other appropriate of-

1 officials have access to a variety of intelligence assess-  
2 ments and analytical views; and

3 (5) perform such other duties as the National  
4 Intelligence Director shall specify.

5 (e) INFORMATION SHARING.—(1) The National Intel-  
6 ligence Director shall ensure that the Directors of the na-  
7 tional intelligence centers and the other elements of the  
8 intelligence community undertake appropriate sharing of  
9 intelligence analysis and plans for operations in order to  
10 facilitate the activities of the centers.

11 (2) In order to facilitate information sharing under  
12 paragraph (1), the Directors of the national intelligence  
13 centers shall—

14 (A) report directly to the National Intelligence  
15 Director regarding their activities under this section;  
16 and

17 (B) coordinate with the Principal Deputy Na-  
18 tional Intelligence Director regarding such activities.

19 (f) STAFF.—(1) In providing for a professional staff  
20 for a national intelligence center, the National Intelligence  
21 Director may establish as positions in the excepted service  
22 such positions in the center as the National Intelligence  
23 Director considers appropriate.

24 (2)(A) The National Intelligence Director shall, from  
25 time to time—

1           (i) specify the transfers, assignments, and de-  
2           tails of personnel funded within the National Intel-  
3           ligence Program to a national intelligence center  
4           from any other element of the intelligence commu-  
5           nity that the National Intelligence Director considers  
6           appropriate; and

7           (ii) in the case of personnel from a department,  
8           agency, or element of the United States Government  
9           not funded within the National Intelligence Pro-  
10          gram, request the transfer, assignment, or detail of  
11          such personnel from the department, agency, or  
12          other element concerned.

13          (B)(i) The head of an element of the intelligence com-  
14          munity shall promptly effect any transfer, assignment, or  
15          detail of personnel specified by the National Intelligence  
16          Director under subparagraph (A)(i).

17          (ii) The head of a department, agency, or element of  
18          the United States Government receiving a request for  
19          transfer, assignment, or detail of personnel under sub-  
20          paragraph (A)(ii) shall, to the extent practicable, approve  
21          the request.

22          (3) Personnel employed in or assigned or detailed to  
23          a national intelligence center under this subsection shall  
24          be under the authority, direction, and control of the Direc-  
25          tor of the center on all matters for which the center has

1 been assigned responsibility and for all matters related to  
2 the accomplishment of the mission of the center.

3 (4) Performance evaluations of personnel assigned or  
4 detailed to a national intelligence center under this sub-  
5 section shall be undertaken by the supervisors of such per-  
6 sonnel at the center.

7 (5) The supervisors of the staff of a national center  
8 may, with the approval of the National Intelligence Direc-  
9 tor, reward the staff of the center for meritorious perform-  
10 ance by the provision of such performance awards as the  
11 National Intelligence Director shall prescribe.

12 (6) The National Intelligence Director may delegate  
13 to the Director of a national intelligence center any re-  
14 sponsibility, power, or authority of the National Intel-  
15 ligence Director under paragraphs (1) through (6).

16 (7) The Director of a national intelligence center may  
17 recommend to the National Intelligence Director the reas-  
18 signment to the home element concerned of any personnel  
19 previously assigned or detailed to the center from another  
20 element of the intelligence community.

21 (g) TERMINATION.—(1) The National Intelligence  
22 Director may terminate a national intelligence center if  
23 the National Intelligence Director determines that the cen-  
24 ter is no longer required to meet an intelligence priority  
25 established by the National Security Council.

1 (2) The National Intelligence Director shall notify  
2 Congress of any determination made under paragraph (1)  
3 before carrying out such determination.

4 **Subtitle E—Education and Train-**  
5 **ing of Intelligence Community**  
6 **Personnel**

7 **SEC. 151. FRAMEWORK FOR CROSS-DISCIPLINARY EDU-**  
8 **CATION AND TRAINING.**

9 The National Intelligence Director shall establish an  
10 integrated framework that brings together the educational  
11 components of the intelligence community in order to pro-  
12 mote a more effective and productive intelligence commu-  
13 nity through cross-disciplinary education and joint train-  
14 ing.

15 **SEC. 152. INTELLIGENCE COMMUNITY SCHOLARSHIP PRO-**  
16 **GRAM.**

17 (a) DEFINITIONS.—In this section:

18 (1) AGENCY.—The term “agency” means each  
19 element of the intelligence community as determined  
20 by the National Intelligence Director.

21 (2) INSTITUTION OF HIGHER EDUCATION.—The  
22 term “institution of higher education” has the  
23 meaning given that term under section 101 of the  
24 Higher Education Act of 1965 (20 U.S.C. 1001).

1           (3) PROGRAM.—The term “Program” means  
2 the Intelligence Community Scholarship Program es-  
3 tablished under subsection (b).

4           (b) ESTABLISHMENT.—

5           (1) IN GENERAL.—The National Intelligence  
6 Director, in consultation with the head of each agen-  
7 cy, shall establish a scholarship program (to be  
8 known as the “Intelligence Community Scholarship  
9 Program”) to award scholarships to individuals that  
10 is designed to recruit and prepare students for civil-  
11 ian careers in the intelligence community to meet  
12 the critical needs of the intelligence community  
13 agencies.

14           (2) SELECTION OF RECIPIENTS.—

15           (A) MERIT AND AGENCY NEEDS.—Individ-  
16 uals shall be selected to receive scholarships  
17 under this section through a competitive proc-  
18 ess primarily on the basis of academic merit  
19 and the needs of the agency.

20           (B) DEMONSTRATED COMMITMENT.—Indi-  
21 viduals selected under this section shall have a  
22 demonstrated commitment to the field of study  
23 for which the scholarship is awarded.

24           (3) CONTRACTUAL AGREEMENTS.—To carry  
25 out the Program the head of each agency shall enter

1 into contractual agreements with individuals selected  
2 under paragraph (2) under which the individuals  
3 agree to serve as full-time employees of the agency,  
4 for the period described in subsection (h)(1), in posi-  
5 tions needed by the agency and for which the indi-  
6 viduals are qualified, in exchange for receiving a  
7 scholarship.

8 (c) ELIGIBILITY.—In order to be eligible to partici-  
9 pate in the Program, an individual shall—

10 (1) be enrolled or accepted for enrollment as a  
11 full-time student at an institution of higher edu-  
12 cation and be pursuing or intend to pursue under-  
13 graduate or graduate education in an academic field  
14 or discipline described in the list made available  
15 under subsection (e);

16 (2) be a United States citizen; and

17 (3) at the time of the initial scholarship award,  
18 not be an employee (as defined under section 2105  
19 of title 5, United States Code).

20 (d) APPLICATION.— An individual seeking a scholar-  
21 ship under this section shall submit an application to the  
22 National Intelligence Director at such time, in such man-  
23 ner, and containing such information, agreements, or as-  
24 surances as the Director may require.

1 (e) PROGRAMS AND FIELDS OF STUDY.—The Na-  
2 tional Intelligence Director shall—

3 (1) make publicly available a list of academic  
4 programs and fields of study for which scholarships  
5 under the Program may be used; and

6 (2) update the list as necessary.

7 (f) SCHOLARSHIPS.—

8 (1) IN GENERAL.—The National Intelligence  
9 Director may provide a scholarship under the Pro-  
10 gram for an academic year if the individual applying  
11 for the scholarship has submitted to the Director, as  
12 part of the application required under subsection  
13 (d), a proposed academic program leading to a de-  
14 gree in a program or field of study on the list made  
15 available under subsection (e).

16 (2) LIMITATION ON YEARS.—An individual may  
17 not receive a scholarship under this section for more  
18 than 4 academic years, unless the National Intel-  
19 ligence Director grants a waiver.

20 (3) STUDENT RESPONSIBILITIES.—Scholarship  
21 recipients shall maintain satisfactory academic  
22 progress.

23 (4) AMOUNT.—The dollar amount of a scholar-  
24 ship under this section for an academic year shall be  
25 determined under regulations issued by the National



1 Intelligence Director, but shall in no case exceed the  
2 cost of tuition, fees, and other authorized expenses  
3 as established by the Director.

4 (5) USE OF SCHOLARSHIPS.—A scholarship  
5 provided under this section may be expended for tui-  
6 tion, fees, and other authorized expenses as estab-  
7 lished by the National Intelligence Director by regu-  
8 lation.

9 (6) PAYMENT TO INSTITUTION OF HIGHER  
10 EDUCATION.—The National Intelligence Director  
11 may enter into a contractual agreement with an in-  
12 stitution of higher education under which the  
13 amounts provided for a scholarship under this sec-  
14 tion for tuition, fees, and other authorized expenses  
15 are paid directly to the institution with respect to  
16 which the scholarship is provided.

17 (g) SPECIAL CONSIDERATION FOR CURRENT EM-  
18 PLOYEES.—

19 (1) SET ASIDE OF SCHOLARSHIPS.—Notwith-  
20 standing paragraphs (1) and (3) of subsection (c),  
21 10 percent of the scholarships awarded under this  
22 section shall be set aside for individuals who are em-  
23 ployees of agencies on the date of enactment of this  
24 section to enhance the education of such employees  
25 in areas of critical needs of agencies.

1           (2) FULL- OR PART-TIME EDUCATION.—Em-  
2           ployees who are awarded scholarships under para-  
3           graph (1) shall be permitted to pursue under-  
4           graduate or graduate education under the scholar-  
5           ship on a full-time or part-time basis.

6           (h) EMPLOYEE SERVICE.—

7           (1) PERIOD OF SERVICE.—Except as provided  
8           in subsection (j)(2), the period of service for which  
9           an individual shall be obligated to serve as an em-  
10          ployee of the agency is 24 months for each academic  
11          year for which a scholarship under this section is  
12          provided. Under no circumstances shall the total pe-  
13          riod of obligated service be more than 8 years.

14          (2) BEGINNING OF SERVICE.—

15           (A) IN GENERAL.—Except as provided in  
16           subparagraph (B), obligated service under para-  
17           graph (1) shall begin not later than 60 days  
18           after the individual obtains the educational de-  
19           gree for which the scholarship was provided.

20           (B) DEFERRAL.—In accordance with regu-  
21           lations established by the National Intelligence  
22           Director, the Director or designee may defer  
23           the obligation of an individual to provide a pe-  
24           riod of service under paragraph (1) if the Di-

1           rector or designee determines that such a defer-  
2           ral is appropriate.

3           (i) REPAYMENT.—

4           (1) IN GENERAL.—Scholarship recipients who  
5           fail to maintain a high level of academic standing,  
6           as defined by the National Intelligence Director, who  
7           are dismissed from their educational institutions for  
8           disciplinary reasons, or who voluntarily terminate  
9           academic training before graduation from the edu-  
10          cational program for which the scholarship was  
11          awarded, shall be in breach of their contractual  
12          agreement and, in lieu of any service obligation aris-  
13          ing under such agreement, shall be liable to the  
14          United States for repayment within 1 year after the  
15          date of default of all scholarship funds paid to them  
16          and to the institution of higher education on their  
17          behalf under the agreement, except as provided in  
18          subsection (j)(2). The repayment period may be ex-  
19          tended by the Director when determined to be nec-  
20          essary, as established by regulation.

21          (2) LIABILITY.—Scholarship recipients who, for  
22          any reason, fail to begin or complete their service  
23          obligation after completion of academic training, or  
24          fail to comply with the terms and conditions of  
25          deferment established by the National Intelligence

1 Director under subsection (h)(2)(B), shall be in  
2 breach of their contractual agreement. When recipi-  
3 ents breach their agreements for the reasons stated  
4 in the preceding sentence, the recipient shall be lia-  
5 ble to the United States for an amount equal to—

6 (A) the total amount of scholarships re-  
7 ceived by such individual under this section;  
8 and

9 (B) the interest on the amounts of such  
10 awards which would be payable if at the time  
11 the awards were received they were loans bear-  
12 ing interest at the maximum legal prevailing  
13 rate, as determined by the Treasurer of the  
14 United States, multiplied by 3.

15 (j) CANCELLATION, WAIVER, OR SUSPENSION OF OB-  
16 LIGATION.—

17 (1) CANCELLATION.—Any obligation of an indi-  
18 vidual incurred under the Program (or a contractual  
19 agreement thereunder) for service or payment shall  
20 be canceled upon the death of the individual.

21 (2) WAIVER OR SUSPENSION.—The National  
22 Intelligence Director shall prescribe regulations to  
23 provide for the partial or total waiver or suspension  
24 of any obligation of service or payment incurred by  
25 an individual under the Program (or a contractual

1 agreement thereunder) whenever compliance by the  
2 individual is impossible or would involve extreme  
3 hardship to the individual, or if enforcement of such  
4 obligation with respect to the individual would be  
5 contrary to the best interests of the Government.

6 (k) REGULATIONS.—The National Intelligence Direc-  
7 tor shall prescribe regulations necessary to carry out this  
8 section.

## 9 **Subtitle F—Additional Authorities** 10 **of National Intelligence Authority**

### 11 **SEC. 161. USE OF APPROPRIATED FUNDS.**

12 (a) DISPOSAL OF PROPERTY.—(1) If specifically au-  
13 thorized to dispose of real property of the National Intel-  
14 ligence Authority under any law enacted after the date of  
15 the enactment of this Act, the National Intelligence Direc-  
16 tor shall, subject to paragraph (2), exercise such authority  
17 in strict compliance with subchapter IV of chapter 5 of  
18 title 40, United States Code.

19 (2) The Director shall deposit the proceeds of any  
20 disposal of property of the National Intelligence Authority  
21 into the miscellaneous receipts of the Treasury in accord-  
22 ance with section 3302(b) of title 31, United States Code.

23 (b) GIFTS.—Gifts or donations of services or property  
24 of or for the National Intelligence Authority may not be  
25 accepted, used, or disposed of unless specifically permitted

1 in advance in an appropriations Act and only under the  
2 conditions and for the purposes specified in such appro-  
3 priations Act.

4 **SEC. 162. ACQUISITION AND FISCAL AUTHORITIES.**

5 (a) ACQUISITIONS OF MAJOR SYSTEMS.—(1) For  
6 each intelligence program for the acquisition of a major  
7 system, the National Intelligence Director shall—

8 (A) require the development and implementa-  
9 tion of a program management plan that includes  
10 cost, schedule, and performance goals and program  
11 milestone criteria;

12 (B) subject to paragraph (4), serve as the ex-  
13 clusive milestone decision authority; and

14 (C) periodically—

15 (i) review and assess the progress made to-  
16 ward the achievement of the goals and mile-  
17 stones established in such plan; and

18 (ii) submit to Congress a report on the re-  
19 sults of such review and assessment.

20 (2) The National Intelligence Director shall prescribe  
21 guidance for the development and implementation of pro-  
22 gram management plans under this subsection. In pre-  
23 scribing such guidance, the Director shall review Depart-  
24 ment of Defense guidance on program management plans  
25 for Department of Defense programs for the acquisition

1 of major systems and, to the extent feasible, incorporate  
2 the principles of the Department of Defense guidance into  
3 the Director's guidance under this subsection.

4 (3) Nothing in this subsection may be construed to  
5 limit the authority of the National Intelligence Director  
6 to delegate to any other official any authority to perform  
7 the responsibilities of the Director under this subsection.

8 (4)(A) The authority conferred by paragraph (1)(B)  
9 shall not apply to Department of Defense programs until  
10 the National Intelligence Director, in consultation with the  
11 Secretary of Defense, determines that the National Intel-  
12 ligence Authority has the personnel and capability to fully  
13 and effectively carry out such authority.

14 (B) The National Intelligence Director may assign  
15 any authority under this subsection to the Secretary of  
16 Defense. The assignment of such authority shall be made  
17 pursuant to a memorandum of understanding between the  
18 Director and the Secretary.

19 (5) In this subsection:

20 (A) The term "intelligence program", with re-  
21 spect to the acquisition of a major system, means a  
22 program that—

23 (i) is carried out to acquire such major  
24 system for an element of the intelligence com-  
25 munity; and

1           (ii) is funded in whole out of amounts  
2           available for the National Intelligence Program.

3           (B) The term “major system” has the meaning  
4           given such term in section 4(9) of the Federal Prop-  
5           erty and Administrative Services Act of 1949 (41  
6           U.S.C. 403(9)).

7           (b) AVAILABILITY OF FUNDS.—Notwithstanding any  
8           other provision of law (other than the provisions of this  
9           Act), sums appropriated or otherwise made available to  
10          the National Intelligence Authority may be expended for  
11          purposes necessary to carry out its functions, including  
12          any function performed by the National Intelligence Au-  
13          thority that is described in section 8(a) of the Central In-  
14          telligence Agency Act of 1949 (50 U.S.C. 403j(a)).

15          (c) RELATIONSHIP OF DIRECTOR’S AUTHORITY TO  
16          OTHER LAWS ON ACQUISITION AND MANAGEMENT OF  
17          PROPERTY AND SERVICES.—Section 113(e) of title 40,  
18          United States Code, is amended—

19               (A) by striking “or” at the end of paragraph  
20               (18);

21               (B) by striking the period at the end of para-  
22               graph (19) and inserting “; or”; and

23               (C) by adding at the end the following new  
24               paragraph:

25               “(20) the National Intelligence Director.”.



1 (d) NATIONAL INTELLIGENCE DIRECTOR REPORT ON  
2 ENHANCEMENT OF NSA AND NGLIA ACQUISITION AU-  
3 THORITIES.—Not later than one year after the date of the  
4 enactment of this Act, the National Intelligence Director  
5 shall—

6 (1) review—

7 (A) the acquisition authority of the Direc-  
8 tor of the National Security Agency; and

9 (B) the acquisition authority of the Direc-  
10 tor of the National Geospatial-Intelligence  
11 Agency; and

12 (2) submit to the Committee on Governmental  
13 Affairs of the Senate and the Committee on Govern-  
14 ment Reform of the House of Representatives a re-  
15 port setting forth any recommended enhancements  
16 of the acquisition authorities of the Director of the  
17 National Security Agency and the Director of the  
18 National Geospatial-Intelligence Agency that the Na-  
19 tional Intelligence Director considers necessary.

20 (e) COMPTROLLER GENERAL REPORT ON ACQUI-  
21 TION POLICIES AND PROCEDURES.—Not later than two  
22 years after the date of the enactment of this Act, the  
23 Comptroller General of the United States shall submit to  
24 Congress a report on the extent to which the policies and  
25 procedures adopted for managing the acquisition of major

1 systems for national intelligence purposes, as identified by  
2 the National Intelligence Director, are likely to result in  
3 successful cost, schedule, and performance outcomes.

4 **SEC. 163. PERSONNEL MATTERS.**

5 (a) IN GENERAL.—In addition to the authorities pro-  
6 vided in section 114, the National Intelligence Director  
7 may exercise with respect to the personnel of the National  
8 Intelligence Authority any authority of the Director of the  
9 Central Intelligence Agency with respect to the personnel  
10 of the Central Intelligence Agency under the Central Intel-  
11 ligence Agency Act of 1949 (50 U.S.C. 403a et seq.), and  
12 other applicable provisions of law, as of the date of the  
13 enactment of this Act to the same extent, and subject to  
14 the same conditions and limitations, that the Director of  
15 the Central Intelligence Agency may exercise such author-  
16 ity with respect to personnel of the Central Intelligence  
17 Agency.

18 (b) RIGHTS AND PROTECTIONS OF EMPLOYEES AND  
19 APPLICANTS.—Employees and applicants for employment  
20 of the National Intelligence Authority shall have the same  
21 rights and protections under the Authority as employees  
22 of the Central Intelligence Agency have under the Central  
23 Intelligence Agency Act of 1949, and other applicable pro-  
24 visions of law, as of the date of the enactment of this Act.

1 **SEC. 164. ETHICS MATTERS.**

2 (a) POLITICAL SERVICE OF PERSONNEL.—Section  
3 7323(b)(2)(B)(i) of title 5, United States Code, is  
4 amended—

5 (1) in subclause (XII), by striking “or” at the  
6 end; and

7 (2) by inserting after subclause (XIII) the fol-  
8 lowing new subclause:

9 “(XIV) the National Intelligence Author-  
10 ity; or”.

11 (b) DELETION OF INFORMATION ABOUT FOREIGN  
12 GIFTS.—Section 7342(f)(4) of title 5, United States Code,  
13 is amended—

14 (1) by inserting “(A)” after “(4)”;

15 (2) in subparagraph (A), as so designated, by  
16 striking “the Director of Central Intelligence” and  
17 inserting “the Director of the Central Intelligence  
18 Agency”; and

19 (3) by adding at the end the following new sub-  
20 paragraph:

21 “(B) In transmitting such listings for the National  
22 Intelligence Authority, the National Intelligence Director  
23 may delete the information described in subparagraphs  
24 (A) and (C) of paragraphs (2) and (3) if the Director cer-  
25 tifies in writing to the Secretary of State that the publica-

1 tion of such information could adversely affect United  
2 States intelligence sources.”.

3 (c) EXEMPTION FROM FINANCIAL DISCLOSURES.—  
4 Section 105(a)(1) of the Ethics in Government Act (5  
5 U.S.C. App.) is amended by inserting “the National Intel-  
6 ligence Authority,” before “the Central Intelligence Agen-  
7 cy”.

8 **TITLE II—OTHER IMPROVE-**  
9 **MENTS OF INTELLIGENCE AC-**  
10 **TIVITIES**

11 **Subtitle A—Improvements of**  
12 **Intelligence Activities**

13 **SEC. 201. AVAILABILITY TO PUBLIC OF CERTAIN INTEL-**  
14 **LIGENCE FUNDING INFORMATION.**

15 (a) AMOUNTS REQUESTED EACH FISCAL YEAR.—  
16 The President shall disclose to the public for each fiscal  
17 year after fiscal year 2005 the aggregate amount of appro-  
18 priations requested in the budget of the President for such  
19 fiscal year for the National Intelligence Program.

20 (b) AMOUNTS AUTHORIZED AND APPROPRIATED  
21 EACH FISCAL YEAR.—Congress shall disclose to the pub-  
22 lic for each fiscal year after fiscal year 2005 the aggregate  
23 amount of funds authorized to be appropriated, and the  
24 aggregate amount of funds appropriated, by Congress for  
25 such fiscal year for the National Intelligence Program.

1           (c) STUDY OF DISCLOSURE OF ADDITIONAL INFOR-  
2 MATION.—(1) The National Intelligence Director shall  
3 conduct a study to assess the advisability of disclosing to  
4 the public amounts as follows:

5           (A) The aggregate amount of appropriations re-  
6 quested in the budget of the President for each fis-  
7 cal year for each element of the intelligence commu-  
8 nity.

9           (B) The aggregate amount of funds authorized  
10 to be appropriated, and the aggregate amount of  
11 funds appropriated, by Congress for each fiscal year  
12 for each element of the intelligence community.

13          (2) The study under paragraph (1) shall—

14           (A) address whether or not the disclosure to the  
15 public of the information referred to in that para-  
16 graph would harm the national security of the  
17 United States; and

18           (B) take into specific account concerns relating  
19 to the disclosure of such information for each ele-  
20 ment of the intelligence community.

21          (3) Not later than 180 days after the effective date  
22 of this section, the Director shall submit to Congress a  
23 report on the study under paragraph (1).

1 **SEC. 202. MERGER OF HOMELAND SECURITY COUNCIL**  
2 **INTO NATIONAL SECURITY COUNCIL.**

3 (a) MERGER OF HOMELAND SECURITY COUNCIL  
4 INTO NATIONAL SECURITY COUNCIL.—Section 101 of the  
5 National Security Act of 1947 (50 U.S.C. 402) is  
6 amended—

7 (1) in the fourth undesignated paragraph of  
8 subsection (a), by striking clauses (5) and (6) and  
9 inserting the following new clauses:

10 “(5) the Attorney General;

11 “(6) the Secretary of Homeland Security;”; and

12 (2) in subsection (b)—

13 (A) in paragraph (1), by striking “and” at  
14 the end;

15 (B) in paragraph (2), by striking the pe-  
16 riod at the end and inserting a semicolon; and

17 (C) by adding at the end the following new  
18 paragraphs:

19 “(3) assess the objectives, commitments, and  
20 risks of the United States in the interests of home-  
21 land security and make recommendations to the  
22 President based on such assessments;

23 “(4) oversee and review the homeland security  
24 policies of the Federal Government and make rec-  
25 ommendations to the President based on such over-  
26 sight and review; and

1           “(5) perform such other functions as the Presi-  
2           dent may direct.”.

3           (c) **REPEAL OF SUPERSEDED AUTHORITY.**—(1) Title  
4 IX of the Homeland Security Act of 2002 (6 U.S.C. 491  
5 et seq.) is repealed.

6           (2) The table of contents for that Act is amended  
7 by striking the items relating to title IX.

8 **SEC. 203. JOINT INTELLIGENCE COMMUNITY COUNCIL.**

9           Title I of the National Security Act of 1947 (50  
10 U.S.C. 401 et seq.) is amended by inserting after section  
11 101 the following new section:

12           “**JOINT INTELLIGENCE COMMUNITY COUNCIL**

13           “**SEC. 101A. (a) JOINT INTELLIGENCE COMMUNITY**  
14 **COUNCIL.**—There is a Joint Intelligence Community  
15 Council.

16           “(b) **MEMBERSHIP.**—The Joint Intelligence Commu-  
17 nity Council shall consist of the following:

18           “(1) The National Intelligence Director, who  
19 shall chair the Council.

20           “(2) The Secretary of State.

21           “(3) The Secretary of the Treasury.

22           “(4) The Secretary of Defense.

23           “(5) The Attorney General.

24           “(6) The Secretary of Energy.

25           “(7) The Secretary of Homeland Security.

1           “(8) Such other officers of the United States  
2           Government as the President may designate from  
3           time to time.

4           “(c) FUNCTIONS.—The Joint Intelligence Commu-  
5           nity Council shall assist the National Intelligence Director  
6           to in developing and implementing a joint, unified national  
7           intelligence effort to protect national security by—

8           “(1) advising the Director on establishing re-  
9           quirements, developing budgets, financial manage-  
10          ment, and monitoring and evaluating the perform-  
11          ance of the intelligence community, and on such  
12          other matters as the Director may request; and

13          “(2) ensuring the timely execution of programs,  
14          policies, and directives established or developed by  
15          the Director.

16          “(d) MEETINGS.—The Joint Intelligence Community  
17          Council shall meet upon the request of the National Intel-  
18          ligence Director.”.

19   **SEC. 204. IMPROVEMENT OF INTELLIGENCE CAPABILITIES**  
20                   **OF THE FEDERAL BUREAU OF INVESTIGA-**  
21                   **TION.**

22          (a) FINDINGS.—Congress makes the following find-  
23          ings:

24                  (1) The National Commission on Terrorist At-  
25          tacks Upon the United States in its final report



1       stated that, under Director Robert Mueller, the Fed-  
2       eral Bureau of Investigation has made significant  
3       progress in improving its intelligence capabilities.

4               (2) In the report, the members of the Commis-  
5       sion also urged that the Federal Bureau of Inves-  
6       tigation fully institutionalize the shift of the Bureau  
7       to a preventive counterterrorism posture.

8       (b) IMPROVEMENT OF INTELLIGENCE CAPABILI-  
9       TIES.—The Director of the Federal Bureau of Investiga-  
10      tion shall continue efforts to improve the intelligence capa-  
11      bilities of the Federal Bureau of Investigation and to de-  
12      velop and maintain within the Bureau a national intel-  
13      ligence workforce.

14      (c) NATIONAL INTELLIGENCE WORKFORCE.—(1) In  
15      developing and maintaining a national intelligence work-  
16      force under subsection (b), the Director of the Federal Bu-  
17      reau of Investigation shall, subject to the direction and  
18      control of the President, develop and maintain a special-  
19      ized and integrated national intelligence workforce con-  
20      sisting of agents, analysts, linguists, and surveillance spe-  
21      cialists who are recruited, trained, and rewarded in a man-  
22      ner which ensures the existence within the Federal Bureau  
23      of Investigation an institutional culture with substantial  
24      expertise in, and commitment to, the intelligence mission  
25      of the Bureau.

1           (2) Each agent employed by the Bureau after the  
2 date of the enactment of this Act shall receive basic train-  
3 ing in both criminal justice matters and national intel-  
4 ligence matters.

5           (3) Each agent employed by the Bureau after the  
6 date of the enactment of this Act shall, to the maximum  
7 extent practicable, be given the opportunity to undergo,  
8 during such agent's early service with the Bureau, mean-  
9 ingful assignments in criminal justice matters and in na-  
10 tional intelligence matters.

11          (4) The Director shall—

12               (A) establish career positions in national intel-  
13 ligence matters for agents and analysts of the Bu-  
14 reau; and

15               (B) in furtherance of the requirement under  
16 subparagraph (A) and to the maximum extent prac-  
17 ticable, afford agents and analysts of the Bureau the  
18 opportunity to work in the career specialty selected  
19 by such agents and analysts over their entire career  
20 with the Bureau.

21          (5) The Director shall carry out a program to en-  
22 hance the capacity of the Bureau to recruit and retain  
23 individuals with backgrounds in intelligence, international  
24 relations, language, technology, and other skills relevant  
25 to the intelligence mission of the Bureau.

1           (6) The Director shall, to the maximum extent prac-  
2 ticable, afford the analysts of the Bureau training and ca-  
3 reer opportunities commensurate with the training and ca-  
4 reer opportunities afforded analysts in other elements of  
5 the intelligence community.

6           (7) Commencing as soon as practicable after the date  
7 of the enactment of this Act, each direct supervisor of a  
8 Field Intelligence Group, and each Bureau Operational  
9 Manager at the Section Chief and Assistant Special Agent  
10 in Charge (ASAC) level and above, shall be a certified in-  
11 telligence officer.

12          (8) The Director shall, to the maximum extent prac-  
13 ticable, ensure that the successful discharge of advanced  
14 training courses, and of one or more assignments to an-  
15 other element of the intelligence community, is a pre-  
16 condition to advancement to higher level intelligence as-  
17 signments within the Bureau.

18          (d) FIELD OFFICE MATTERS.—(1) In improving the  
19 intelligence capabilities of the Federal Bureau of Inves-  
20 tigation under subsection (b), the Director of the Federal  
21 Bureau of Investigation shall ensure that each Field Intel-  
22 ligence Group reports directly to a field office senior man-  
23 ager responsible for intelligence matters.

24          (2) The Director shall provide for such expansion of  
25 the secure facilities in the field offices of the Bureau as

1 is necessary to ensure the discharge by the field offices  
2 of the intelligence mission of the Bureau.

3 (3) The Director shall require that each Field Intel-  
4 ligence Group manager ensures the integration of ana-  
5 lysts, agents, linguists, and surveillance personnel in the  
6 field.

7 (e) BUDGET MATTERS.—The Director of the Federal  
8 Bureau of Investigation shall, in consultation with the Di-  
9 rector of the Office of Management and Budget, modify  
10 the budget structure of the Federal Bureau of Investiga-  
11 tion in order to organize the budget according to the four  
12 principal missions of the Bureau as follows:

13 (1) Intelligence.

14 (2) Counterterrorism and counterintelligence.

15 (3) Criminal Enterprises/Federal Crimes.

16 (4) Criminal justice services.

17 (f) REPORTS.—(1) Not later than 180 days after the  
18 date of the enactment of this Act, the Director of the Fed-  
19 eral Bureau of Investigation shall submit to Congress a  
20 report on the progress made as of the date of such report  
21 in carrying out the requirements of this section.

22 (2) The Director shall include in each annual pro-  
23 gram review of the Federal Bureau of Investigation that  
24 is submitted to Congress a report on the progress made  
25 by each field office of the Bureau during the period cov-

1 ered by such review in addressing Bureau and national  
2 program priorities.

3 (3) Not later than 180 days after the date of the en-  
4 actment of this Act, and every 12 months thereafter, the  
5 Director shall submit to Congress a report assessing the  
6 qualifications, status, and roles of analysts at Bureau  
7 headquarters and in the field offices of the Bureau.

8 (4) Not later than 180 days after the date of the en-  
9 actment of this Act, and every 12 months thereafter, the  
10 Director shall submit to Congress a report on the progress  
11 of the Bureau in implementing information-sharing prin-  
12 ciples.

13 **SEC. 205. INFORMATION SHARING.**

14 (a) DEFINITIONS.—In this section:

15 (1) ADVISORY BOARD.—The term “Advisory  
16 Board” means the Advisory Board on Information  
17 Sharing established under subsection (i).

18 (2) EXECUTIVE COUNCIL.—The term “Execu-  
19 tive Council” means the Executive Council on Infor-  
20 mation Sharing established under subsection (h).

21 (3) HOMELAND SECURITY INFORMATION.—The  
22 term “homeland security information” means all in-  
23 formation, whether collected, produced, or distrib-  
24 uted by intelligence, law enforcement, military,  
25 homeland security, or other activities relating to—

1 (A) the existence, organization, capabilities,  
2 ties, plans, intentions, vulnerabilities, means of  
3 finance or material support, or activities of for-  
4 eign or international terrorist groups or individ-  
5 uals, or of domestic groups or individuals in-  
6 volved in transnational terrorism;

7 (B) threats posed by such groups or indi-  
8 viduals to the United States, United States per-  
9 sons, or United States interests, or to those of  
10 other nations;

11 (C) communications of or by such groups  
12 or individuals; or

13 (D) groups or individuals reasonably be-  
14 lieved to be assisting or associated with such  
15 groups or individuals.

16 (4) NETWORK.—The term “Network” means  
17 the Information Sharing Network described under  
18 subsection (c).

19 (b) FINDINGS.—Consistent with the report of the Na-  
20 tional Commission on Terrorist Attacks upon the United  
21 States, Congress makes the following findings:

22 (1) The effective use of information, from all  
23 available sources, is essential to the fight against  
24 terror and the protection of our homeland. The big-  
25 gest impediment to all-source analysis, and to a

1 greater likelihood of “connecting the dots”, is resist-  
2 ance to sharing information.

3 (2) The United States Government has access  
4 to a vast amount of information, including not only  
5 traditional intelligence but also other government  
6 databases, such as those containing customs or im-  
7 migration information. However, the United States  
8 Government has a weak system for processing and  
9 using the information it has.

10 (3) In the period preceding September 11,  
11 2001, there were instances of potentially helpful in-  
12 formation that was available but that no person  
13 knew to ask for; information that was distributed  
14 only in compartmented channels, and information  
15 that was requested but could not be shared.

16 (4) Current security requirements nurture over-  
17 classification and excessive compartmentalization of  
18 information among agencies. Each agency’s incentive  
19 structure opposes sharing, with risks, including  
20 criminal, civil, and administrative sanctions, but few  
21 rewards for sharing information.

22 (5) The current system, in which each intel-  
23 ligence agency has its own security practices, re-  
24 quires a demonstrated “need to know” before shar-  
25 ing. This approach assumes that it is possible to

1 know, in advance, who will need to use the informa-  
2 tion. An outgrowth of the cold war, such a system  
3 implicitly assumes that the risk of inadvertent dis-  
4 closure outweighs the benefits of wider sharing.  
5 Such assumptions are no longer appropriate. Al-  
6 though counterintelligence concerns are still real, the  
7 costs of not sharing information are also substantial.  
8 The current “need-to-know” culture of information  
9 protection needs to be replaced with a “need-to-  
10 share” culture of integration.

11 (6) A new approach to the sharing of intel-  
12 ligence and homeland security information is ur-  
13 gently needed. An important conceptual model for a  
14 new “trusted information network” is the System-  
15 wide Homeland Analysis and Resource Exchange  
16 (SHARE) Network proposed by a task force of lead-  
17 ing professionals assembled by the Markle Founda-  
18 tion and described in reports issued in October 2002  
19 and December 2003.

20 (7) No single agency can create a meaningful  
21 information sharing system on its own. Alone, each  
22 agency can only modernize stovepipes, not replace  
23 them. Presidential leadership is required to bring  
24 about governmentwide change.

25 (c) INFORMATION SHARING NETWORK.—



1           (1) ESTABLISHMENT.—The President shall es-  
2           tablish a trusted information network and secure in-  
3           formation sharing environment to promote sharing  
4           of intelligence and homeland security information in  
5           a manner consistent with national security and the  
6           protection of privacy and civil liberties, and based on  
7           clearly defined and consistently applied policies and  
8           procedures, and valid investigative, analytical or  
9           operational requirements.

10          (2) ATTRIBUTES.—The Network shall promote  
11          coordination, communication and collaboration of  
12          people and information among all relevant Federal  
13          departments and agencies, State, tribal, and local  
14          authorities, and relevant private sector entities, in-  
15          cluding owners and operators of critical infrastruc-  
16          ture, by using policy guidelines and technologies that  
17          support—

18                 (A) a decentralized, distributed, and co-  
19                 ordinated environment that connects existing  
20                 systems where appropriate and allows users to  
21                 share information among agencies, between lev-  
22                 els of government, and, as appropriate, with the  
23                 private sector;

1 (B) the sharing of information in a form  
2 and manner that facilitates its use in analysis,  
3 investigations and operations;

4 (C) building upon existing systems capa-  
5 bilities currently in use across the Government;

6 (D) utilizing industry best practices, in-  
7 cluding minimizing the centralization of data  
8 and seeking to use common tools and capabili-  
9 ties whenever possible;

10 (E) employing an information access man-  
11 agement approach that controls access to data  
12 rather than to just networks;

13 (F) facilitating the sharing of information  
14 at and across all levels of security by using pol-  
15 icy guidelines and technologies that support  
16 writing information that can be broadly shared;

17 (G) providing directory services for locat-  
18 ing people and information;

19 (H) incorporating protections for individ-  
20 uals' privacy and civil liberties;

21 (I) incorporating strong mechanisms for  
22 information security and privacy and civil lib-  
23 erties guideline enforcement in order to enhance  
24 accountability and facilitate oversight,  
25 including—

1 (i) multifactor authentication and ac-  
2 cess control;

3 (ii) strong encryption and data protec-  
4 tion;

5 (iii) immutable audit capabilities;

6 (iv) automated policy enforcement;

7 (v) perpetual, automated screening for  
8 abuses of network and intrusions; and

9 (vi) uniform classification and han-  
10 dling procedures;

11 (J) compliance with requirements of appli-  
12 cable law and guidance with regard to the plan-  
13 ning, design, acquisition, operation, and man-  
14 agement of information systems; and

15 (K) permitting continuous system up-  
16 grades to benefit from advances in technology  
17 while preserving the integrity of stored data.

18 (d) IMMEDIATE ACTIONS.—Not later than 90 days  
19 after the date of the enactment of this Act, the Director  
20 of the Office of Management and Budget, in consultation  
21 with the Executive Council, shall—

22 (1) submit to the President and to Congress a  
23 description of the technological, legal, and policy  
24 issues presented by the creation of the Network de-

1       scribed in subsection (c), and the way in which these  
2       issues will be addressed;

3           (2) establish electronic directory services to as-  
4       sist in locating in the Federal Government intel-  
5       ligence and homeland security information and peo-  
6       ple with relevant knowledge about intelligence and  
7       homeland security information; and

8           (3) conduct a review of relevant current Federal  
9       agency capabilities, including—

10           (A) a baseline inventory of current Federal  
11       systems that contain intelligence or homeland  
12       security information;

13           (B) the money currently spent to maintain  
14       those systems; and

15           (C) identification of other information that  
16       should be included in the Network.

17       (e) GUIDELINES AND REQUIREMENTS.—As soon as  
18       possible, but in no event later than 180 days after the  
19       date of the enactment of this Act, the President shall—

20           (1) in consultation with the Executive  
21       Council—

22           (A) issue guidelines for acquiring, access-  
23       ing, sharing, and using information, including  
24       guidelines to ensure that information is pro-  
25       vided in its most shareable form, such as by

1 separating out data from the sources and meth-  
2 ods by which that data are obtained; and

3 (B) on classification policy and handling  
4 procedures across Federal agencies, including  
5 commonly accepted processing and access con-  
6 trols;

7 (2) in consultation with the Privacy and Civil  
8 Liberties Oversight Board established under section  
9 211, issue guidelines that—

10 (A) protect privacy and civil liberties in the  
11 development and use of the Network; and

12 (B) shall be made public, unless, and only  
13 to the extent that, nondisclosure is clearly nec-  
14 essary to protect national security; and

15 (3) require the heads of Federal departments  
16 and agencies to promote a culture of information  
17 sharing by—

18 (A) reducing disincentives to information  
19 sharing, including overclassification of informa-  
20 tion and unnecessary requirements for origi-  
21 nator approval; and

22 (B) providing affirmative incentives for in-  
23 formation sharing, such as the incorporation of  
24 information sharing performance measures into  
25 agency and managerial evaluations, and em-

1           employee awards for promoting innovative infor-  
2           mation sharing practices.

3           (f) ENTERPRISE ARCHITECTURE AND IMPLEMENTA-  
4   TION PLAN.—Not later than 270 days after the date of  
5   the enactment of this Act, the Director of Management  
6   and Budget shall submit to the President and to Congress  
7   an enterprise architecture and implementation plan for the  
8   Network. The enterprise architecture and implementation  
9   plan shall be prepared by the Director of Management and  
10  Budget, in consultation with the Executive Council, and  
11  shall include—

12           (1) a description of the parameters of the pro-  
13   posed Network, including functions, capabilities, and  
14   resources;

15           (2) a delineation of the roles of the Federal de-  
16   partments and agencies that will participate in the  
17   development of the Network, including identification  
18   of any agency that will build the infrastructure need-  
19   ed to operate and manage the Network (as distinct  
20   from the individual agency components that are to  
21   be part of the Network), with the delineation of roles  
22   to be consistent with—

23           (A) the authority of the National Intel-  
24   ligence Director under this Act to set standards  
25   for information sharing and information tech-

1 nology throughout the intelligence community;  
2 and

3 (B) the authority of the Secretary of  
4 Homeland Security and the role of the Depart-  
5 ment of Homeland Security in coordinating  
6 with State, tribal, and local officials and the  
7 private sector;

8 (3) a description of the technological require-  
9 ments to appropriately link and enhance existing  
10 networks and a description of the system design that  
11 will meet these requirements;

12 (4) an enterprise architecture that—

13 (A) is consistent with applicable laws and  
14 guidance with regard to planning, design, acqui-  
15 sition, operation, and management of informa-  
16 tion systems;

17 (B) will be used to guide and define the  
18 development and implementation of the Net-  
19 work; and

20 (C) addresses the existing and planned en-  
21 terprise architectures of the departments and  
22 agencies participating in the Network;

23 (5) a description of how privacy and civil lib-  
24 erties will be protected throughout the design and  
25 implementation of the Network;

1           (6) objective, systemwide performance measures  
2           to enable the assessment of progress toward achiev-  
3           ing full implementation of the Network;

4           (7) a plan, including a time line, for the devel-  
5           opment and phased implementation of the Network;

6           (8) total budget requirements to develop and  
7           implement the Network, including the estimated an-  
8           nual cost for each of the 5 years following the date  
9           of the enactment of this Act; and

10          (9) proposals for any legislation that the Direc-  
11          tor of Management and Budget determines nec-  
12          essary to implement the Network.

13          (g) DIRECTOR OF MANAGEMENT AND BUDGET RE-  
14          SPONSIBLE FOR INFORMATION SHARING ACROSS THE  
15          FEDERAL GOVERNMENT.—

16                 (1) ADDITIONAL DUTIES AND RESPONSIBIL-  
17                 ITIES.—

18                         (A) IN GENERAL.—The Director of Man-  
19                         agement and Budget, in consultation with the  
20                         Executive Council, shall—

21                                 (i) implement and manage the Net-  
22                                 work;

23                                 (ii) develop and implement policies,  
24                                 procedures, guidelines, rules, and stand-  
25                                 ards as appropriate to foster the develop-



1                   ment and proper operation of the Network;  
2                   and

3                   (iii) assist, monitor, and assess the  
4                   implementation of the Network by Federal  
5                   departments and agencies to ensure ade-  
6                   quate progress, technological consistency  
7                   and policy compliance; and regularly report  
8                   the findings to the President and to Con-  
9                   gress.

10                  (B) CONTENT OF POLICIES, PROCEDURES,  
11                  GUIDELINES, RULES, AND STANDARDS.—The  
12                  policies, procedures, guidelines, rules, and  
13                  standards under subparagraph (A)(ii) shall—

14                   (i) take into account the varying mis-  
15                   sions and security requirements of agencies  
16                   participating in the Network;

17                   (ii) address development, implementa-  
18                   tion, and oversight of technical standards  
19                   and requirements;

20                   (iii) address and facilitate information  
21                   sharing between and among departments  
22                   and agencies of the intelligence community,  
23                   the Department of Defense, the Homeland  
24                   Security community and the law enforce-  
25                   ment community;

1 (iv) address and facilitate information  
2 sharing between Federal departments and  
3 agencies and State, tribal and local govern-  
4 ments;

5 (v) address and facilitate, as appro-  
6 priate, information sharing between Fed-  
7 eral departments and agencies and the pri-  
8 vate sector;

9 (vi) address and facilitate, as appro-  
10 priate, information sharing between Fed-  
11 eral departments and agencies with foreign  
12 partners and allies; and

13 (vii) ensure the protection of privacy  
14 and civil liberties.

15 (2) APPOINTMENT OF PRINCIPAL OFFICER.—

16 Not later than 30 days after the date of the enact-  
17 ment of this Act, the Director of Management and  
18 Budget shall appoint, with approval of the Presi-  
19 dent, a principal officer in the Office of Management  
20 and Budget whose primary responsibility shall be to  
21 carry out the day-to-day duties of the Director speci-  
22 fied in this section. The officer shall report directly  
23 to the Director of Management and Budget, have  
24 the rank of a Deputy Director and shall be paid at  
25 the rate of pay payable for a position at level III of

1 the Executive Schedule under section 5314 of title  
2 5, United States Code.

3 (h) EXECUTIVE COUNCIL ON INFORMATION SHAR-  
4 ING.—

5 (1) ESTABLISHMENT.—There is established an  
6 Executive Council on Information Sharing that shall  
7 assist the Director of Management and Budget in  
8 the execution of the Director's duties under this Act  
9 concerning information sharing.

10 (2) MEMBERSHIP.—The members of the Execu-  
11 tive Council shall be—

12 (A) the Director of Management and  
13 Budget, who shall serve as Chairman of the Ex-  
14 ecutive Council;

15 (B) the Secretary of Homeland Security or  
16 his designee;

17 (C) the Secretary of Defense or his des-  
18 ignee;

19 (D) the Attorney General or his designee;

20 (E) the Secretary of State or his designee;

21 (F) the Director of the Federal Bureau of  
22 Investigation or his designee;

23 (G) the National Intelligence Director or  
24 his designee;

1 (H) such other Federal officials as the  
2 President shall designate;

3 (I) representatives of State, tribal, and  
4 local governments, to be appointed by the Presi-  
5 dent; and

6 (J) individuals who are employed in private  
7 businesses or nonprofit organizations that own  
8 or operate critical infrastructure, to be ap-  
9 pointed by the President.

10 (3) RESPONSIBILITIES.—The Executive Council  
11 shall assist the Director of Management and Budget  
12 in—

13 (A) implementing and managing the Net-  
14 work;

15 (B) developing policies, procedures, guide-  
16 lines, rules, and standards necessary to estab-  
17 lish and implement the Network;

18 (C) ensuring there is coordination among  
19 departments and agencies participating in the  
20 Network in the development and implementa-  
21 tion of the Network;

22 (D) reviewing, on an ongoing basis, poli-  
23 cies, procedures, guidelines, rules, and stand-  
24 ards related to the implementation of the Net-  
25 work;

1           (E) establishing a dispute resolution pro-  
2           cess to resolve disagreements among depart-  
3           ments and agencies about whether particular  
4           information should be shared and in what man-  
5           ner; and

6           (F) considering such reports as are sub-  
7           mitted by the Advisory Board on Information  
8           Sharing under subsection (i)(2).

9           (4) INAPPLICABILITY OF FEDERAL ADVISORY  
10          COMMITTEE ACT.—The Council shall not be subject  
11          to the requirements of the Federal Advisory Com-  
12          mittee Act (5 U.S.C. App.).

13          (5) REPORTS.—Not later than 1 year after the  
14          date of the enactment of this Act, and annually  
15          thereafter, the Director of Management and Budget,  
16          in the capacity of Chair of the Executive Council,  
17          shall submit a report to the President and to Con-  
18          gress that shall include—

19                (A) a description of the activities and ac-  
20                complishments of the Council in the preceding  
21                year; and

22                (B) the number and dates of the meetings  
23                held by the Council and a list of attendees at  
24                each meeting.

1           (6) INFORMING THE PUBLIC.—The Executive  
2 Council shall—

3           (A) make its reports to Congress available  
4 to the public to the greatest extent that is con-  
5 sistent with the protection of classified informa-  
6 tion and applicable law; and

7           (B) otherwise inform the public of its ac-  
8 tivities, as appropriate and in a manner con-  
9 sistent with the protection of classified informa-  
10 tion and applicable law.

11 (i) ADVISORY BOARD ON INFORMATION SHARING.—

12           (1) ESTABLISHMENT.—There is established an  
13 Advisory Board on Information Sharing to advise  
14 the President and the Executive Council on policy,  
15 technical, and management issues related to the de-  
16 sign and operation of the Network.

17           (2) RESPONSIBILITIES.—The Advisory Board  
18 shall advise the Executive Council on policy, tech-  
19 nical, and management issues related to the design  
20 and operation of the Network. At the request of the  
21 Executive Council, or the Director of Management  
22 and Budget in the capacity as Chair of the Execu-  
23 tive Council, or on its own initiative, the Advisory  
24 Board shall submit reports to the Executive Council  
25 concerning the findings and recommendations of the

1 Advisory Board regarding the design and operation  
2 of the Network.

3 (3) MEMBERSHIP AND QUALIFICATIONS.—The  
4 Advisory Board shall be composed of no more than  
5 15 members, to be appointed by the President from  
6 outside the Federal Government. The members of  
7 the Advisory Board shall have significant experience  
8 or expertise in policy, technical and operational mat-  
9 ters, including issues of security, privacy, or civil lib-  
10 erties, and shall be selected solely on the basis of  
11 their professional qualifications, achievements, public  
12 stature and relevant experience.

13 (4) CHAIR.—The President shall designate one  
14 of the members of the Advisory Board to act as  
15 chair of the Advisory Board.

16 (5) ADMINISTRATIVE SUPPORT.—The Office of  
17 Management and Budget shall provide administra-  
18 tive support for the Advisory Board.

19 (j) REPORTS.—

20 (1) IN GENERAL.—Not later than 1 year after  
21 the date of the enactment of this Act, and semiannu-  
22 ally thereafter, the President through the Director of  
23 Management and Budget shall submit a report to  
24 Congress on the state of the Network and of infor-  
25 mation sharing across the Federal Government.

1           (2) CONTENT.—Each report under this sub-  
2 section shall include—

3           (A) a progress report on the extent to  
4 which the Network has been implemented, in-  
5 cluding how the Network has fared on the gov-  
6 ernment-wide and agency-specific performance  
7 measures and whether the performance goals  
8 set in the preceding year have been met;

9           (B) objective systemwide performance  
10 goals for the following year;

11           (C) an accounting of how much was spent  
12 on the Network in the preceding year;

13           (D) actions taken to ensure that agencies  
14 procure new technology that is consistent with  
15 the Network and information on whether new  
16 systems and technology are consistent with the  
17 Network;

18           (E) the extent to which, in appropriate cir-  
19 cumstances, all terrorism watch lists are avail-  
20 able for combined searching in real time  
21 through the Network and whether there are  
22 consistent standards for placing individuals on,  
23 and removing individuals from, the watch lists,  
24 including the availability of processes for cor-  
25 recting errors;



1 (F) the extent to which unnecessary road-  
2 blocks, impediments, or disincentives to infor-  
3 mation sharing, including the inappropriate use  
4 of paper-only intelligence products and require-  
5 ments for originator approval, have been elimi-  
6 nated;

7 (G) the extent to which positive incentives  
8 for information sharing have been implemented;

9 (H) the extent to which classified informa-  
10 tion is also made available through the Net-  
11 work, in whole or in part, in unclassified form;

12 (I) the extent to which State, tribal, and  
13 local officials—

14 (i) are participating in the Network;

15 (ii) have systems which have become  
16 integrated into the Network;

17 (iii) are providing as well as receiving  
18 information; and

19 (iv) are using the Network to commu-  
20 nicate with each other;

21 (J) the extent to which—

22 (i) private sector data, including infor-  
23 mation from owners and operators of crit-  
24 ical infrastructure, is incorporated in the  
25 Network; and

1 (ii) the private sector is both pro-  
2 viding and receiving information;

3 (K) where private sector data has been  
4 used by the Government or has been incor-  
5 porated into the Network—

6 (i) the measures taken to protect sen-  
7 sitive business information; and

8 (ii) where the data involves informa-  
9 tion about individuals, the measures taken  
10 to ensure the accuracy of such data;

11 (L) the measures taken by the Federal  
12 Government to ensure the accuracy of other in-  
13 formation on the Network and, in particular,  
14 the accuracy of information about individuals;

15 (M) an assessment of the Network's pri-  
16 vacy and civil liberties protections, including ac-  
17 tions taken in the preceding year to implement  
18 or enforce privacy and civil liberties protections  
19 and a report of complaints received about inter-  
20 ference with an individual's privacy or civil lib-  
21 erties; and

22 (N) an assessment of the security protec-  
23 tions of the Network.

24 (k) AGENCY RESPONSIBILITIES.—The head of each  
25 department or agency possessing or using intelligence or

1 homeland security information or otherwise participating  
2 in the Network shall—

3           (1) ensure full department or agency compli-  
4           ance with information sharing policies, procedures,  
5           guidelines, rules, and standards established for the  
6           Network under subsections (c) and (g);

7           (2) ensure the provision of adequate resources  
8           for systems and activities supporting operation of  
9           and participation in the Network; and

10           (3) ensure full agency or department coopera-  
11           tion in the development of the Network and associ-  
12           ated enterprise architecture to implement govern-  
13           mentwide information sharing, and in the manage-  
14           ment and acquisition of information technology con-  
15           sistent with applicable law.

16           (1) AGENCY PLANS AND REPORTS.—Each Federal  
17           department or agency that possesses or uses intelligence  
18           and homeland security information, operates a system in  
19           the Network or otherwise participates, or expects to par-  
20           ticipate, in the Network, shall submit to the Director of  
21           Management and Budget—

22           (1) not later than 1 year after the date of the  
23           enactment of this Act, a report including—

1 (A) a strategic plan for implementation of  
2 the Network's requirements within the depart-  
3 ment or agency;

4 (B) objective performance measures to as-  
5 sess the progress and adequacy of the depart-  
6 ment or agency's information sharing efforts;  
7 and

8 (C) budgetary requirements to integrate  
9 the agency into the Network, including pro-  
10 jected annual expenditures for each of the fol-  
11 lowing 5 years following the submission of the  
12 report; and

13 (2) annually thereafter, reports including—

14 (A) an assessment of the progress of the  
15 department or agency in complying with the  
16 Network's requirements, including how well the  
17 agency has performed on the objective measures  
18 developed under paragraph (1)(B);

19 (B) the agency's expenditures to imple-  
20 ment and comply with the Network's require-  
21 ments in the preceding year; and

22 (C) the agency's or department's plans for  
23 further implementation of the Network in the  
24 year following the submission of the report.

25 (m) PERIODIC ASSESSMENTS.—

1 (1) COMPTROLLER GENERAL.—

2 (A) IN GENERAL.—Not later than 1 year  
3 after the date of the enactment of this Act, and  
4 periodically thereafter, the Comptroller General  
5 shall evaluate the implementation of the Net-  
6 work, both generally and, at the discretion of  
7 the Comptroller General, within specific depart-  
8 ments and agencies, to determine the extent of  
9 compliance with the Network's requirements  
10 and to assess the effectiveness of the Network  
11 in improving information sharing and collabora-  
12 tion and in protecting privacy and civil liberties,  
13 and shall report to Congress on the findings of  
14 the Comptroller General.

15 (B) INFORMATION AVAILABLE TO THE  
16 COMPTROLLER GENERAL.—Upon request by the  
17 Comptroller General, information relevant to an  
18 evaluation under subsection (a) shall be made  
19 available to the Comptroller General under sec-  
20 tion 716 of title 31, United States Code.

21 (C) CONSULTATION WITH CONGRESSIONAL  
22 COMMITTEES.—If a record is not made avail-  
23 able to the Comptroller General within a rea-  
24 sonable time, before the Comptroller General  
25 files a report under section 716(b)(1) of title

1           31, United States Code, the Comptroller Gen-  
2           eral shall consult with the Select Committee on  
3           Intelligence of the Senate, the Permanent Se-  
4           lect Committee on Intelligence of the House of  
5           Representatives, the Committee on Govern-  
6           mental Affairs of the Senate, and the Com-  
7           mittee on Government Reform of the House of  
8           Representatives concerning the Comptroller's  
9           intent to file a report.

10           (2) INSPECTORS GENERAL.—The Inspector  
11           General in any Federal department or agency that  
12           possesses or uses intelligence or homeland security  
13           information or that otherwise participates in the  
14           Network shall, at the discretion of the Inspector  
15           General—

16                   (A) conduct audits or investigations to—

17                           (i) determine the compliance of that  
18                           department or agency with the Network's  
19                           requirements; and

20                           (ii) assess the effectiveness of that de-  
21                           partment or agency in improving informa-  
22                           tion sharing and collaboration and in pro-  
23                           tecting privacy and civil liberties; and

24                   (B) issue reports on such audits and inves-  
25           tigations.

1 (n) AUTHORIZATION OF APPROPRIATIONS.—There  
2 are authorized to be appropriated—

3 (1) \$50,000,000 to the Director of Management  
4 and Budget to carry out this section for fiscal year  
5 2005; and

6 (2) such sums as are necessary to carry out this  
7 section in each fiscal year thereafter, to be disbursed  
8 and allocated in accordance with the Network imple-  
9 mentation plan required by subsection (f).

10 **Subtitle B—Privacy and Civil**  
11 **Liberties**

12 **SEC. 211. PRIVACY AND CIVIL LIBERTIES OVERSIGHT**  
13 **BOARD.**

14 (a) IN GENERAL.—There is established within the  
15 Executive Office of the President a Privacy and Civil Lib-  
16 erties Oversight Board (referred to in this subtitle as the  
17 “Board”).

18 (b) FINDINGS.—Consistent with the report of the Na-  
19 tional Commission on Terrorist Attacks Upon the United  
20 States, Congress makes the following findings:

21 (1) In conducting the war on terrorism, the  
22 Government may need additional powers and may  
23 need to enhance the use of its existing powers.

24 (2) This shift of power and authority to the  
25 Government calls for an enhanced system of checks

1 and balances to protect the precious liberties that  
2 are vital to our way of life and to ensure that the  
3 Government uses its powers for the purposes for  
4 which the powers were given.

5 (c) PURPOSE.—The Board shall—

6 (1) analyze and review actions the executive  
7 branch takes to protect the Nation from terrorism;  
8 and

9 (2) ensure that liberty concerns are appro-  
10 priately considered in the development and imple-  
11 mentation of laws, regulations, and policies related  
12 to efforts to protect the Nation against terrorism.

13 (d) FUNCTIONS.—

14 (1) ADVICE AND COUNSEL ON POLICY DEVEL-  
15 OPMENT AND IMPLEMENTATION.—The Board  
16 shall—

17 (A) review proposed legislation, regula-  
18 tions, and policies related to efforts to protect  
19 the Nation from terrorism, including the devel-  
20 opment and adoption of information sharing  
21 guidelines under section 205(g);

22 (B) review the implementation of new and  
23 existing legislation, regulations, and policies re-  
24 lated to efforts to protect the Nation from ter-



1           rorism, including the implementation of infor-  
2           mation sharing guidelines under section 205(g);

3           (C) advise the President and the depart-  
4           ments, agencies, and elements of the executive  
5           branch to ensure that privacy and civil liberties  
6           are appropriately considered in the development  
7           and implementation of such legislation, regula-  
8           tions, policies, and guidelines; and

9           (D) in providing advice on proposals to re-  
10          tain or enhance a particular governmental  
11          power, consider whether the department, agen-  
12          cy, or element of the executive branch has  
13          explained—

14                 (i) that the power actually materially  
15                 enhances security;

16                 (ii) that there is adequate supervision  
17                 of the use by the executive branch of the  
18                 power to ensure protection of privacy and  
19                 civil liberties; and

20                 (iii) that there are adequate guidelines  
21                 and oversight to properly confine its use.

22          (2) OVERSIGHT.—The Board shall continually  
23          review—

24                 (A) the regulations, policies, and proce-  
25                 dures, and the implementation of the regula-

1 tions, policies, and procedures, of the depart-  
2 ments, agencies, and elements of the executive  
3 branch to ensure that privacy and civil liberties  
4 are protected;

5 (B) the information sharing practices of  
6 the departments, agencies, and elements of the  
7 executive branch to determine whether they ap-  
8 propriately protect privacy and civil liberties  
9 and adhere to the information sharing guide-  
10 lines prescribed under section 205(g) and to  
11 other governing laws, regulations, and policies  
12 regarding privacy and civil liberties; and

13 (C) other actions by the executive branch  
14 related to efforts to protect the Nation from  
15 terrorism to determine whether such actions—

16 (i) appropriately protect privacy and  
17 civil liberties; and

18 (ii) are consistent with governing  
19 laws, regulations, and policies regarding  
20 privacy and civil liberties.

21 (3) RELATIONSHIP WITH PRIVACY AND CIVIL  
22 LIBERTIES OFFICERS.—The Board shall—

23 (A) review and assess reports and other in-  
24 formation from privacy officers and civil lib-  
25 erties officers described in section 212;

1 (B) when appropriate, make recommenda-  
2 tions to such privacy officers and civil liberties  
3 officers regarding their activities; and

4 (C) when appropriate, coordinate the ac-  
5 tivities of such privacy officers and civil liberties  
6 officers on relevant interagency matters.

7 (e) REPORTS.—

8 (1) IN GENERAL.—The Board shall—

9 (A) receive and review reports from privacy  
10 officers and civil liberties officers described in  
11 section 212; and

12 (B) periodically submit, not less than semi-  
13 annually, reports to Congress and the Presi-  
14 dent, with such reports in an unclassified form  
15 to the greatest extent possible and available in  
16 a classified annex when necessary.

17 (2) CONTENTS.—Not less than 2 reports sub-  
18 mitted each year under paragraph (1)(B) shall  
19 include—

20 (A) a description of the major activities of  
21 the Board during the preceding period; and

22 (B) information on the findings, conclu-  
23 sions, and recommendations of the Board re-  
24 sulting from its advice and oversight functions  
25 under subsection (d).

1 (f) INFORMING THE PUBLIC.—The Board  
2 shall—

3 (1) make its reports, including its reports to  
4 Congress, available to the public to the greatest ex-  
5 tent that is consistent with the protection of classi-  
6 fied information and applicable law; and

7 (2) hold public hearings and otherwise inform  
8 the public of its activities, as appropriate and in a  
9 manner consistent with the protection of classified  
10 information and applicable law.

11 (g) ACCESS TO INFORMATION.—

12 (1) AUTHORIZATION.—If determined by the  
13 Board to be necessary to carry out its responsibil-  
14 ities under this section, the Board is authorized to—

15 (A) have access from any department,  
16 agency, or element of the executive branch, or  
17 any Federal officer or employee, to all relevant  
18 records, reports, audits, reviews, documents, pa-  
19 pers, recommendations, or other relevant mate-  
20 rial, including classified information consistent  
21 with applicable law;

22 (B) interview, take statements from, or  
23 take public testimony from personnel of any de-  
24 partment, agency, or element of the executive  
25 branch, or any Federal officer or employee;

1 (C) request information or assistance from  
2 any State, tribal, or local government; and

3 (D) require, by subpoena issued at the di-  
4 rection of a majority of the members of the  
5 Board, persons (other than departments, agen-  
6 cies, and elements of the executive branch) to  
7 produce any relevant information, documents,  
8 reports, answers, records, accounts, papers, and  
9 other documentary or testimonial evidence.

10 (2) ENFORCEMENT OF SUBPOENA.—In the case  
11 of contumacy or failure to obey a subpoena issued  
12 under paragraph (1)(D), the United States district  
13 court for the judicial district in which the subpoe-  
14 naed person resides, is served, or may be found may  
15 issue an order requiring such person to produce the  
16 evidence required by such subpoena.

17 (3) AGENCY COOPERATION.—Whenever infor-  
18 mation or assistance requested under subparagraph  
19 (A) or (B) of paragraph (1) is, in the judgment of  
20 the Board, unreasonably refused or not provided, the  
21 Board shall report the circumstances to the head of  
22 the department, agency, or element concerned with-  
23 out delay. The head of the department, agency, or  
24 element concerned shall ensure that the Board is  
25 given access to the information, assistance, material,

1 or personnel the Board determines to be necessary  
2 to carry out its functions.

3 (h) MEMBERSHIP.—

4 (1) MEMBERS.—The Board shall be composed  
5 of a full-time chairman and 4 additional members,  
6 who shall be appointed by the President, by and  
7 with the advice and consent of the Senate.

8 (2) QUALIFICATIONS.—Members of the Board  
9 shall be selected solely on the basis of their profes-  
10 sional qualifications, achievements, public stature,  
11 and relevant experience, and without regard to polit-  
12 ical affiliation.

13 (3) INCOMPATIBLE OFFICE.—An individual ap-  
14 pointed to the Board may not, while serving on the  
15 Board, be an elected official, officer, or employee of  
16 the Federal Government, other than in the capacity  
17 as a member of the Board.

18 (i) COMPENSATION AND TRAVEL EXPENSES.—

19 (1) COMPENSATION.—

20 (A) CHAIRMAN.—The chairman shall be  
21 compensated at the rate of pay payable for a  
22 position at level III of the Executive Schedule  
23 under section 5314 of title 5, United States  
24 Code, for each day during which the chairman

1 is engaged in the actual performance of the du-  
2 ties of the Board.

3 (B) MEMBERS.—Each member of the  
4 Board shall be compensated at a rate of pay  
5 payable for a position at level IV of the Execu-  
6 tive Schedule under section 5315 of title 5,  
7 United States Code, for each day during which  
8 that member is engaged in the actual perform-  
9 ance of the duties of the Board.

10 (2) TRAVEL EXPENSES.—Members of the  
11 Board shall be allowed travel expenses, including per  
12 diem in lieu of subsistence, at rates authorized for  
13 persons employed intermittently by the Government  
14 under section 5703(b) of title 5, United States Code,  
15 while away from their homes or regular places of  
16 business in the performance of services for the  
17 Board.

18 (j) STAFF.—

19 (1) APPOINTMENT AND COMPENSATION.—The  
20 Chairman, in accordance with rules agreed upon by  
21 the Board, shall appoint and fix the compensation of  
22 a full-time executive director and such other per-  
23 sonnel as may be necessary to enable the Board to  
24 carry out its functions, without regard to the provi-  
25 sions of title 5, United States Code, governing ap-

1 pointments in the competitive service, and without  
2 regard to the provisions of chapter 51 and sub-  
3 chapter III of chapter 53 of such title relating to  
4 classification and General Schedule pay rates, except  
5 that no rate of pay fixed under this subsection may  
6 exceed the equivalent of that payable for a position  
7 at level V of the Executive Schedule under section  
8 5316 of title 5, United States Code.

9 (2) **DETAILEES.**—Any Federal employee may  
10 be detailed to the Board without reimbursement  
11 from the Board, and such detailee shall retain the  
12 rights, status, and privileges of the detailee's regular  
13 employment without interruption.

14 (3) **CONSULTANT SERVICES.**—The Board may  
15 procure the temporary or intermittent services of ex-  
16 perts and consultants in accordance with section  
17 3109 of title 5, United States Code, at rates that do  
18 not exceed the daily rate paid a person occupying a  
19 position at level IV of the Executive Schedule under  
20 section 5315 of such title.

21 (k) **SECURITY CLEARANCES.**—The appropriate de-  
22 partments, agencies, and elements of the executive branch  
23 shall cooperate with the Board to expeditiously provide the  
24 Board members and staff with appropriate security clear-



1 ances to the extent possible under existing procedures and  
2 requirements.

3 (1) TREATMENT AS AGENCY, NOT AS ADVISORY COM-  
4 MITTEE.—The Board—

5 (1) is an agency (as defined in section 551(1)  
6 of title 5, United States Code); and

7 (2) is not an advisory committee (as defined in  
8 section 3(2) of the Federal Advisory Committee Act  
9 (5 U.S.C. App.)).

10 **SEC. 212. PRIVACY AND CIVIL LIBERTIES OFFICERS.**

11 (a) DESIGNATION AND FUNCTIONS.—The Attorney  
12 General, the Secretary of Defense, the Secretary of State,  
13 the Secretary of the Treasury, the Secretary of Health and  
14 Human Services, the Secretary of Homeland Security, the  
15 National Intelligence Director, the Director of the Central  
16 Intelligence Agency, and the head of any other depart-  
17 ment, agency, or element of the executive branch des-  
18 ignated by the Privacy and Civil Liberties Oversight  
19 Board to be appropriate for coverage under this section  
20 shall designate not less than 1 senior officer to—

21 (1) assist the head of such department, agency,  
22 or element and other officials of such department,  
23 agency, or element in appropriately considering pri-  
24 vacy and civil liberties concerns when such officials  
25 are proposing, developing, or implementing laws,

1 regulations, policies, procedures, or guidelines re-  
2 lated to efforts to protect the Nation against ter-  
3 rorism;

4 (2) periodically investigate and review depart-  
5 ment, agency, or element actions, policies, proce-  
6 dures, guidelines, and related laws and their imple-  
7 mentation to ensure that such department, agency,  
8 or element is adequately considering privacy and  
9 civil liberties in its actions;

10 (3) ensure that such department, agency, or  
11 element has adequate procedures to receive, inves-  
12 tigate, respond to, and redress complaints from indi-  
13 viduals who allege such department, agency, or ele-  
14 ment has violated their privacy or civil liberties; and

15 (4) in providing advice on proposals to retain or  
16 enhance a particular governmental power the officer  
17 shall consider whether such department, agency, or  
18 element has explained—

19 (i) that the power actually materially  
20 enhances security;

21 (ii) that there is adequate supervision  
22 of the use by such department, agency, or  
23 element of the power to ensure protection  
24 of privacy and civil liberties; and

1 (iii) that there are adequate guidelines  
2 and oversight to properly confine its use.

3 (b) EXCEPTION TO DESIGNATION AUTHORITY.—

4 (1) PRIVACY OFFICERS.—In any department,  
5 agency, or element referred to in subsection (a) or  
6 designated by the Board, which has a statutorily  
7 created privacy officer, such officer shall perform the  
8 functions specified in subsection (a) with respect to  
9 privacy.

10 (2) CIVIL LIBERTIES OFFICERS.—In any de-  
11 partment, agency, or element referred to in sub-  
12 section (a) or designated by the Board, which has a  
13 statutorily created civil liberties officer, such officer  
14 shall perform the functions specified in subsection  
15 (a) with respect to civil liberties.

16 (c) SUPERVISION AND COORDINATION.—Each pri-  
17 vacy officer or civil liberties officer described in subsection  
18 (a) or (b) shall—

19 (1) report directly to the head of the depart-  
20 ment, agency, or element concerned; and

21 (2) coordinate their activities with the Inspector  
22 General of such department, agency, or element to  
23 avoid duplication of effort.

1 (d) AGENCY COOPERATION.—The head of each de-  
2 partment, agency, or element shall ensure that each pri-  
3 vacy officer and civil liberties officer—

4 (1) has the information, material, and resources  
5 necessary to fulfill the functions of such officer;

6 (2) is advised of proposed policy changes;

7 (3) is consulted by decision makers; and

8 (4) is given access to material and personnel  
9 the officer determines to be necessary to carry out  
10 the functions of such officer.

11 (e) REPRISAL FOR MAKING COMPLAINT.—No action  
12 constituting a reprisal, or threat of reprisal, for making  
13 a complaint or for disclosing information to a privacy offi-  
14 cer or civil liberties officer described in subsection (a) or  
15 (b), or to the Privacy and Civil Liberties Oversight Board,  
16 that indicates a possible violation of privacy protections  
17 or civil liberties in the administration of the programs and  
18 operations of the Federal Government relating to efforts  
19 to protect the Nation from terrorism shall be taken by  
20 any Federal employee in a position to take such action,  
21 unless the complaint was made or the information was dis-  
22 closed with the knowledge that it was false or with willful  
23 disregard for its truth or falsity.

24 (f) PERIODIC REPORTS.—

1           (1) IN GENERAL.—The privacy officers and civil  
2 liberties officers of each department, agency, or ele-  
3 ment referred to or described in subsection (a) or  
4 (b) shall periodically, but not less than quarterly,  
5 submit a report on the activities of such officers to  
6 Congress, the head of such department, agency, or  
7 element, and the Privacy and Civil Liberties Over-  
8 sight Board, with such reports in unclassified form  
9 to the greatest extent possible and available in a  
10 classified annex where necessary.

11           (2) CONTENTS.—Each report submitted under  
12 paragraph (1) shall include information on the dis-  
13 charge of each of the functions of the officer con-  
14 cerned, including—

15                   (A) information on the number and types  
16 of reviews undertaken;

17                   (B) the type of advice provided and the re-  
18 sponse given to such advice;

19                   (C) the number and nature of the com-  
20 plaints received by the department, agency, or  
21 element concerned for alleged violations; and

22                   (D) a summary of the disposition of such  
23 complaints, the reviews and inquiries conducted,  
24 and the impact of the activities of such officer.

1 (g) INFORMING THE PUBLIC.—Each privacy officer  
2 and civil liberties officer shall—

3 (1) make the reports of such officer, including  
4 reports to Congress, available to the public to the  
5 greatest extent that is consistent with the protection  
6 of classified information and applicable law; and

7 (2) otherwise inform the public of the activities  
8 of such officer, as appropriate and in a manner con-  
9 sistent with the protection of classified information  
10 and applicable law.

11 (h) SAVINGS CLAUSE.—Nothing in this section shall  
12 be construed to limit or otherwise supplant any other au-  
13 thorities or responsibilities provided by law to privacy offi-  
14 cers or civil liberties officers.

14 by and with the advice and consent of the Senate.

15 “(b) SUPERVISION.—The Director of the Central In-  
16 telligence Agency shall report to the National Intelligence  
17 Director regarding the activities of the Director of the  
18 Central Intelligence Agency.

19 “(c) DUTIES.—The Director of the Central Intel-  
20 ligence Agency shall—

21 “(1) serve as the head of the Central Intel-  
22 ligence Agency; and

23 “(2) carry out the responsibilities specified in  
24 subsection (d).

25 “(d) RESPONSIBILITIES.—The Director of the Cen-  
26 tral Intelligence Agency shall—

1           “(1) collect intelligence through human sources  
2           and by other appropriate means, except that the Di-  
3           rector of the Central Intelligence Agency shall have  
4           no police, subpoena, or law enforcement powers or  
5           internal security functions;

6           “(2) correlate and evaluate intelligence related  
7           to the national security and provide appropriate dis-  
8           semination of such intelligence;

9           “(3) provide overall direction for and coordina-  
10          tion of the collection of national intelligence outside  
11          the United States through human sources by ele-  
12          ments of the intelligence community authorized to  
13          undertake such collection and, in coordination with  
14          other departments, agencies, or elements of the  
15          United States Government which are authorized to  
16          undertake such collection, ensure that the most ef-  
17          fective use is made of resources and that appropriate  
18          account is taken of the risks to the United States  
19          and those involved in such collection; and

20          “(4) perform such other functions and duties  
21          pertaining to intelligence relating to the national se-  
22          curity as the President or the National Intelligence  
23          Director may direct.

24          “(e) TERMINATION OF EMPLOYMENT OF CIA EM-  
25          PLOYEES.—(1) Notwithstanding the provisions of any



1 other law, the Director of the Central Intelligence Agency  
2 may, in the discretion of the Director, terminate the em-  
3 ployment of any officer or employee of the Central Intel-  
4 ligence Agency whenever the Director considers the termi-  
5 nation of employment of such officer or employee nec-  
6 essary or advisable in the interests of the United States.

7 “(2) Any termination of employment of an officer or  
8 employee under paragraph (1) shall not affect the right  
9 of the officer or employee to seek or accept employment  
10 in any other department, agency, or element of the United  
11 States Government if declared eligible for such employ-  
12 ment by the Office of Personnel Management.

13 “(f) COORDINATION WITH FOREIGN GOVERN-  
14 MENTS.—Under the direction of the National Intelligence  
15 Director and in a manner consistent with section 207 of  
16 the Foreign Service Act of 1980 (22 U.S.C. 3927), the  
17 Director of the Central Intelligence Agency shall coordi-  
18 nate the relationships between elements of the intelligence  
19 community and the intelligence or security services of for-  
20 eign governments on all matters involving intelligence re-  
21 lated to the national security or involving intelligence ac-  
22 quired through clandestine means.”.

23 (b) TRANSFORMATION OF CENTRAL INTELLIGENCE  
24 AGENCY.—The Director of the Central Intelligence Agen-  
25 cy shall, in accordance with standards developed by the

1 Director in consultation with the National Intelligence

3 (1) enhance the analytic, human intelligence,  
4 and other capabilities of the Central Intelligence  
5 Agency;

6 (2) develop and maintain an effective language  
7 program within the Agency;

8 (3) emphasize the hiring of personnel of diverse  
9 backgrounds for purposes of improving the capabili-  
10 ties of the Agency;

11 (4) establish and maintain effective relation-  
12 ships between human intelligence and signals intel-  
13 ligence within the Agency at the operational level;  
14 and

15 (5) achieve a more effective balance within the  
16 Agency with respect to unilateral operations and liai-  
17 son operations.

18 (c) REPORTS.—(1) Not later than 180 days after the  
19 effective date of this section, and annually thereafter, the  
20 Director of the Central Intelligence Agency shall submit  
21 to the National Intelligence Director and the congressional  
22 intelligence committees a report setting forth the fol-  
23 lowing:

24 (A) A strategy for improving the conduct of  
25 analysis (including strategic analysis) by the Central

1 Intelligence Agency, and the progress of the Agency  
2 in implementing the strategy.

3 (B) A strategy for improving the human intel-  
4 ligence and other capabilities of the Agency, and the  
5 progress of the Agency in implementing the strategy,  
6 including—

7 (i) the recruitment, training, equipping,  
8 and deployment of personnel required to ad-  
9 dress the current and projected threats to the  
10 national security of the United States during  
11 each of the 2-year, 5-year, and 10-year periods  
12 beginning on the date of such report, including  
13 personnel with the backgrounds, education, and  
14 experience necessary for ensuring a human in-  
15 telligence capability adequate for such projected  
16 threats;

17 (ii) the achievement of a proper balance  
18 between unilateral operations and liaison oper-  
19 ations;

20 (iii) the development of language capabili-  
21 ties (including the achievement of high stand-  
22 ards in such capabilities by the use of financial  
23 incentives and other mechanisms);

24 (iv) the sound financial management of the  
25 Directorate of Operations; and

1 (v) the identification of other capabilities  
2 required to address the current and projected  
3 threats to the national security of the United  
4 States during each of the 2-year, 5-year, and  
5 10-year periods beginning on the date of such  
6 report.

7 (C) In conjunction with the Director of the Na-  
8 tional Security Agency, a strategy for achieving inte-  
9 gration between signals and human intelligence ca-  
10 pabilities, and the progress in implementing the  
11 strategy.

12 (D) Metrics and milestones for measuring  
13 progress in the implementation of each such strat-  
14 egy.

15 (2)(A) The information in each report under para-  
16 graph (1) on the element of the strategy referred to in  
17 paragraph (1)(B)(i) shall identify the number and types  
18 of personnel required to implement the strategy during  
19 each period addressed in such report, include a plan for  
20 the recruitment, training, equipping, and deployment of  
21 such personal, and set forth an estimate of the costs of  
22 such activities.

23 (B) If as of the date of a report under paragraph  
24 (1), a proper balance does not exist between unilateral op-

1 erations and liaison operations, such report shall set forth  
2 the steps to be taken to achieve such balance.

3 (C) The information in each report under paragraph

## 17 **Subtitle D—Effective Date**

### 18 **SEC. 341. EFFECTIVE DATE.**

19 (a) IN GENERAL.—Except as provided in subsection  
20 (b), this Act, and the amendments made by this Act, shall  
21 take effect 180 days after the date of the enactment of  
22 this Act.

23 (b) EARLIER EFFECTIVE DATE.—In order to ensure  
24 the rapid implementation of this Act while simultaneously  
25 ensuring a smooth transition that will safeguard the na-

1 tional security of the United States, the President may  
2 provide that this Act (including the amendments made by  
3 this Act), or one or more particular provisions of this Act  
4 (including the amendments made by such provision or pro-  
5 visions), shall take effect on such date that is earlier than  
6 the date otherwise provided under subsection (a) as the  
7 President shall specify.

8 (c) NOTIFICATION OF EFFECTIVE DATES.—If the  
9 President exercises the authority in subsection (b), the  
10 President shall—

11 (1) notify Congress of the exercise of such au-  
12 thority; and

13 (2) publish in the Federal Register notice of the  
14 earlier effective date or dates involved, including  
15 each provision (and amendment) covered by such  
16 earlier effective date.

## 17 **Subtitle E—Other Matters**

### 18 **SEC. 351. SEVERABILITY.**

19 If any provision of this Act, or an amendment made  
20 by this Act, or the application of such provision to any  
21 person or circumstance is held invalid, the remainder of  
22 this Act, or the application of such provision to persons  
23 or circumstances other than those to which such provision  
24 is held invalid, shall not be affected thereby.

1 **SEC. 352. AUTHORIZATION OF APPROPRIATIONS.**

2       There are specifically authorized to be appropriated  
3 for each fiscal year such sums as may be necessary to  
4 carry out this Act and the amendments made by this Act.
