**HELP LOW-INCOME FAMILIES KEEP THEIR HEALTH
INSURANCE FOR THEIR CHILDREN**

Dear Colleague:

We wish to draw your attention to the attached letter, signed by more than 130 consumer and provider organizations, supporting compromise legislation to prevent \$2.7 billion of unspent money from the State Children's Health Insurance Program (SCHIP) from reverting back to the Treasury.

Millions of American families are struggling to maintain their health insurance coverage during these difficult economic times. We should not make matters worse by failing to retain

Dear Representative,

As national organizations committed to children's health care, we believe it is imperative that the 108th Congress act immediately to restore to the State Children's Health Insurance Program (SCHIP) the \$1.2 billion of funds that reverted to the federal treasury at the end of fiscal year 2002 and extend the \$1.5 billion of funds that will revert at the end of the current fiscal year (FY 2003).

It is essential to preserve these funds for SCHIP to help prevent a devastating cut in the number of children receiving their health coverage through the program. A number of states will soon have insufficient federal SCHIP funds available to sustain their current programs and would have no choice but to cut enrollment. According to Office of Management and Budget data released last year, the result of these shortfalls will be a substantial reduction in SCHIP enrollment of 900,000 children between fiscal years 2003 to 2006. Analysis of the latest data from the states shows that 20 states will face federal funding shortfalls over the next several years.

In the final days of the 107th Congress, Chairman Tauzin and Ranking Member Dingell of the House Energy and Commerce Committee and then-Chairman Baucus and Ranking Member Grassley of the Senate Finance Committee developed a bipartisan consensus proposal to keep the SCHIP funds from expiring, but Congress failed to pass the measure before adjourning. We urge you to work with the House and Senate Leadership to enact this proposal expeditiously. It is the first step necessary to prevent the looming health coverage crisis that will result from insufficient federal funding of the SCHIP program.

We cannot emphasize enough the importance of this issue given the remarkable gains in enrollment of uninsured children in SCHIP – in fiscal year 2001, 4.6 million children were covered by SCHIP. We must not let these gains in insuring uninsured children be compromised by allowing \$2.7 billion in federal SCHIP funds to expire and be lost to the program.

We note that while the Tauzin/Dingell/Baucus/Grassley proposal is an essential first step in ensuring that states and uninsured children have adequate federal funding for the SCHIP program, we also urge you to support more comprehensive long-term legislation that not only increases federal SCHIP funding but also efficiently targets SCHIP funds to the states (and children) that most need them. Such legislation includes the Children's Health Improvement and Protection Act of 2002 (S. 2860), introduced by Senators Rockefeller, Chafee, Kennedy, and Hatch in the 107th Congress. That legislation represents the logical next step in ensuring that SCHIP coverage will not be dropped for nearly a million children.

We look forward to working with the Congress to quickly preserve these essential funds for the millions of children who would otherwise be uninsured without the SCHIP program. For more information, please feel free to contact Edwin Park at the Center on
