Section 1 – OVERVIEW

1.1 Introduction

During recent years the Federal Government has placed increased importance on acquisition reform, managing for results and accountability, and workforce restructuring and de-layering. The Department of Commerce (DOC) continues to embrace these concepts by developing and implementing programs, policies and guidance that assist DOC in making progress in areas such as performance management, human capital restructuring, and acquisition reform. The delegation of contracting authority within the DOC is designed to align authority with function, responsibility, and accountability by delegating contracting authority to the lowest level possible, empowering individuals to make decisions while ensuring accountability for results. Commerce Acquisition Manual (CAM) Chapter, 1301.70, identifies the various delegations of contracting authority that are initially set forth in the Federal Acquisition Regulation (FAR) and establishes the level of authority within the DOC.

1.2 Purpose

Department Administrative Order (DAO) 208-2, Contracting Authority, establishes clear lines of contracting authority and accountability as required by Executive Order 12931, Federal Procurement Reform, Public Law 98-191, Office of Federal Procurement Policy Act, 41 U.S.C. 414, and Public Law 108-136, Services Acquisition Reform Act of 2003. DAO 208-2 provides delegations of contracting authority at the highest levels within DOC. CAM 1301.70 is intended to further identify DOC delegations of contracting authority by providing specific delegations that correspond directly to the various contracting delegations outlined in the FAR.

1.3 Definitions

Chief Acquisition Officer (CAO) – The Department's Executive-level non-career employee designated pursuant to the <u>Services Acquisition Reform Act</u> to advise and assist the head of the agency and other agency officials to ensure the mission of the agency is achieved through the management of the agency's acquisition activities. The Chief Financial Officer and Assistant Secretary for Administration has been designated by the Head of the Agency as the Chief Acquisition Officer for the Department of Commerce.

Contracting Activity – The operating units identified in paragraph 2.08 of <u>DAO 208-2</u> and those identified within this document under the definition of Operating Unit. Contracting activities may or may not have authority to operate contracting offices (see paragraphs 2.10 and 4.04 of <u>DAO 208-2</u>).

Contracting Office - An office that has the authority to award or execute contracts for supplies or services and performs post-award functions (see paragraphs 2.10 and 4.04 of <u>DAO 208-2</u>).

Contracting Officer (CO) –Individuals designated authority by the Senior Bureau Procurement Official (BPO) to enter into, administer, and/or terminate contracts and to make related determinations and findings. Only those individuals who have been certified as contracting officers, through the issuance of a Certificate of Appointment (Contracting Officer Warrant (SF1402)), by the BPO in accordance with the requirements and procedures of the Commerce Acquisition Regulation (CAR) and the CAM may exercise the authorities of contracting officers. However, by virtue of their positions, the Head of the Agency, the Procurement Executive, and the Heads of Operating Units identified in paragraph 4.04 of DAO 208-2 are also designated as contracting officers

Head of Agency (or Agency Head) (HA) – The Secretary of Commerce, except pursuant to Department Organization Order (DOO) 10-5, Chief Financial Officer and Assistant Secretary for Administration, for Procurement matters the head of the agency shall be the Chief Financial Officer and Assistant Secretary for Administration (CFO/ASA), unless a statute provides that the authority of the Secretary is non-delegable.

Head of Contracting Activity (HCA) – For purposes of delegation of contracting authority officials who are designated as Heads of Operating Units (those who are assigned by the President or by the Secretary to manage the primary or constituent operating units of the DOC (as defined in DAO 1-1, Mission and Organization of the Department of Commerce), in orders establishing the respective operating units, and paragraph 2.08 of DAO 208-2, with the exception of the Office of the Secretary, are designated as the HCA for procurements initiated in support of the procurement activities of that operating unit. DAO 208-2 designated the Chief Financial Officer and Assistant Secretary for Administration as the HCA for procurements initiated in support of the programs and activities of the Office of the Secretary and all other Secretarial Offices and Departmental Offices.

Head of Contracting Office (HCO) – Individuals designated by the BPO to head the contracting offices within each operating unit that has designated contracting authority to award and administer contracts to the full limit of the Department's contracting authority. The HCO must be a procurement professional in the GS-1102 (or equivalent OPM occupational designation) occupational series. BPOs will issue each HCO a Contracting Officer Warrant which delegates the authority to enter into, administer, and/or terminate contracts and to make related determinations and findings.

Procurement Executive (or Senior Procurement Executive) (PE) - The official appointed pursuant to <u>Executive Order 12931</u> and the <u>Executive Order 12931</u> and the <u>Executive Order and the Services Acquisition Reform Act.</u> Pursuant to <u>DOO 20-26, Director for Acquisition Management, the Director for Acquisition Management is the Procurement Executive for the DOC.</u>

Operating Unit – The following entities are considered operating units, as defined in DOO 1-1, and in the Orders establishing the respective operating unit: Bureau of Economic Analysis (BEA), Bureau of the Census (Census), <a href="Economic Economic Econom


Senior Bureau Procurement Official (BPO) - The senior career procurement official, within each operating unit that has been delegated contracting authority, is designated as the Senior Bureau Procurement Official. The BPO must be a procurement professional who has both experience and training in the area of federal procurement and contracting. HCA's may designate one BPO within their organization to carry out the day-to-day functions of managing the contracting activity. BPOs may also serve as the Head of Contracting Office. The PE will issue each BPO a Contracting Officer Warrant which delegates the authority to enter into, administer, and/or terminate contracts and to make related determinations and findings.

1.4 Applicability

The Secretary has delegated the authority of "Head of Agency" under the authorities in 41 U.S.C. Chapter 4, and 48 Code of Federal Regulation (CFR) Chapter 1, regarding purchases and contracts for property or services, and other procurement related authorities to the Chief Acquisition Officer who is the CFO/ASA. The Chief Acquisition Officer has further delegated to the Director for Acquisition Management the authority to serve as the Procurement Executive (in accordance with Executive Order 12931, the Office of Federal Procurement Policy Act, 41 U.S.C. 414, and the Services Acquisition Reform Act, to establish clear lines of contracting authority and accountability, and to implement acquisition-related requirements for the Competition in Contracting Act (P.L. 98-369); Executive Order 12931, Federal Procurement Reform, dated October 13, 1994; the Government Performance and Results Act of 1993; the Federal Acquisition Streamlining Act of 1994 (P.L. 103-355); the Clinger-Cohen Act 1996 (P.L. 104-106), and the Services Acquisition Reform Act of 2003 (P.L. 108-136); and other statutory regulatory and administrative directives, with the authority to redeligate to appropriate officials.

The authority delegated or redelgated is to be exercised in conformity with federal acquisition laws and regulations, Department polices, and conditions or limitations that are established by the Secretary, the Deputy Secretary, the Chief Acquisition Officer or the Procurement Executive. Figure 1-1 depicts the flow of contracting authority within the DOC.

Delegations of authority specifically outlined in the <u>FAR</u> are further defined in this CAM Chapter for the Department by the Procurement Executive.

Section 2 -DELEGATIONS OF AUTHORITY

2.1 Contracting Authority

The following delegations of contracting authority have been established by DAO 208-2:

Secretary of Commerce - The Secretary has delegated the authority of Agency Head to the CFO/ASA under the authorities of <u>41 U.S.C. Chapter 4</u>, and <u>48 CFR Chapter 1</u>, unless a statute provides that the authority of the Secretary is nondelegable. Specific authorities that cannot be delegated and remain with the Secretary are set forth in CAM 1301. 70, Section 2.2, Functional Delegations.

Chief Financial Officer and Assistant Secretary for Administration (Chief Acquisition Officer) -

- a. Pursuant to <u>DOO 10-5</u>, the Secretary has delegated to the Chief Acquisition Officer the authorities specified in the Code of Federal Regulations regarding purchases and contracts for property or services, and other procurement related authorities of the Secretary.
- b. Specific contracting authorities are delegated in CAM 1301.70, Section 2.2, Functional Delegations. Authorities that are specifically delegated to the Chief Acquisition Officer which are identified as non-delegable must be performed by that individual. They may not be redelegated.

Director for Acquisition Management (Procurement Executive) -

- a. Pursuant to <u>DOO 10-5</u> and <u>DOO 20-26</u>, the Chief Acquisition Officer has delegated to the Director for Acquisition Management the authority to serve as the Procurement Executive. As the Procurement Executive, the Director for Acquisition Management is delegated Department wide responsibility for, planning, developing and implementing policies and procedures for the acquisition of materials, supplies, equipment and services through procurement and contracting processes, and for operation of a contracting office for the Office of the Secretary and other elements of the Department.
- b. The authority to establish contracting activities and delegate broad contracting authority to HCA's lies with the Procurement Executive.
- c. Specific contracting authorities are delegated in CAM 1301.70, Section 2.2, Functional Delegations. Authorities that are specifically delegated to the Procurement Executive which are identified as non-delegable must be performed by that individual. They may not be re-delegated.
- d. The PE will issue each BPO a Contracting Officer Warrant which delegates the authority to enter into, administer, and/or terminate contracts and to make related determinations and findings.

Heads of Operating Units -

- a. The heads of the following operating units are authorized to operate contracting offices, as currently exist in those operating units:
- 1. NOAA, pursuant to DOO 25-5, National Oceanic and Atmospheric Administration;
- 2. NIST, pursuant to DOO 30-2B, National Institute of Standards and Technology;
- 3. PTO, pursuant to DOO 30-3, Patent and Trademark Office; and
- 4. Census, pursuant to DOO 35-2B, Bureau of the Census.
- b. Heads of operating units are not authorized to establish new contracting offices. Only the Procurement Executive can authorize establishment of new contracting offices.

Heads of Contracting Activities -

- a. HCAs have overall responsibility and accountability for procurements initiated in support of the programs and activities of their organizations, and specifically, for the contracting decisions required to be made by them in their capacity as HCA, or by those in their organizations having delegated authority for contract decision making.
- b. Specific contracting authorities are delegated in CAM 1301.70, Section 2.2, Functional Delegations. Authorities that are specifically delegated to HCAs which are identified as non-delegable must be performed by those individuals. They may not be re-delegated.
- c. The HCAs in operating units not having contracting offices (see paragraphs 2.10 and 4.04 of <u>DAO 208-2</u>) may delegate those authorities specified in CAM 1301.70, which can be performed below the level of the HCA, to individuals in the operating unit that provides their procurement service. Such delegations must be by mutual agreement of the parties. The individuals performing such delegated functions must be at appropriate levels in the servicing organization, as specified in <u>DAO 208-2</u> paragraph 2.04, paragraph 4.05 and in this paragraph of CAM 1301.70.
- d. Delegations made pursuant to paragraph c above must be in writing designating the specific organizational position receiving the delegation.

Bureau Senior Procurement Official -

a. HCAs may delegate authority to carry out the day-to-day functions of managing the organization's contracting activity to the BPO.

- b. Specific contracting authorities are delegated in CAM 1301.70, Section 2.2, Functional Delegations. Authorities that are specifically delegated to BPOs which are identified as nondelegable must be performed by those individuals. They may not be re-delegated.
- c. BPOs will issue each HCO a Contracting Officer warrant which delegates the authority to enter into, administer, and/or terminate contracts and to make related determinations and findings.
- d. BPOs will issue Contracting Officer warrants to qualified individuals within their respective operating units.

Heads of Contracting Office – Specific contracting authorities are delegated in CAM 1301.70, Section 2.2, Functional Delegations. Authorities that are specifically delegated to HCOs which are identified as non-delegable must be performed by those individuals. They may not be redelegated.

Contracting Officer - Specific contracting authorities are delegated in CAM 1301.70, Section 2.2, Functional Delegations. Authorities that are specifically delegated to COs are non-delegable and must be performed by those individuals.

Miscellaneous Delegations – CAM 1301.70, Section 2.2, Functional Delegations identifies authorities that have been delegated to individuals other than those named in paragraphs 4.01 through 4.06 of <u>DAO 208-2</u>.

Government Purchase Card - Delegations of authority to make purchases with the Government Purchase Card are made to individual employees by the HCO who services the respective employee's organization. Procedures governing the Purchase Card Program are set forth in CAM Part 1313.301, Commerce Purchase Card Procedures.

Non-Appropriated Funds – Authority to obligate non-appropriated funds is delegated by the Procurement Executive to the BPO. The BPO may further delegate the authority to obligate non-appropriated funds no lower than the HCO. Although such contracts are not subject to the FAR, they remain subject to legal review and other applicable regulations and statutes such as the Competition in Contracting Act.

2.2 Functional Delegations

Throughout the FAR various functional delegations of authority are identified. Appendix A, DOC Functional Delegation Matrix, sets forth the <u>FAR</u> functional delegations and the corresponding designation within the DOC.
