

ATR: AGGREGATE DATA PROFILE

Data through Sept 30, 2006

This data profile describes how the Access to Recovery (ATR) Program is meeting its objectives of expanding client choice, improving access to clinical treatment and recovery support services, and increasing substance abuse treatment capacity. Note that these data are preliminary. They represent client demographics and outcomes only for the first waves of data reported by the ATR grantees. Future program results may vary. All data were reported by ATR grantees through the Services Accountability Improvement System (SAIS).

Clients Served through 9/30/06

- ATR has already served **117,616** of the **125,000** clients expected to be served over 3 years.
- Sixty-eight percent (68%) of clients served are Males. Thirty-two percent (32%) are Females.
- Race distribution: about 59% of clients are White; 33% of clients are African American; 6.2% are American Indian/Alaska Natives; and approximately 1% are Asian/Pacific Islanders. In terms of ethnicity, about 12% of clients reported being Hispanic.
- The majority (53.8%) of clients served are between the ages of 25 and 44; about 27% of clients are 24 and under; 16% are between 45 and 54; about 3% of clients are over 55.

SERVICES AND VOUCHER DATA

- Over **64%** of the clients for whom status and discharge data are available have received Recovery Support Services.
- Vouchers in the amount of **\$118,105,210** have been redeemed for Clinical or Recovery Support services.
- Of these, **50%** of the dollars paid have been for Recovery Support services.
- About **29%** of the dollars paid for Recovery Support and Clinical Services have been to faith-based organizations.
- Faith-based providers account for **22%** of all Recovery Support providers and **29%** of all Clinical Treatment providers with a voucher redemption in the SAIS.

Update

64% of clients have received Recovery Support Services

50% of dollars paid have been for Recovery Support Services

29% of dollars paid have been to faith-based organizations

Faith-based organizations account for 22% of Recovery Support and 29% of Clinical Treatment providers

PRELIMINARY TREATMENT OUTCOMES

Intake to Discharge Data

ATR outcome data reflect changes over time from intake to discharge from services. Through Sept. 30, 2006, ATR grantees have collected discharge data on 65,654 clients.

These data are uploaded quarterly and the next upload to SAMHSA is January 31, 2007 covering data ending December 31, 2006.

65.2% were abstinent

22.5% were housed

27% were employed

60% were socially connected

81.3% were not involved with the criminal justice system

- Of those clients who reported using substances at intake into ATR, **65.2%** were abstinent from substance use at discharge.

- Of those clients who reported not having stable housing at intake to ATR, **22.5%** reported being stably housed at discharge.

- Of those clients who were unemployed at intake to ATR, **27%** reported being employed at discharge.

- Of those clients who reported not being socially connected at intake to ATR, **60%** were socially connected (attended self help groups or had someone to whom to turn in times of trouble) by discharge.

- Of those clients who were involved with the criminal justice system at intake to ATR, **81.3%** reported no involvement at discharge.
