

### NEW I&E COMMITTEE MEMBER BRINGS VALUABLE EXPERIENCE TO THE IG COMMUNITY



On December 26, 2007, Todd J. Zinsel was sworn in as the fifth Inspector General of the

U.S. Department of Commerce. Mr. Zinsel brings a wealth of experience to his position, spending the majority of his 24-year career in public service as a member of the Inspector General community. Mr. Zinsel began his Government career in 1983 as an investigator for the U.S. Department of Labor. He joined the Department of Transportation in 1991, serving as special-agent-in-charge of OIG's New York regional Office of Investigations, and worked his way up the ladder to become Deputy Inspector General in 2001. Mr. Zinsel has received numerous awards for superior performance and leadership throughout his career, including the Secretary of Transportation's 9-11 Medal and two Gold Medals—the first for

his work with the Department's Hurricane Katrina Task Force and the second for his involvement in Transportation's response to the collapse of the I-35W bridge in Minneapolis in 2007. He was recently awarded the Transportation IG's Bronze Medal for superior achievement as Deputy Inspector General. Mr. Zinsel holds a bachelor's degree in Political Science from Northern Kentucky University and a master's degree in Political Science from Miami University, Oxford, Ohio. He has also completed the Senior Managers in Government program at Harvard's John F. Kennedy School of Government. We welcome Mr. Zinsel to the Department of Commerce and look forward to benefiting from his extensive experience through his membership on the I & E Committee.

## **TRAINING WORK GROUP HOLDS 1<sup>st</sup> MEETING**
