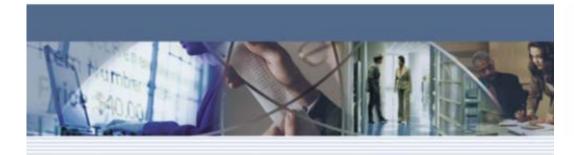

■ IAE Updates

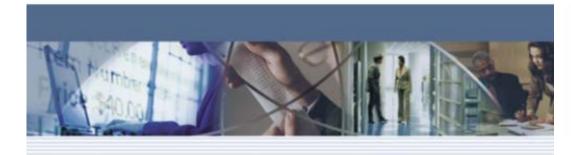
By January 2006, stats on the IAE systems increased significantly and continue to grow.

- 403,000 vendors in CCR
- 42,360 representations and certifications in ORCA
- 3,793,095 federal civilian contract actions submitted to FPDS-NG in 2004; 1,585,082 in 2005 YTD
- EPLS averaging 1.6 million hits per month
- 116,000 active procurement documents posted on FBO

ACQUISITION REQUIREMENTS TEAM

Since March, 2005 the Acquisition Requirements Team (ART) has been working on developing a set of mandatory government-wide system requirements that all commercial acquisition/contract writing COTS packages will have to satisfy in order to qualify for Federal agency use, including interfaces with finance systems. The team also surveyed relevant vendors in order to gather information that can be used to classify available products in terms of their general architecture and existing technical capabilities. The ART work culminated in the Jan 6, 2006 pre-public release of an initial "Internal Draft of the Acquisition System Requirements" for CAOC and CFOC comments. Once comments have been vetted, an exposure draft will be released to the public for comment.







IAE PERFORMANCE TEAM

The IAE Performance team was formed to redesign the process of collecting and sharing contractor performance data. In January 2006, the team completed draft guidelines entitled "Contractor Performance in the Acquisition Process." The guide is designed to help agencies know their role in addressing and using contractor performance information. It addresses the types of performance information which exists. resources for finding the data, and standards to employ. It discusses best use of performance data throughout the acquisition process, from the pre-award and planning phase, through source selection and into contract evaluation. A FAR change has also been drafted

EPLS

In December, GSA awarded Information Sciences Corporation of Silver Spring, MD the contract to develop, operate, enhance, support, manage and run the new Excluded Parties List System (EPLS). The \$5.9 million contract has a base period of two years with the potential of earning three oneyear options and will be managed by the Office of the Chief Acquisition Officer's IAE Project Team. The new EPLS will provide enhanced searching, reporting and downloading capabilities with additional features and functionalities as expressed by the user community. Primary among these will be making Dun & Bradstreet numbers (DUNS) mandatory to facilitate searches and allow interface with the CCR.

TIN

On October 30, 2005, CCR began validating the Taxpayer Identification Number and Taxpayer Name (TIN) of each new and updating CCR registrant with the Internal Revenue Service (IRS) records in order to improve data accuracy in the federal procurement system. Registrants must indicate consent at the time of registration.

The Civilian Agency Acquisition Council and the Defense Acquisition Regulations Council have proposed to amend the FAR Regulations to include the validation of the TIN with the IRS. Comments from the public were invited per FAR Case 2005-007 in the Federal Register on October 19, 2005.

ESRS

On October 28, 2005 SBA and IAE announced the launch of eSRS (Electronic Subcontracting Reporting System), a new system to streamline reporting of small business subcontracting activity on large federal prime contracts. This web-based tool provides agencies with immediate access to analytical data on subcontracting performance. The eSRS eliminates submission of paper SF 294s and 295s, Individual Subcontracting Reports, and Summary Subcontracting Reports, and replaces them with electronic versions. Contractors no longer have to enter and compute data manually and distribute multiple paper reports to agencies. Contract data must first be entered accurately into FPDS-NG in order to process subcontracting reports through eSRS. All civilian federal agencies, contracting officers, prime contractors, and large subcontractors can register at www.esrs.gov and begin using eSRS. Register for weekly web training

GOALING REPORT

Robert Burton, Associate Administrator, OMB Office of Federal Procurement Policy issued a memorandum to the federal acquisition community on October 27, 2005 stating that they are no longer required to submit small business procurement data manually to SBA. This is in response to FPDS-NG's successful delivery of the Small Business Goaling Report for FY 2004. Next year's FY2005 report will be based solely on the data pulled from FPDS-NG.

HURRICANE KATRINA'S IMPACT

The Fall 2005 GSA Acquisition Workforce Forum featured the article "Hurricane Katrina's Impact on IAE Systems" on page 2. You can access the article at: http://acquisition.gov/articles.cfm. FPDS-NG posted a daily file of hurricane support contracts within a few weeks of Katrina. Following Hurricanes Rita and Wilma, the need to identify to which disaster contract actions were applied became obvious. FPDS-NG responded by incorporating a new field to flag and identify contracts for such special efforts.

IGTE

Effective July 31, 2005, the Office of Management and Budget terminated the Intragovernmental Transaction Exchange (IGTE) system. The system had been utilized by several agencies to conduct transactions for payment of both rent and IT services. Those agencies reverted back to entering intra-governmental buy/sell transactions directly into IPAC. The Chief Financial Officers (CFO) Council created a

sub-committee for intragovernmental transactions, under the Financial Statement Acceleration Committee, chaired by Mary Sally Matiella. The committee has the responsibility for determining what changes to Business Rules, IPAC or other requirements, may improve the intragovernmental process. The FedReg, or Federal Agency Registration System (https://www.bpn.gov/far), will continue to operate.
