**SUBJECT:** Reporting Race and Ethnicity in the 2008 Ryan White HIV/AIDS Program Annual Data Report

In order to comply with Office of Management and Budget (OMB) regulations, all Ryan White-funded agencies will be required to report race and ethnicity data separately in the 2008 Ryan White Data Report (RDR).

Agencies should report the number of unduplicated clients by racial category and by ethnicity, based on the self-report of the client. All clients who identify with more than one race should be included in the "More than one race" category and in either the Hispanic or Non-Hispanic column or table. If clients report race, but not ethnicity, report them in the appropriate race category in the Non-Hispanic column or table. If clients report ethnicity, but not race, report them in the "Not reported" race category in the appropriate Hispanic or Non-Hispanic column or table. Clients who do not report race or ethnicity should be included in the "Not reported" race category and in the Non-Hispanic column or table. Do not include any anonymous individuals in these counts.

Providers should adjust their data collection systems to collect these data beginning January 1, 2008. Data will be reported in a format similar to the below chart. For example, the race and ethnicity of HIV-positive/indeterminate clients will be reported in Item 58 of the RDR as:
