## Net Enabled Command Capability (NECC)



DoD's future principal command control information technology to enable decision superiority via advanced collaborative information sharing achieved through vertical and horizontal interoperability.

Seeking Milestone B, follow FY09 Capability Module (CM) Release Plan (12 CMs)

## DISA's NECC Component Program Management Office (NECC CPMO)



Facilitate the transition of DISA capabilities to NECC through the Capability Modules (CM) including development, T&E, certification and accreditation to deliver capabilities against the NECC service oriented architecture.

CFAST v6.0 (HW and SW refresh, increase performance, minor architecture changes, upgrade COTS products)

## Global Command and Control System – Joint (GCCS-J)



DoD's premier joint command and control system of record, providing joint warfighter with an integrated picture of the battlespace through all stages of military operations.

GCCS-J v4.2 (JOPES / SORTS / Global) Sustainment

## Global Combat Support Systems (GCSS (CC/JTF))



Provides end-to-end information interoperability across combat support and command and control functions.

Increment 7 MS C; NIPRNet v7.0 and SIPRNet v7.0.0

## Multi National Information Sharing (MNIS)



Provides standard community of interest services and applications for future GIG EIE to facilitate collaboration among DoD components and foreign nations.
