# Installation Summaries from the FY 2000 Survey of Threatened and Endangered Species on Army Lands

Jason M. Bak, Steven Sekscienski, and Bill Woodson

The Army's Environmental Quality Report (EQR) is one of the means by which installations report annually to Army Headquarters (HQDA) on a variety of natural resource and environmental issues. This report (part of a continuing series) summarizes data from a variety of sources including the Threatened and Endangered Species portion of the FY 2000 EQR. Installation-level data provides information on species that occur on or contiguous to each installation, while species-level data lists all installations on which each species occurs. Corresponding information on Federal status, critical habitat, informal consultations with the U.S. Fish and Wildlife Service (USFWS), and Biological Opinions rendered by USFWS are provided.



### **1 Executive Summary**

The Army has 170 distinct Threatened, Endangered, and proposed Threatened/Endangered species on 94 installations. Figure 1 shows the breakdown by category of the onsite<sup>1</sup> Federally Threatened and Endangered species (T&E) for FY 2000. The Army has 12 installations with designated critical habitat occurring for one or more species. By the end of FY 2000, the Army had completed 30 Threatened and/or Endangered Species Management Plans.





Figure 2. Reportable T&E Expenditures from FY 1990-2000.

In FY 2000, the Army spent over \$20 million dollars on Threatened and Endangered species management. This figure includes Endangered Species Act (ESA) reportable expenses<sup>2</sup> of \$17.4 million dollars, including both onsite and contiguous<sup>3</sup> species. In addition, \$3.1 million dollars was spent on non-reportable expenses<sup>4</sup> for onsite and contiguous species. These monetary figures do not include millions of dollars that are expended by military operations for work-arounds and avoidance. Figure 2 shows reportable expenses from FY 1990-2000. Table 1 shows the top ten species, in terms of expenditures, for FY 2000.

## **2** Introduction

### Background

The Army's primary mission is to provide national defense. However, as a Federal agency, the Army is also required by the Endangered Species Act to conserve the Threatened and Endangered species that occur on the same lands where it conducts the training of soldiers and testing of weapons. Regular data collection efforts provide the Army with information that it needs to monitor and manage Federally Threatened, Endangered, proposed, and Candidate species (TES) and their habitats (Refer to Section 5 for an expanded definition of the acronyms). Each year, installations are asked to provide Army Headquarters (HQDA) with a list of TES occurring within their boundaries and on surrounding lands, and respond to a series of questions about those species. This information gives the Army the ability to assess the status of its' TES nationwide, to plan for expenditures related to TES, and to deal proactively with any potential conflicts between TES and the military mission (Shaw and Hill 1996, Schreiber et al. 1997, Shaw et al. 1998).

### Objective

The objective of this project was to analyze and report TES information from the FY 2000 Environmental Quality Report (EQR) and other available data sources. This data will help the Army plan how to best comply with its obligations under the Endangered Species Act (ESA) while carrying out its military mission.

### Approach

Threatened and Endangered Species data are now extracted from the EQR, which contains questions on a broad range of environmental and natural resource issues, including TES. Questions on TES included Federal status, presence of critical habitat, number of informal consultations and Biological Opinions, and total expenditures for each species on the installation. Information is also collected on the status of an installation's Endangered Species Management Plan (ESMP) and Planning Level Survey (PLS), covering all species on the installation.

### Scope

The intended scope of the EQR encompasses all Army installations with onsite or contiguous species that were listed in the Federal Register in late FY 2000 as having Threatened, Endangered, Proposed Threatened, Proposed Endangered, or Candidate status. As in previous survey years, several installations did not respond to the survey and therefore had to be contacted to obtain data. For practical purposes, the survey represents a complete census of Army installations with TES.

## 3 Changes From the FY 1998 TES Survey

The last published report documented conservation data collected during FY 1998, no report was produced for FY 1999. This report focuses on conservation data for FY 2000, but includes tables that provide updates from the FY 1999 data collection.

#### **Species That Have Changed Federal Status**

Tables 2 and 3 provide updates to installation species' Federal status from FY 1998-1999 and FY 1999-2000, respectively. Over the two-year period, five species were reported as having an updated status, either proposed to listed or proposed to withdrawn from listing consideration.

#### **New Species Reported**

Tables 4 and 5 reflect species that were reported by installations for the first time in FY 1999 or FY 2000, respectively. Nineteen species were added since the FY 1998 published report. The breakdown by category includes: 6 plants, 4 invertebrates, 2 amphibians, 2 fish, 2 mammals, 1 bird, 1 clam, and 1 snail.

### **4** Summary Information

#### Installation and Species Information

Information was collected from a total of 124 installations for the FY 2000 reporting period that have either onsite or contiguous TES. Of those responding, 99 installations (80%) reported onsite TES and 25 installations (20%) reported only having contiguous TES.

Of the 220 distinct species, 75% are Endangered, 19% are Threatened, 4% are Candidates, 1% are Threatened due to similarity of appearance or proposed Threatened (Table 8). By category, 51% of the distinct species are plants, 16% are birds, 7% are mammals, 6% are reptiles, 5% are invertebrates, 5% are snails, 4% are clams, 4% are fish, and 2% are amphibians (Table 8).

The 124 installations with onsite or contiguous TES include: 55 Army National Guard, 22 Army Materiel Command, 14 Training and Doctrine Command, 12 Forces Command, 7 U.S. Army Reserve Command, 6 U.S. Army, Pacific, 2 Military District of Washington, 2 Medical Command, 1 Army Testing and Evaluation Center, 1 Military Traffic Management Command, 1 U.S. Army South, and 1 U.S. Military Academy.

#### **T&E Species**

A total of 209 distinct T&E species (407 occurrences) were identified on 118 of the 124 installations that reported having onsite or contiguous TES. Of the 118 installations, 94 reported having onsite T&E. The remaining 24 installations reported having only contiguous T&E species. Of the 209 distinct T&E species, 170 species occurred onsite and the remaining 39 species were reported as being contiguous., to at least one installation and not onsite at any installation (Table 9).

#### **Proposed and Candidate Species**

A total of 11 distinct proposed/Candidate species were identified from the 124 installations that reported having onsite or contiguous TES. Six installations reported having only proposed and/or Candidate species on or contiguous to their installation. Of the 11 distinct proposed/Candidate species identified on Army lands, 10 occurred within at least one installation's boundary. The remaining one was reported as being contiguous to at least one installation and not onsite at any installation (Table 10).

#### **Critical Habitat**

The USFWS has designated critical habitat for 135 species, 11 of those species have designations occurring on 12 Army installations (Table 11). Of the 14 occurrences, 6 of the critical habitat designations are on reported unoccupied habitat.

#### **Consultations and Biological Opinions**

Installations reported a total of 284 informal and 43 formal consultations with the USFWS/NMFS in FY 2000. Of the 52 Biological Opinions rendered, 26 (46%) resulted in a Non-Jeopardy Biological Opinion and the remaining 26 (46%) Biological Opinions resulted in a No Opinion Rendered. No Jeopardy Biological Opinions were reported in FY 2000.

#### **Endangered Species Management Plans**

Each installation is required to prepare an Endangered Species Management Plan (ESMP) for listed and proposed species. Of the 94 installations reporting onsite T&E, 30 have current and approved ESMPs; 35 have partially complete ( $\geq$ 60%); 6 have partially complete (<60%), and 1 installation reported they have not yet initiated an ESMP. In addition, 16 installations reported they did not require an ESMP and 11 installations did not report the status of their ESMP. Of the 25 installations reporting only contiguous T&E, 2 have current and approved ESMPs; 1 has a partially complete ( $\geq$ 60%); 2 have partially complete (<60%) ESMPs, and 2 installations reported they have not yet initiated an ESMP. In addition, 14 installations do not require an ESMP and 4 installations did not report the status of their ESMP.

#### **Planning Level Surveys**

Each installation is also required to prepare a T&E Planning Level Survey (PLS) to provide natural resource managers the basis to develop plans for continued training and mission requirements, and to meet stewardship goals. Of the 94 installations reporting onsite T&E, 67 have a completed T&E PLS, 7 have a partially completed T&E PLS ( $\geq$ 85%), 12 have a partially completed T&E PLS ( $\geq$ 50%-<85%), and 3 have a partially completed T&E PLS ( $\geq$ 0-50%). Of the remaining 10 installations, 1 has not initiated the PLS and 9 did not report the status of the T&E PLS. Of the 25 installations reporting contiguous T&E, 10 have a completed T&E PLS, 3 have a partially completed PLS ( $\geq$ 0-50%). #### **Expenditures**

T&E expenditures are broken down into reportable and non-reportable expenditures. Reportable expenditures include money spent primarily for the conservation of T&E species pursuant to the Endangered Species Act. Non-reportable expenditures are monies spent on multi-species projects, proposed Threatened, proposed Endangered, Candidate, State listed, and any other species of concern. These expenses are typically incurred to prevent listing.

In reportable expenditures, a total of \$17,388K was spent for onsite T&E in FY 2000. By category, expenditures for onsite T&E include: \$11,102K for birds, \$2,673K for plants, \$1,389K for mammals, \$1,332 for reptiles, \$333K for invertebrates, \$172K for snails, and \$98K for fish. An additional \$134K was spent on contiguous T&E in FY 2000. The breakdown by category includes, \$92K for birds and \$42K for mammals. Table 12 provides a summary of Army reportable expenses from FY1996-FY2000.

An additional \$3,149K was also spent in non-reportable expenditures, for managing all other sensitive species not covered in the species-specific expenditures question. By MACOM, TRADOC spent \$1,386K on non-reportable species, MEDCOM spent \$700K, FORSCOM spent \$420K, ARNG spent \$373K, ATEC spent \$144K, AMC spent \$74K, USARC spent \$24K, MDW spent \$23K, and USMA spent \$6K. These expenditures are not an inclusive list as other unreported projects may include money for species management.

#### **Consistent Reporting**

The Army is frequently asked for information on Threatened and Endangered species. However, often the requestor does not realize the intricacy of the data in that there are multiple answers to the question, "How many Threatened and Endangered species are on Army lands?" For future consistency, the number provided (unless other data are specifically requested) will be distinct T&E onsite<sup>5</sup>. Table 13 shows these numbers for FY 1996 through FY 2000.

### **5** Definitions

**Biological Opinion** – The document that states the opinion of the U. S. Fish and Wildlife Service (USFWS)/ National Marine Fisheries Service (NMFS) as to whether or not a Federal agency's proposed action is likely to jeopardize the continued existence of a listed species or result in the destruction or adverse modification of critical habitat.

**Category** – Species are divided into the following categories in this report:

mammals
plants
reptiles
snails

**Critical Habitat** – An area determined by the USFWS/ NMFS to be critical to the survival of a species. Under certain circumstances, critical habitat may be designated in an area deemed favorable for the species, but where the species is not known to occur. Only a small number of the species with critical habitat actually have such habitat designated on Army installations.

**Distinct Species** – A species may occur on several installations, but is only counted once for purposes of assessing the number of distinct species found Army-wide. For example, species X may occur on five installations, but when the total number of species is presented, species X is only counted once.

**ESMP** – Endangered Species Management Plan. A plan developed in accordance with Army Regulation (AR) 200-3, Chapter 11, for the management of listed or proposed species or critical habitat.

**Expenditures** – The total cost for managing each Federally listed Threatened or Endangered species for which funds were expended during the reporting fiscal year. Guidelines for reporting TES expenditures are provided by the USFWS. Guidance is based on the notion of "reasonably identifiable Federal Expenditures made primarily for the conservation of Endangered and Threatened species pursuant to this [Threatened and Endangered Species] Act."

#### **Federal Status**

- E Federally Endangered
- T Federally Threatened
- PE Federally Proposed as Endangered
- PT Federally Proposed as Threatened
- C Candidate for Federal Listing
- C(w) Candidate species whose listing is "warranted but precluded" by other listing activity in the past year. No distinction is made between C and C(w) for reporting purposes.

**Federal Action [Proposed Action]** – Any activity permitted, funded, or conducted by a Federal agency.

**Formal Consultation** – The process between USFWS/ NMFS and a Federal agency that commences when the Federal agency determines its action may affect a listed species or critical habitat. The Federal agency then submits a written request for consultation with USFWS/ NMFS. The process concludes with the issuance of a Biological Opinion from the USFWS/ NMFS, stating whether or not the action is likely to result in jeopardy to the species or adverse modification of critical habitat.

**Informal Consultation** – The informal consultation process precedes formal consultation and may be requested by the Federal agency, a designated non-Federal representative, or other applicant. Informal consultation may include such topics as which species occur in the proposed action area, and what effect the action may have on listed species or critical habitats. Informal consultation often concludes with USFWS/ NMFS providing written concurrence with the Federal agency's determination that its action is not likely to adversely affect listed species or critical habitat.

**Installation** – The term installation includes active military installations, state National Guard Bureau (NGB) offices, NGB training sites, Army ammunition plants and depots, and regional support centers for the Army Reserve. Analyses in this report do not make a distinction between the various types. In some cases it was difficult to define "installation" data because some NGB state offices, for example, reported on an individual basis, while others reported at the state level.

**Jeopardy Biological Opinion** – A Biological Opinion issued by the USFWS or NMFS stating that a proposed action is likely to jeopardize the continued existence of listed species or result in the destruction or adverse modification of critical habitat.

**MACOM** – Major Command AMC- Army Materiel Command ARNG- Army National Guard ATEC- Army Testing and Evaluation Command FORSCOM- Forces Command TRADOC- Training and Doctrine Command

USARC- U.S. Army Reserve Command USARPAC- U.S. Army Pacific Command USARSO- U.S. Army South Command USMA- U.S. Military Academy

**Non-jeopardy Biological Opinion** – A Biological Opinion issued by the USFWS or NMFS stating that a proposed action may affect, but is not likely to jeopardize the continued existence of listed species or result in adverse modification of critical habitat.

**PLS** – Planning Level Survey. An installation-wide inventory used to characterize essential components of the installation natural resources (e. g., landform, soil, water, and biota). Planning level surveys for TES include, at a minimum, a map showing the kinds and known distribution of TES on the installation.

**Species Occurrence** – An occurrence is equivalent to an individual record. For example, a species that occurs on three installations is recorded as having three occurrences.

S/A – Similarity of Appearance. A species that closely resembles a Threatened or Endangered species may be given the Federal status of the species it resembles. Similarities of Appearance species are denoted with a T(S/A) or E(S/A). However, no distinction is made between S/A and TES for reporting purposes.

#### **Species Location**

*Contiguous* – Species known to occupy or otherwise use habitat adjacent to an installation, which may be affected by installation military activities and land management practices. Contiguous species are of concern to installations because of the possibility that they may at some future time be found on the installation.

Onsite – Species that have been documented on the installation.

**T&E** – The term T&E includes only Federally Threatened and Endangered species. These two statuses include S/A species.

**TEP** – The term TEP includes all Federally Threatened, Endangered, and Proposed species.

**TES** – Threatened and Endangered Species. The term TES includes all Federally Threatened, Endangered, Proposed, and Candidate species on Army lands.
