◆ The 2004 NASA Annual Occupational Health Conference, June 21st-25th: The conference is less than one month away and all preparations are right on schedule. At this time there are approximately 100 attendees registered. Below you will find information about the various components of the conference. ◆ General Session Information: This year's conference theme "Embracing Change in Occupational Health - Moving Towards ONE NASA" will be highlighted during the general sessions. Speakers both internal to NASA and from organizations such as the Department of Health and Human Services (HHS), OSHA, and the Mayo Clinic will present on timely OH issues. Keynote speaker Gary Bradt (leading interpreter of "Who Moved My Cheese") will speak on Change Management. Former astronaut Story Musgrave will be speaking to attendees, as well as Thomas Jefferson, the luncheon speaker on Wednesday, June 23rd.

◆ OH Discipline Breakout Sessions: As in the past, OH disciplines will host Breakout Sessions. These sessions are designed to generate discussions on current issues, new initiatives, and best practices. This year's sessions include: 1) COTRs, 2) EHRS Task Force, 3) Health Physics, 4) Physician/Nurse, 5) Employee Assistance Program, and 6) Industrial Hygiene. Take this opportunity to meet and interact with your counterparts at the other NASA Centers.

◆ OH Conference Tours: On Monday evening June 21st immediately following the welcome reception there will be a candlelight walking tour of Colonial Williamsburg. On the afternoon of Thursday June 24th there will be a tour of the Jamestown Settlement. This attraction commemorates the Jamestown settlement started in 1607.



Electronic Health Records System (EHRS)

Update: While the EHRS project team focused on workflow process development this month, an official <u>sources sought</u> <u>notice</u> was issued by the NASA procurement office to gauge interest from commercial vendors in providing the software application. The project team has a Task Force working group planned for this year's conference and an update of the project's status will be delivered during both the MD/RN and COTR breakout session.

CDC Announces New Goals and Organizational

Design: On May 13, 2004, CDC announced the results of the Futures Initiative activities which began in 2003. One aspect of the announcement concerns the clustering of the Agency for Toxic Substances and Disease Registry/National Center for Environmental Health (ATSDR/NCEH), the National Center for Injury Prevention and Control (NCIPC) and the National Institute for Occupational Safety and Health (NIOSH) into *one of four* coordinating centers at CDC. The new organization provides a framework for the CDC to meet its overarching health protection goals of preparedness, health promotion and prevention of disease, injury and disability through more effective coordination of the programs of its centers, institutes and offices.
