## Occupational Health Responds to Hurricane

**Katrina:** On August 29 Hurricane Katrina ripped through the Gulf Coast states impacting both NASA's Michoud Assembly Facility (MAF) in New Orleans, LA and Stennis Space Center



(SSC) in Bay St. Louis, MS. On September 8 & 9 in response to the disaster, representatives of the Agency Occupational Health (OH) office under the leadership of Dr. Williams surveyed the two

affected sites to assess OH impacts and support needs. The Agency office has been coordinating staffing support by sending OH personnel from around the Agency to support both facilities since the storm. This includes Employee Assistance Program (EAP), Medical, and Environmental Health personnel. OH personnel from other NASA sites are scheduled to continue this post hurricane support for the immediate future. Many of the



OH staff at both MAF and SSC have lost their homes and personal belongings, and yet many have continued to go to work in this most difficult time. We want to

recognize their efforts and the Agency OH Office will continue to support them in this challenging time. As part of this overall effort a new <u>hurricane resources webpage</u> has been created to help OH professionals get hurricane response information they need quickly from trusted information sources.
