## Interoperability Tier Descriptions



#### Interoperability Assessment must:

- Include what entities desire inter-operation (the set or community)
- Include what tier of inter-operation is addressed (which "C's")
- Address the importance of the interoperation tier
- Assess the interoperability solutions (e.g., technical, fundamental, social, procedural)
- Build upon the fundamental relationships of the tier (the "C's")
