ON 15 DEC 2005, OFFICIALS FROM THE FOOD AND DRUG ADMINISTRATION (FDA) RELEASED A FINAL ORDER, AGAIN FINDING THAT ANTHRAX VACCINE PROTECTS AGAINST ALL ROUTES OF EXPOSURE, INCLUDING INHALATION ANTHRAX. WHILE SENIOR DOD LEADERSHIP COMPLETES A POLICY REVIEW, THE COAST GUARD WILL CONTINUE VOLUNTARY ANTHRAX VACCINATIONS AS PER REF B AND C. THIS INTERIM APPROACH WILL CONTINUE TO INCLUDE EDUCATIONAL BRIEFINGS, AN OPTION TO REFUSE, AND WEEKLY REPORTING REQUIREMENTS. PER REF C, THE CURRENT COAST GUARD POLICY FOR ANTHRAX VACCINATIONS REMAINS IN EFFECT UNTIL 14 JAN 2006.
