I. APPLICATION INSTRUCTIONS FOR FPCA

The Federal Post Card Application (FPCA) is the primary form for requesting registration and/or an absentee ballot from your local election official. **Read all instructions printed below and on the FPCA before completing and signing your application.** Circled letters correspond to the circled letters on the sample form on the preceding page.

- A Block 2.f and 2.g: Your Delaware Driver's License number is required. If you do not have a Delaware Driver's License then the last four digits of your Social Security number is required for voter registration. If you do not possess either of these identifications, the state shall assign a number that will serve to identify you for voter registration purposes.
- **B** Block 2.h and 2.i: Provide an email address that you can access and/or a phone number at which you can be reached in the event that there are questions regarding your application
- **Block 3.a through 3.e:** Provide the complete street address of your Delaware voting residence. A post office box is not sufficient. If your address includes a rural route, describe its location in Block 6. For example: "on Highway _______, 2 miles past Highway _______, across the street from the _____ gas station." This address should be different from the one provided in Block 4 and must in be the county where you claim legal voting residence.
- **Block 4.a:** Print the complete address where you want your ballot sent usually your current mailing address. It must be different from the address you provided in Block 3.
- Block 4.c: Delaware does not allow you to return the absentee ballot electronically. See Section II.D. or III.D.
- **Block 5:** Specify your political party affiliation, e.g. Democrat, Republican, Libertarian, Green Party, Independent, decline to state, etc. Delaware conducts Primary Elections for the Democratic and Republican parties. You must be registered as a Democrat to vote in the Democratic Primary and as a Republican to vote in the Republican Primary. You may not change your political party affiliation between March 31st in the year of a General Election and day of the Primary Election. If you are currently registered to vote and want to change your political party affiliation, submit an FPCA that shows your new political party affiliation. There are two periods during which a person is prohibited from changing their political party affiliation prior to a Presidential Election. The first period begins November 1st in the year before a Presidential Election and runs through the day of the Presidential Primary. The second period begins on March 31st in the year of the election and runs through the day of the Primary Election.
- **©** Block 6: Submission of this form serves as a request to receive ballots for all Federal elections held through the next two regularly scheduled general elections. If you do not wish to receive ballots for that length of time, you may request a ballot for each election for Federal office held in the next election year OR a ballot for only the next

scheduled election for Federal office by noting your choice here

See special instructions in Sections II.E. and III.E.

Block 7: You must sign and date the FPCA. Election Officials cannot process the FPCA unless it is signed. You are swearing or affirming under penalty of perjury that the information on the FPCA is true and correct when you sign the FPCA.

II. UNIFORMED SERVICES

These procedures apply to persons who are U.S. citizens, residents of Delaware and members of the Uniformed Services and their family members. Uniformed Services are defined as the U.S. Armed Forces, merchant marine, commissioned corps of the Public Health Service and the National Oceanic and Atmospheric Administration.

A. Registering and Requesting an Absentee Ballot

Send a completed FPCA to the appropriate Department of Elections as soon as practical in the year of a general election. If you move or are deployed during the year, send an FPCA with your new information to the Department of Elections as soon as practical. The deadline for a *UOCAVA* voter to register to vote is the third Monday prior to the date of a primary or general election. Late submission of FPCAs and/or failure to return ballots promptly are the major reasons that ballots are received too late to be counted.

Send an FPCA to the appropriate Department of Elections every year and whenever you change your mailing address in order to keep your voter registration and your absentee ballot information up to date.

If you are already registered and only wish to request an absentee ballot, send a completed FPCA requesting an absentee ballot to the Department of Elections as soon as practical in the year of a general election but not later than 4 days before the day of the election. For Presidential Elections, the Departments of Elections will accept applications for absentee ballots beginning August 15 in the year prior to a Presidential Election.

B. Casting Your Vote

Vote and return your ballot as soon as you receive it. Ballots received after the deadline will not be counted.

Ballot Return Deadline: Voted ballot must be returned to the Department of Elections that issued them no later than 8 p.m. on election day in order to be counted.

The Departments of Elections for the counties will mail ballots as soon as they are available. Ballots for primary elections will be mailed approximately 30 days prior to the election. Ballots for general elections will be mailed approximately 45 days prior to the election.

If you have not received your state ballot in a timely manner, use the **Federal Write-In Absentee Ballot.** See instructions in Chapter Two.

C. Notary/Witness Requirements

No registration or voting materials are notarized or witnessed.

D. Electronic Transmission of FPCAs and Ballots

- Delaware allows you to send the FPCA for registration and absentee ballot by fax. After faxing, submit the FPCA by mail.
- Delaware allows you to receive the blank ballot by fax or email.
- Delaware does not allow you to return the voted ballot by fax or email.

E. Special Write-In Absentee Ballot

Delaware provides a state special write-in absentee ballot available 90 days before the election if you will be unable to vote by regular absentee ballot or in person due to requirements of military service or due to living in isolated or extremely remote areas of the world.

The FPCA may be used to request the state special write-in ballot. In **Block 6 of the FPCA** write "I am unable to vote by regular absentee ballot or in person due to requirements of military service. I request a special write-in ballot."

The special write-in ballot may be requested at any time before the election.

The regular ballot that you are eligible to vote will be sent if the request for the special write-in ballot is received after the standard ballots are available.

Vote the special write-in ballot by writing in the name of person for whom you wish to vote or by writing in the party preference for each office.

F. Bars to Registration and Voting

Persons who have been convicted of a felony (unless pardoned or whose voting rights have been restored) or found mentally incompetent may not register to vote or vote. Persons convicted of a felony may have their voting rights restored 5 years after completion of their sentence to include payment of all fines and court ordered restitution. This applies to all felons except those convicted of murder or manslaughter; offenses against public administration including bribery, improper influence or abuse or office; or sexual offenses. See Delaware's Constitution, Article V, § 2, and Delaware Code, Title 15, Chapter 61 for complete information.

G. Action on Registration Requests

You are notified when your application is accepted. If your application is rejected, you are so notified with the reason(s) for rejection.

H. Action If Registration Is Denied

Denial of registration may be appealed to the board of elections for your county and/or superior court. Consult a legal assistance officer or civilian counsel. Upon denial of your voter registration application or absentee ballot request, Delaware shall provide you with the reason(s) for the rejection.

I. Late Registration

Military and overseas citizens who return to the United States within 60 days of an election and establish residence in Delaware can register to vote after the normal deadline. Contact the Department of Elections for the county in which you live for further information.

J. Voting By Citizens Who Have Never Lived in the U.S.

A U.S. citizen who was born abroad and who is eligible to vote and who has never lived in the U.S. may register and vote in the county where a parent would be eligible to register and vote.

III. CIVILIANS OUTSIDE U.S.

These procedures apply to persons who are U.S. citizens, residents of Delaware and overseas citizens. The term "overseas citizen" means a U.S. citizen who resides outside the U.S and (but for such residence) would be qualified to vote in Delaware.

- Delaware residents temporarily residing outside the U.S. (for local, state and Federal office ballots)
- overseas citizens (for Federal office ballots only)

A. Registering and Requesting an Absentee Ballot

Send a completed FPCA to the appropriate Department of Elections as soon as practical in the year of a general election. If you move or are deployed during the year, send an FPCA with your new information to the Department of Elections as soon as practical. The deadline for a *UOCAVA* voter to register to vote is the third Monday prior to the date of a primary or general election. Late submission of FPCAs and/or failure to return ballots promptly are the major reasons that ballots are received too late to be counted.

Send an FPCA to the appropriate Department of Elections every year and whenever you change your mailing address in order to keep your voter registration and your absentee ballot information up to date.

If you are already registered and only wish to request an absentee ballot, send a completed FPCA requesting an absentee ballot to the Department of Elections as soon as practical in the year of a general election but not later than 4 days before the day of the election. E. Special Write-In Absentee Ballot

J. Voting By Citizens Who Have Never Lived in the U.S.

A U.S. citizen who was born abroad and who is eligible to vote and who has never lived in the U.S. may register and vote in the county where a parent would be eligible to register and vote.
