ORDERING VOTING MATERIALS

Maintaining an adequate supply of voting materials is an essential function of every Voting Assistance Officer (VAO). The Federal Post Card Application, Standard Form 76 (FPCA, SF 76) and the Federal Write-In Absentee Ballots, Standard Form 186 (FWAB, SF 186) are both available online at www.fvap.gov. The FVAP ID number for the *2008-09 Voting Assistance Guide* is VAG08-09; for the Election Dates Poster, EDP08; and for the Motivational Poster, DoD113. The Federal Voting Assistance Program (FVAP) recommends VAOs keep forms in stock, and also encourages use of the FVAP website (www.fvap.gov). The following can be used as a reference for VAOs to order new and replacement materials. For further information, contact your Service or Department of State Voting Action Office (see below).
