I. APPLICATION INSTRUCTIONS FOR FPCA

The Federal Post Card Application (FPCA) is the primary form for requesting registration and/or an absentee ballot from your local election official. **Read all instructions printed below and on the FPCA before completing and signing your application.** Circled letters correspond to the circled letters on the sample form on the preceding page.

- A Block 2.f and 2.g: Your Social Security number is required. If you do not have a Social Security number, your American Samoa Driver's License number is required for voter registration. If you do not possess either of these identifications, American Samoa shall assign a number that will serve to identify you for voter registration purposes.
- **B** Block 3.a through 3.e: Provide the complete address of your American Samoa voting residence. This address must be different from the one provided in Block 4 and must be within American Samoa.
- **⊙** Block 4.a: Print the complete address where you want your ballot sent usually your current mailing address. Your current mailing address must be different from the address you provided in Block 3.
- **Block 4.c:** This form acts as a request for a mailed absentee ballot only. American Samoa does not allow you to receive or return the absentee ballot electronically. See Section II.D. or III.D.
- **Block 6:** If you use this form to register, you must write here:
- 1. Your age
- 2. Your place of current employment
- 3. A statement that the residence listed in Block 3 was acquired with the intent to make American Samoa your legal residence.

Submission of this form serves as a request to receive ballots for all Federal elections held through the next two regularly scheduled general elections. If you do not wish to receive ballots for that length of time, you may request a ballot for each election for Federal office held in the next election year OR a ballot for only the next scheduled election for Federal office by noting your choice here.

- **Block 7:** You must sign and date the FPCA. If using the FPCA to register, it must be signed by a notary public, commissioned officer, consular officer or other authorized person.
- **G** Block 7: If you are not yet registered, a notary public, commissioned officer, consular officer, or other authorized person must complete this section.

II. UNIFORMED SERVICES

These procedures apply to persons who are U.S. citizens, residents of American Samoa and members of the Uniformed Services and their family members. Uniformed Services are defined as the U.S. Armed Forces, merchant marine, commissioned corps of the Public Health Service and the National Oceanic and Atmospheric Administration. (Consult Section B below for ballot type eligibility).

A. Registering and Requesting an Absentee Ballot

You should send an FPCA to your local election official early every year and whenever you change your mailing address (see below for eligibility and also Chapter Two).

You must register in person to vote a ballot for local offices.

You may register absentee to vote a ballot for Federal offices only.

If you are an unregistered citizen, the Chief Election Officer must receive your FPCA not later than 4:30 p.m., 30 days before the election.

If you are a registered citizen, the chief election officer must receive your FPCA between 75 and 15 days before the election.

B. Casting Your Vote

Ballot Return Deadline: Return your voted ballot so that it arrives at the Election Office by 1:30 p.m. on election day.

Local election officials mail ballots as soon as official ballots are printed and available, and if your request for absentee ballot was sent no later than 15 days before the election.

Due to its territorial status, American Samoa does not send representatives to the U.S. Senate or directly participate in the election of the President and Vice President of the U.S. At the Federal level, only a Delegate to the House of Representatives is elected.

If you have not received your state ballot in a timely manner, use the **Federal Write-In Absentee Ballot.** See instructions in Chapter Two.

C. Notary/Witness Requirements

FPCA: Must be sworn to by a notary public, commissioned officer, consular officer or other authorized person.

Returning a Ballot: No notary or witness required.

D. Electronic Transmission of FPCAs and Ballots

- American Samoa allows you to send the FPCA for registration and absentee ballot by fax. After faxing, submit the FPCA by mail.
- American Samoa does not allow you to receive the blank ballot by fax.
- American Samoa does not allow you to return the voted ballot by fax.

E. Bars to Registration and Voting

Persons under guardianship, found incompetent, or convicted of a felony may not register or vote. Felons may vote if restored to civil rights or on good behavior for two years from the date of conviction or release from prison, whichever is later.

F. Cancellation of Registration

Registration is canceled for failure to vote in two consecutive elections.

G. Action on Registration Reguests

No notice of registration is sent.

H. Action If Registration Is Denied

Persons denied registration may appeal to the board of registration. Consult a legal assistance officer or civilian counsel. Upon denial of your voter registration application or absentee ballot request, American Samoa shall provide you with the reason(s) for the rejection.

III. CIVILIANS OUTSIDE U.S.

The following procedures apply to persons who are U.S. citizens, residents of American Samoa and overseas citizens. The term "overseas citizen(s)" means a U.S. citizen who resides outside the U.S. and (but for such residence) would be qualified to vote in American Samoa.

A. Registering and Requesting an Absentee Ballot

You should send an FPCA to your local election official early every year and whenever you change your mailing address (see below for eligibility) and also Chapter Two.

You must register in person to vote a ballot for local offices.

You may register absentee to vote a ballot for Federal offices only.

If you are an unregistered overseas citizen, the Chief Election Officer must receive your FPCA not later than 4:30 p.m., 30 days before the election.

If you are a registered overseas citizen, the Chief Election Officer must receive your FPCA between 75 and 15 days before the election.

B. Casting Your Vote

Ballot Return Envelope: Return your voted ballot so that it arrives at the Election Office by 1:30 p.m. on election day.

Local election officials mail ballots as soon as official ballots are printed and available, and if your request for absentee ballot was sent no later than 15 days before the election.

C. Notary/Witness Requirements

- American Samoa does not allow you to return the voted ballot by fax.

E. Bars to Registration and Voting

Persons under guardianship, found incompetent, or convicted of a felony may not register or vote. Felons may vote if restored to civil rights or on good behavior for two years from the date of conviction or release from prison, whichever is later.

F. Cancellation of Registration

Registration is canceled for failure to vote in two consecutive elections.

G. Action on Registration Requests

No notice of registration is sent.

H. Action If Registration Is Denied

Persons denied registration may appeal to the board of registration. Consult a legal assistance officer or civilian counsel. Upon denial of your voter registration application or absentee ballot request, American Samoa shall provide you with the reason(s) for the rejection.
