#### I. APPLICATION INSTRUCTIONS FOR FPCA

The Federal Post Card Application (FPCA) is the primary form for requesting registration and/or an absentee ballot from your local election official. **Read all instructions printed below and on the FPCA before completing and signing your application.** Circled letters correspond to the circled letters on the sample form on the preceding page.

- A Block 2.f and 2.g: Your Oregon Driver's License number OR if you do not have an Oregon driver's license, the last four digits of your Social Security number is required for voter registration. The state shall assign a number that will serve to identify you for voter registration purposes.
- Block 3.a through 3.e: Provide the complete street address of your Oregon voting residence. A post office box is not sufficient. If your address includes a rural route, describe its location in Block 6. For example: "on Highway \_\_\_\_\_\_, across the street from the \_\_\_\_\_\_ gas station." This address is different from the one provided in Block 4 and must be within the county where you claim legal voting residence.
- **⊙** Block 4.a: Print the complete address where you want your ballot sent usually your current mailing address. It is different from the address you provided in Block 3.
- **Block 4.c:** See Section II.D. or III.D.
- Block 5: Print the name of a political party or write, "not affiliated with a party." If you do not complete Block 5, you will be registered "non-affiliated." If you print the name of a party that selects its candidates at the primary election, you will be eligible to vote in that party's primary. Political party affiliation is not required if only requesting absentee ballots for general elections. If you are not affiliated with a political party and you wish to vote the primary ballot of a party that has authorized participation of non-affiliated electors, write in Block 6: "I want to vote in the (fill in the name of the political party) primary. Please send me its primary election absentee ballot." In this case submit your FPCA at least 45 days prior to the primary election. Candidates nominated at a primary election run in the general election.
- Block 6: Submission of this form serves as a request to receive ballots for all Federal elections held through the next two regularly scheduled general elections. If you do not wish to receive ballots for that length of time, you may request a ballot for each election for Federal office held in the next election year OR a ballot for only the next scheduled election for Federal office by noting your choice here.

Refer to Section II.E. or III.E. for additional instructions.

**6 Block 7:** You must sign and date the FPCA. When signing, you are swearing or affirming that the information is true and correct. A witness or a notary is not required.

#### **II. UNIFORMED SERVICES**

These procedures apply to persons who are U.S. citizens, residents of Oregon and members of the Uniformed Services and their family members. Uniformed Services are defined as the U.S. Armed Forces, merchant marine, commissioned corps of the Public Health Service and the National Oceanic and Atmospheric Administration.

### A. Registering and Requesting an Absentee Ballot

You should send an FPCA to your local election official early every year and whenever you change your mailing address, except if you are requesting a special write-in ballot (See Section II.E. and also Chapter Two).

To register to vote and request an absentee ballot, send a completed FPCA to the county clerk by the 21st day before the election at which you intend to vote. A postmark of the 21st day before the election is accepted.

If you are already registered and only wish to request an absentee ballot, send a completed FPCA to the county clerk so that it arrives not later than the Thursday before the election, as long as there is adequate time to receive and return a ballot by mail no later than 8:00 p.m. on election day.

#### **B.** Casting Your Vote

**Ballot Return Deadline:** Voted ballot must arrive by **8** p.m. on election day.

Local election officials mail absentee ballots 45 days before the primary and general elections.

If you have not received your state ballot in a timely manner, use the **Federal Write-In Absentee Ballot.** See instructions in Chapter Two and Section II.D.

#### C. Notary/Witness Requirements

No registration or voting materials are notarized or witnessed.

### D. Electronic Transmission of FPCAs and Ballots

- Oregon allows you to send the FPCA for registration by fax or email. After faxing or emailing, you must submit the original FPCA by mail. However, the signed original must be received or postmarked by the 21st day before the election.
- If using the FPCA for ballot request only, Oregon allows you to send the FPCA for absentee ballot

request by fax or email. The signed original FPCA must arrive by the Thursday before the election.

- Oregon allows you to receive the blank absentee ballot by fax or email.
- Oregon does not allow you to return the voted ballot by fax or email.

#### E. Federal Write-In Absentee Ballot

Oregon expanded use of the Federal Write-In Absentee Ballot (FWAB), SF 186. An Oregon qualified voter may use the Federal Write-In Absentee Ballot for general, special, and primary elections for Federal offices. The voter may use the Voter's Declaration/Affirmation simultaneously as registration and ballot request, as long as the voter is otherwise qualified to register in Oregon and has signed and completed the information of the FWAB required to register in Oregon.

If you receive your regular absentee ballot after you have returned the FWAB, you may vote your regular absentee ballot and return it. If your regular absentee ballot is received before the FWAB is processed, your regular absentee ballot will be counted. If you have any questions, please contact the Secretary of State's Office.

#### F. Special Write-In Absentee Ballot

Oregon provides a state special write-in absentee ballot if you are residing, stationed, or working outside the U.S. and will be unable to vote and return a regular absentee ballot by normal mail delivery within the period provided for regular absentee ballots.

Use the FPCA to request this state special write-in ballot. In **Block 6 of the FPCA** write: "I am outside the territorial limits of the United States and the District of Columbia and I am unable to vote and return a regular absentee ballot by normal mail delivery in the time provided for regular absentee ballots. I request a special write-in absentee ballot."

You may request the state special write-in ballot any time before the election, but any request received by the county clerk less than 40 days before the election is treated as a request for a regular absentee ballot.

The FPCA you use to request a write-in ballot is valid only for the election specified in the application.

#### G. Late Registration

Members of the U.S. Armed Forces or merchant marine who have been discharged within 30 days of an election may follow the procedures outlined in Section II to register and vote.

#### H. Bars to Registration and Voting

Persons found mentally incompetent by a court may not register or vote. Persons imprisoned by the Oregon Department of Corrections for a felony may register but may not vote from the date of sentencing until released, paroled or the conviction is set aside.

#### I. Cancellation of Registration

Registration is valid until the registrant notifies the county clerk of cancellation or changes to his or her voting status. An election official also automatically updates registrations for which he or she receives information from the U. S. Postal Service of a mailing or residence address change. Additionally, an elections official may inactivate or cancel a registration if a person has moved, has not responded to a notice from the election official and has not voted nor updated the registration for a period of not less than five years.

#### J. Action on Registration Requests

Notice of acceptance or denial is sent.

#### K. Action If Registration Is Denied

Upon denial of your voter registration application or absentee ballot request, Oregon shall provide you with the reason(s) for the rejection. Persons denied registration may appeal to the county clerk. Consult a legal assistance officer or civilian counsel.

#### III. CIVILIANS OUTSIDE U.S.

These procedures apply to persons who are U.S. citizens and residents of Oregon.

- Oregon residents and their spouses and dependents temporarily residing outside the U.S. (for local, state and Federal office ballots)
- overseas citizens from Oregon (for Federal office ballots only)

### A. Registering and Requesting an Absentee Ballot

You should send an FPCA to your local election official early every year and whenever you change your mailing address, except if you are requesting a special write-in ballot (See Section III.E and also Chapter Two).

To register to vote and request an absentee ballot, send a completed FPCA to the county clerk by the 21st day before the election at which you intend to vote. A postmark of the 21st day before the election is accepted.

If you are already registered and only wish to request an absentee ballot, send a completed FPCA to the county clerk so that it arrives not later than the Thursday before the election, as long as there is adequate time to receive and return a ballot by mail no later than 8:00 p.m. on election day

#### **B.** Casting Your Vote

**Ballot Return Deadline:** Voted ballot must arrive by **8** p.m. on election day.

Local election officials mail absentee ballots 45 days before the primary and general elections.

If you have not received your state ballot in a timely manner, use the **Federal Write-In Absentee Ballot.** See instructions in Chapter Two and Section III.D.

#### E. Federal Write-In Absentee Ballot
