# Vermont

#### I. APPLICATION INSTRUCTIONS FOR FPCA

The Federal Post Card Application (FPCA) is the primary form for requesting registration and/or an absentee ballot from your local election official. **Read all instructions printed below and on the FPCA before completing and signing your application.** Circled letters correspond to the circled letters on the sample form on the preceding page.

- A Block 2.f and 2.g: Provide your Vermont Driver's License number or if you do not have a Vermont Driver's License, the last four digits of your Social Security Number. If you do not possess either of these identifications, the State shall assign a number that will serve to identify you for voter registration purposes.
- Block 2.h and 2.j: Provide an email address that you can access and/or a phone number (including all country and local prefixes) at which you can be reached for use in contacting you in a timely manner in the event that there is a question regarding your application.
- **©** Block 3.a through 3.e: Provide the complete street address of your Vermont voting residence. A post office box is not sufficient. If you do not have a street address, describe the physical location of your residence in Block 6. For example: "on Highway \_\_\_\_\_\_, 2 miles past Highway \_\_\_\_\_\_, across the street from the \_\_\_\_\_\_ gas station." This address must be within the town where you claim legal voting residence.
- **Block 4.a:** Print the complete address where you want your ballot sent usually your current mailing address. It must be different from the address you provided in Block 3.
- Block 4.c: Check the box corresponding to the manner in which you prefer to receive your ballot. If you want to receive it by fax or email, please be sure to include your fax number or email address in Block 2.i or 2.j. See Section II.D or III.D.
- Block 5: If you do not list a party affiliation, you cannot vote in the presidential primary election. You must indicate your political party affiliation when applying for a presidential primary ballot (Example: Democrat, Republican) or write "none" in Block 5 of the FPCA. Political party choice is not required if only requesting absentee ballots for general elections or other primaries.
- **6 Block 6:** To register, you must take a self-administered oath, or it may be administered by anyone over the age of 18. If another person administers the oath, he or she must provide the printed name and signature in block 6. The Vermont voter's oath is:
- "I solemnly swear (or affirm) that whenever I give my vote or suffrage, touching any matter that concerns the State of Vermont, I will do it so as in my conscience I shall judge will most conduce to the best good of the same, as established by the Constitution, without fear or favor of any person."

You or the person who administered the oath to you must write in Block 6 one of the following:

Submission of this form serves as a request to receive ballots for all Federal elections held through the next two regularly scheduled general elections. If you do not wish to receive ballots for that length of time, you may request a ballot for each election for Federal office held in the next election year OR a ballot for only the next scheduled election for Federal office by noting your choice here.

- Block 7: Please note under AFFIRMATION: Item 3 is not applicable for voting purposes in Vermont.
- Block 7: You must sign and date the FPCA. When signing, you are swearing or affirming that the information is true and correct.

#### **II. UNIFORMED SERVICES**

These procedures apply to persons who are U.S. citizens, residents of Vermont and members of the Uniformed Services and their family members. Uniformed Services are defined as the U.S. Armed Forces, merchant marine, commissioned corps of the Public Health Service and the National Oceanic and Atmospheric Administration.

## A. Registering and Requesting an Absentee Ballot

You should send an FPCA to your local election official early every year and whenever you change your mailing address (see Chapter Two).

**To register and request an absentee ballot,** send a completed FPCA so that it is received by the town clerk not later than 5 p.m. on the Wednesday immediately before the election.

To request an absentee ballot if you are already registered, send a completed FPCA to the town clerk so that it arrives not later than 5 p.m. or the closing of the town clerk's office on the day preceding the election. Alternatively, you may request a ballot by telephone. Contact information is available at http://vermont-elections.org/soshome.htm. (Although Vermont law allows absentee ballot requests as stated, you must time your request in order for you to receive your ballot in time to actually return it so it arrives at the town clerk's office before 7 p.m. on election day.)

#### **B.** Casting Your Vote

Ballot Return Deadline: Voted ballot must arrive at the town clerk not later than the close of polls on election day.

Local election officials mail absentee ballots approximately 30 days before Federal and state elections. Ballots for local elections are available 20 days before the election.

If you have not received your state ballot in a timely manner, use the **Federal Write-In Absentee Ballot.** See instructions in Chapter Two.

#### C. Notary/Witness Requirements

**FPCA:** If you have never registered before in Vermont, you must take the Voter's Oath as part of the registration process. Please see Section I, paragraph G for instructions on how to certify in Block 6 of the FPCA that you took the Vermont voter's oath.

**Returning a Ballot:** The ballot return envelope is not sworn to or witnessed. However, your signature must be on the inside envelope certificate.

## D. Electronic Transmission of FPCAs and Ballots

- Vermont allows you to send the FPCA for registration and absentee ballot request by fax or email. After faxing or emailing, submit the FPCA by mail or express delivery service.
- Vermont allows you to receive the blank absentee ballot by fax or email.
- Vermont *does not* allow you to return your voted ballot by fax or email.

#### E. Application for Ballot by Proxy

A member of your immediate family may request a ballot from the town clerk for you. This request by proxy must be received by 5 p.m., the day before the election. (Although Vermont law allows absentee ballot requests as stated, you must time your request in order for you to receive your ballot in time to actually return it so it arrives at the town clerk's office before 7 p.m. on election day.)

#### F. Federal Write-In Absentee Ballot

Vermont has expanded the use of the Federal Write-In Absentee Ballot (FWAB), SF 186. The instructions described in Chapter Two of this *Guide* remain the same, except that Vermont allows eligible voters to use the FWAB to vote in any election (primary, special, and general) for Federal and state offices. Note: Vermont law requires that you enter your party preference in Block 5 of the FWAB when voting in Presidential primaries.

#### G. Cancellation of Registration

Persons who are no longer residents of Vermont may be removed from the voting checklist.

#### H. Action on Registration Requests

Notice of acceptance or denial is sent.

#### I. Action If Registration Is Denied

Upon denial of your voter registration application or absentee ballot request, Vermont shall provide you with the reason(s) for the rejection. Persons denied registration should reapply, providing the information requested in the first notice of denial. If a second denial is received, consult a legal assistance officer or civilian counsel.

#### III. CIVILIANS OUTSIDE U.S.

These procedures apply to persons who are U.S. citizens, residents of Vermont and overseas citizens. The term "overseas citizen" means a U.S. citizen who resides outside the U.S. and (but for such residence) would be qualified to vote in Vermont.

- residents of Vermont temporarily residing outside the U.S. (for local, state and Federal office ballots)
- overseas citizens (for Federal office ballots only)

### A. Registering and Requesting an Absentee Ballot

You should send an FPCA to your local election official early every year and whenever you change your mailing address (see Chapter Two).

**To register and request an absentee ballot,** send a completed FPCA so that it is received by the town clerk not later than 5 p.m. on the Wednesday immediately before the election.

To request an absentee ballot if you are already registered, send a completed FPCA to the town clerk so that it arrives not later than 5 p.m. or the closing of the town clerk's office on the day preceding the election. Alternatively, you may request a ballot by telephone.

#### **B.** Casting Your Vote

**Ballot Return Deadline:** Voted ballot must arrive at the town clerk by **close of polls on election day.** 

Local election officials mail absentee ballots approximately 30 days before Federal and state elections. Ballots for local elections are available 20 days before the election.

If you have not received your state ballot in a timely manner, use the **Federal Write-In Absentee Ballot.** See instructions in Chapter Two.

#### C. Notary/Witness Requirements

**FPCA:** If you have never registered before in Vermont, you must take the Voter's Oath as part of the registration process. Please see Section I, paragraph G for instructions on how to certify in Block 6 of the FPCA that you took the Vermont voter's oath.

**Returning a Ballot:** The ballot return envelope is not sworn to or witnessed. However, your signature must be on the inside envelope certificate.

## D. Electronic Transmission of FPCAs and Ballots

- Vermont allows you to send the FPCA for registration and absentee ballot request by fax or email. After faxing or emailing, submit the FPCA by mail or express delivery service.
- Vermont allows you to receive the blank absentee ballot by fax or email.
- Vermont *does not* allow you to return your voted ballot by fax or email.

#### E. Application For Ballot By Proxy

A member of your immediate family may request a ballot from the town clerk for you. This request by proxy must be received by 5 p.m., the day before the election. (Although Vermont law allows absentee ballot requests as stated, you must time your request in order for you to receive your ballot in time to actually return it so it arrives at the town clerk's office before 7 p.m. on election day.)

#### F. Federal Write-In Absentee Ballot

Vermont has expanded the use of the Federal Write-In Absentee Ballot (FWAB), SF 186. The instructions described in Chapter Two of this *Guide* remain the same, except that Vermont allows eligible voters to use the FWAB to vote in any election (primary, special, and general) for Federal and state offices. Note: Vermont law requires that you enter your party preference in Block 5 of the FWAB when voting in Presidential primaries.

#### G. Cancellation of Registration

Persons who are no longer residents of Vermont may be removed from the voting checklist.

#### H. Action on Registration Requests

Notice of acceptance or denial is sent.

#### I. Action If Registration Is Denied

Upon denial of your voter registration application or absentee ballot request, Vermont shall provide you with the reason(s) for the rejection. Persons denied registration should reapply, providing the information requested in the first notice of denial. If a second denial is received, consult a legal assistance officer or civilian counsel.
