### **Annual NIPA Revision**

#### GDP Revisions

- Annual Revision 2007: Lower growth 3.0 to 2.7 percent, 2003:IV – 2007:I
  - Mean absolute revision 0.27 percentage point



# PCE price index /CPI

- Fundamental differences in PCE price index & CPI lead to comparisons of differentials
  - PCE / CPI differential shrinking in most recent time period




Growth Rates PCE price index vs.CPI

  - BEA/BLS reconciliation article now available on BEA web site


## **Current Issues**

- BusinessWeek and Offshoring:
  - Real imports understated and real GDP and productivity overstated
    - Import price indexes do not capture lower price level of imported goods
  - Similar to old and difficult "new" goods problem in price measurement.
    - Not clear how to "fix"
  - Probably offset as domestic production shifts to lower cost domestic suppliers and/or new goods and services with a lower quality-adjusted price
  - Likely to hear more: Sloan/NAPA and Congress



## **National Accounts**

- NIPA annual revision, methodological improvements including:
  - Improved price index- Deflation of business purchases of light trucks (Source of part of BEA-FRB differences for Motor vehicles, 2006)
  - New BLS price indexes- Nonresidential construction—deflators for office buildings and for schools
  - Developed improved seasonal factors for new Census quarterly services survey QSS data



## National Accounts

- Looking ahead:
  - Continued work on implementing flexible annual revisions with regular annual July releases
  - Incorporation of revision to SNA, international guidelines
  - Research:
    - Satellite accounts for health
    - Data gaps and accounting issues- employee stock options, bonuses, compensation, and profits



## International Accounts

- Annual Revisions, improved methodologies and source data including
  - New financial derivatives data
  - New source data and method for interest receipts and payments on long term securities
- Launched integrated services survey and other improvements recommended by NAS/NAPA on issues of offshoring


### Looking Ahead:

- Develop state-level estimates of exports and imports of selected businesses (professional & technical)
- Continue phased incorporation of data from new integrated surveys
- Begin conducting new 2007 benchmark survey of FDI in U.S.
- Continue implementation of NAS/NAPA recommendations on issues of offshoring




# Industry Accounts

- 2002 Benchmark I-O Account-uses new balancing method
- Next steps in BEA/BLS integration- BLS use of **BFA KI FMS**
- Improvements to Travel and Tourism and Transportation Satellite accounts, including coverage of vacation homes, gasoline consumption
- Provision of KLEMS decomposition of annual tables, 1998-2005



# Industry Accounts

- Looking ahead:
  - Develop consistent NAICS time series for industry R&D performance and funding prior to 1987
  - Release GDP by Industry for 2006 and revised 2004-2005.
  - Release 2002 Capital Flow table
  - Work on consistent time series of historical benchmark use tables to reflect changes introduced in 2003 NIPA comprehensive revision
  - Database re-engineering as part of research to prepare constant-price I-O tables



# **Regional Accounts**


- New Associate Director Joel Platt
- GDP by metropolitan area by NAICS sector (September 2007)
- 2006 GDP by state estimates released four months earlier
  - 2006 personal income for metro areas estimatesone month earlier
- Follow-on experimental methodology for estimating state price levels for 2000



## **Regional Accounts**

#### Looking ahead:

- Develop prototype estimates of pension and retirement distributions and income available to households
- Develop disposable personal income for metro areas
- Begin development of experimental estimates of state and metro area personal income and GDP adjusted for price level differences
- Investigate acceleration of state personal income


