### NOTE FOR CONTRACTING PARTIES TO THE HARMONIZED SYSTEM CONVENTION

## APPROVAL OF DECISIONS TAKEN BY THE HARMONIZED SYSTEM COMMITTEE AT ITS 30<sup>th</sup> SESSION

- 1. Some of the decisions taken by the Harmonized System Committee at its 30<sup>th</sup> Session fall to be approved under the procedure laid down in Article 8.2 of the Harmonized System Convention.
- 2. These decisions are listed in the Annex hereto, in the order in which the various items appear in the Report of the Committee's 30<sup>th</sup> Session (Doc. NC0655E2).
- 3. Under the procedure laid down in the HS Convention or in Council Decision No. 298, Contracting Parties who wish to request that any of the decisions listed in the Annex be referred to the Council or directly back to the Harmonized System Committee may do so within a period of two months running from 1<sup>st</sup> December 2002. Any such request should therefore reach the Secretariat by 31 January 2003 at the latest.
- 4. Following the above closing date, the Secretariat will notify all Contracting Parties to the Harmonized System Convention of :
  - (a) the decisions deemed to have been approved;
  - (b) the decisions having given rise to a request that they be referred directly back to the Harmonized System Committee;
  - (c) any decisions having given rise to a request that they be referred to the Council.
