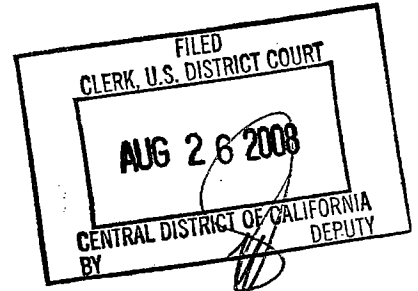

Proposed STATUTORY RESTRAINING ORDER

Having read the Complaint for Injunctive and Other Equitable Relief,  
Plaintiff's Motion for a Statutory Restraining Order, the Memorandum of Points  
and Authorities in support of its motion and the supporting declarations and  
related exhibits; and the Defendants having had telephone notice of the motion;

**THE COURT FINDS:**

1. The Court has jurisdiction over the subject matter.
2. Section 6c(a) of the Commodity Exchange Act, as amended ("Act"),  
7 U.S.C. § 13a-1 (2002), permits this Court to enter a statutory restraining order  
("SRO").

2 or business or personal finances of the Defendants.

3 **II. ACCESS TO AND INSPECTION OF BOOKS AND RECORDS**

4 **IT IS FURTHER ORDERED** that representatives of the CFTC be allowed  
5 immediately to inspect and copy the books, records, and other documents of the  
6 Defendants and their agents including, but not limited to, electronically stored  
7 data, tape recordings, and computer discs, wherever they may be situated and  
8 whether they are in the possession of the Defendants or others, and to copy said  
9 documents, data and records, either on or off the premises where they may be  
10 situated.

14 **III. ORDER PERMITTING EXPEDITED DISCOVERY**

15 **IT IS FURTHER ORDERED** that:

16 A. The prohibition upon discovery before the early meeting  
17 of counsel is removed pursuant to Rule 26(d) of the Federal Rules of  
18 Civil Procedure and parties may initiate discovery immediately upon  
19 entry of this Order;

20 B. The parties may proceed to take the oral deposition of any  
21 person upon three calendar days actual notice if the notice is served  
22 upon the parties personally or by phone or telecopier to the party's  
last known phone or telecopier number; and

23 C. The parties may take the deposition of any person for the  
24 purpose of discovering the identities of pool participants and other  
25 investors and the nature of Defendants' dealings with them, and the  
26 nature, location, status, source and extent of assets of the Defendants  
and the location of any documents reflecting those assets.

1 **IV. BOND NOT REQUIRED OF PLAINTIFF**

2 **IT IS FURTHER ORDERED** that:

3 1. Pursuant to Section 6c(b) of the Act, 7 U.S.C. § 13a-1, no bond need be  
4 posted by the Plaintiff CFTC, which is an agency of the United States of America.  
5

6 **V. STAY**

7 **IT IS FURTHER ORDERED** that except by leave of the Court the  
8 Defendants and all other persons and entities be and hereby are stayed from taking  
9 any action to establish or enforce any claim, right or interest for, against, on behalf  
10 of, or in the name of the Defendants, including but not limited to, the following  
11 actions:  
12

13  
14 A. Commencing, prosecuting, litigating or enforcing any suit,  
15 except that actions may be filed to toll any applicable statute of  
16 limitations;

17 B. Accelerating the due date of any obligation or claimed  
18 obligation, enforcing any lien upon, or taking or attempting to take  
19 possession of, or retaining possession of, property of the Defendants  
20 or any property claimed by the Defendants, or attempting to foreclose,  
21 forfeit, alter or terminate any of the Defendants' interests in property,  
22 whether such acts are part of a judicial proceeding or otherwise;

23 C. Using self-help or executing or issuing, or causing the  
24 execution or issuance of any court attachment, subpoena, replevin,  
25 execution or other process for the purpose of impounding or taking  
26 possession of or interfering with, or creating or enforcing a lien upon  
any property, wherever located, owned by or in the possession of the  
Defendants; and

D. Doing any act or thing to interfere with the exclusive  
jurisdiction of this Court over the property and assets of the

1 Defendants. This Paragraph does not stay the commencement or  
2 continuation of an action or proceeding by a governmental unit to  
enforce such governmental unit's police or regulatory power.

3 **VI. DIRECTIVES TO FINANCIAL INSTITUTIONS AND OTHERS**

4 **IT IS FURTHER ORDERED**, pending further Order of this Court, that  
5 any financial or brokerage institution, business entity, or person that holds,  
6 controls, or maintains custody of any account or asset owned, controlled, managed,  
7 or held by, on behalf of, or for the benefit of the Defendants, or has held,  
8 controlled, or maintained custody of any account or asset owned, controlled,  
9 managed, or held by, on behalf of, or for the benefit of the Defendant at any time  
10 since January 1, 2005, shall:

11 A. Provide counsel for the Commission, within five (5)  
12 business days of receiving a copy of this Order, a statement setting  
13 forth: (a) the identification number of each and every such account or  
14 asset titled in the name, individually or jointly, of the Defendants, or  
15 owned, controlled, managed, or held by, on behalf of, or for the benefit  
16 of the Defendants: (b) the balance of each such account, or a  
17 description of the nature and value of such asset as of the close of  
18 business on the day on which this Order is served, and, if the account  
19 or other asset has been closed or removed, the date closed or removed,  
20 the total funds removed in order to close the account, and the name of  
21 the person or entity to whom such account or other asset was  
22 remitted; and (c) the identification of any safe deposit box that is  
23 either titled in the name, individually or jointly, of the Defendants or  
is otherwise subject to access by the Defendants; and

24 B. Upon request by the Commission, promptly provide the  
25 Commission with copies of all records or other documentation  
26 pertaining to such account or asset, including, but not limited to,  
originals or copies of account applications, account statements,  
signature cards, checks, drafts, deposit tickets, transfers to and from

1 the accounts, all other debit and credit instruments or slips, currency  
2 transaction reports, 1099 forms, and safe deposit box logs.

3 **VII. SERVICE OF ORDER**

4 **IT IS FURTHER ORDERED** that copies of this Order may be served by  
5 any means, including facsimile transmission and Federal Express, upon any  
6 financial institution or other entity or person that may have possession, custody, or  
7 control of any documents or assets of the Defendants, or that may be subject to  
8 any provision of this Order. William Janulis, Michael Tallarico, Ralph  
9 DerAsadourian and Cynthia Cannon, all employees of the CFTC, are hereby  
10 specially appointed to serve process, including this Order and all other papers in  
11 this cause.

14 **VIII. SERVICE ON THE COMMISSION**

15 **IT IS FURTHER ORDERED** that the Defendants shall serve all  
16 pleadings, correspondence, notices required by this Order, and other materials on  
17 the Plaintiff Commission by delivering a copy to William Janulis, Senior Trial  
18 Attorney, Division of Enforcement, Commodity Futures Trading Commission,  
19 525 W. Monroe, Suite 1100, Chicago, Illinois 60661.

22 **VIII. COURT MAINTAINS JURISDICTION**

23 **IT IS FURTHER ORDERED** that this Statutory Restraining Order shall  
24 remain in full force and effect until further Order of this Court, upon application,
