

- Release 2: Asset Accounting, Acquisition of Property and Equipment, Facilities, Property, Quality Management, Barcoding
- Release 3: Aircraft, Configuration Management, Radio Frequency Tags, Geospatial Information System, Document Management System, Environmental

#### IAM Release 1 – Functional Scope



- Release 1 Draft Functional Scope
  - Warehouse Management (Receiving & Inspection, Storage, Safety Levels) of Store Stock, Stand-by Stock and Program Stock
    - ✓ Line item receiving against a PO for Release 1 material types
    - Inspection paperwork, count, part number and damage and the associated remediation of issues. (This is not true QA inspection)
    - ✓ Material put-away bin assignment
    - ✓ Bin Management what material is stored and in what areas
    - ✓ Issue to individual/project material requests





#### IAM Release 1 – Functional Scope



- Release 1 Draft Functional Scope
  - Inventory Management– (Bill of Material for stock items, Kitting, Shelf-life, WIP, Chemicals) of Store Stock, Stand-by Stock and Program Stock
    - ✓ Material Master Set-up and maintenance
    - Substance Master Further set up of the 'material master' to include information pertaining to chemicals
    - MSDS set-up and management of MSDS and associated Dangerous Goods and Hazardous Materials identification requirements
    - Inventory quantity on-hand (includes chemicals)
    - Inventory reorder points minimum and maximum bin levels
    - ✓ Physical Inventory in support of perpetual, cycle or annual counts
    - Material Resource Planning (MRP) Automated PR generation for designated materials based on demands
    - ✓ Shelf- life monitoring
    - ✓ Kit identification and set-up





## IAM Release 1 – Functional Scope



- Release 1 Draft Functional Scope
  - Material Acquisition (includes requisitioning) of Store Stock, Stand-by Stock and Program Stock
    - ✓ Initiate Acquisition identification of need
    - Approve Purchase Requisition for those items requiring higher approval
    - Create/Approval and Issue of Purchase Orders
    - Track Purchase Order validation of receipt and expected delivery status
    - ✓ Modify/Cancel Purchase Requisition & Purchase Order







- Strategic Planning Council to decide scope
  - Bare bones to middle ground to whole hog
  - Will Goldilocks be satisfied?
- Get to know your Center Implementation Team
- Engage as you see fit
