- Item(s) are sold as is, where is, and all sales are final with no refunds.
- Bidders and their employees are required to wear Personal Protective Equipment (PPE) during lot inspections. During removal the Buyer and employees are required to wear, at a minimum, hard hats, gloves, safety glasses, steel toe boots, and any other PPE required as specified in the safe removal plan.
- All Buyers will be required to submit a "Safe Removal Plan" to the Valley Wide Investment Recovery Principle Engineer after award and prior to removal of the lots.
- TVA requires a two day notice prior to removal.
- Anyone inspecting material or working on a TVA site must sign a safety waiver.
- Some items may require special rigging and crane operation. Rigging and Crane operation on a TVA site requires the Buyer to be certified by TVA prior to removal. Certification may be obtained only after attending a class with TVA. A copy of the certification is required prior to removal.
- A Buyer's forklift operator must have a valid certification and the forklift must be inspected prior to operation on a TVA site. A copy of the certification is required prior to removal. TVA does not provide forklifts.
- TVA will not furnish dumpsters, lunch areas, utilities, vending areas and the like.
- Buyer is required to clean-up the area prior to removal of the last load. This includes removal of all trash, pallets, dunnage, etc. unless otherwise noted in the lot description. If the area is a non-paved area, the Buyer is responsible for final grading of the area if removal is by the Buyer and not TVA. If the area is a paved surface the Buyer is responsible for sweeping the area regardless of who loads the material. All material and waste must be removed from the TVA site.
- **Removal will be allowed Monday through Friday from 7:00 a.m. through 3:30 p.m. unless otherwise a federal holiday. If Bidders need to work a schedule other than this, the Bidders must include the exception at the time of bid submittal.**
- Bidders must provide any exceptions to the requirements within this sales notice at the time of bid submittal.
- **Removal can not start until October 2, 2008 and must be completed by October 7, 2008.**
