This is to advise you that the Bay Area Air Quality Management District is issuing a minor revision to the Major Facility Review (Title V) Permit for the following facility:

The purpose of the revision is to incorporate the following provisions of the consent decree entered against ConocoPhillips by the US District Court for the Southern District of Texas on January 27, 2005:

- All heaters and boilers that were not previously subject to 40 CFR 60, Subpart J (Subpart J), are now considered to be "affected facilities" even though they were built before June 11, 1973.
- Heaters will not be allowed to burn fuel oil except during periods of natural gas curtailment, test runs, or operator training.

The permit was proposed to EPA on July 18, 2007. The review period ended on August 31, 2007. No comments were received.

In addition to the changes above, the following administrative amendments will be made to the permit:

- The names of the responsible official and facility contact were updated.
- The name of the District Contact was changed to Sanjeev Kamboj.
- The names of the equipment affected was added to the header of Conditions 383, 1440, 6725, 7353, 7523, 12121, 12122, 12124, 12125, 12127, 12129-12133, 12245, 13184, 16677, 18251, 18629, 18680, 19278, 19476, 19488, 20773, 21092, and 21235.
