The purpose of the proposed minor revision is to remove references to equipment that is no longer operated at the site or was never installed at the site, add the new landfill gas flare and its requirements to the permit, specify alternate well temperature limits and the proposed changes to the landfill gas collection system for the following two years, and finally to update the facility's responsible official.

All proposed permit revisions are clearly shown in strikeout/underline format in the proposed permit and are summarized in the statement of basis.

This revision is minor pursuant to BAAQMD Regulation 2-6-215 and will be effective immediately. The revised permit will be formally issued after the 45-day EPA review period has ended. This revision is not subject to public comment and therefore, requires no public notice.
