The purpose of this revision is to allow an alternative monitoring procedure that will demonstrate compliance with the Regulation 8-2-301 total carbon limits, which apply to VOC-laden soil handling activities at the S-2 Altamont Landfill. Incorporation of the proposed alternative monitoring procedures will require a permit shield that will replace the Regulation 8-2-601 stack testing procedures with the Regulation 8-40-604 fugitive emission monitoring procedures. The proposed alternative monitoring procedures do not relax the frequency of the required monitoring. This application will not result in any emission increases.

The Executive Officer/Air Pollution Control Officer invites written comment on the above proposed significant revision. Comments must be received by November 23, 2005. The public may also request a public hearing for this significant revision.

Significant revisions of Major Facility Review Permits are also subject to review and approval by US EPA. If US EPA has not objected to a proposed significant revision and District has not addressed a public comment in a satisfactory manner, the public may petition US EPA, Region IX, Operating Permits Section at 75 Hawthorne Street, San Francisco, CA 94105, within 60 days after the end of US EPA's review, to reconsider the issuance of the permit.
