**NOTICE** is hereby given that the Executive Officer/Air Pollution Control Officer of the Bay Area Air Quality Management District invites interested persons to submit written public comments on the proposed Renewal of the Major Facility Review Permit for the following facility:

Major facilities are required to obtain operating permits under Title V of the 1990 Clean Air Act Amendments, the Federal Operating Permit Program and the District's Regulation 2, Rule 6 - Major Facility Review. The permits summarize all air-related requirements that apply to each source of emissions at each facility. There have been no significant changes in emissions at this facility.

The Sonoma County Central Landfill (Site #A2254) was issued a Major Facility Operating Permit (Title V Permit) on February 27, 2001. The Title V permit has since undergone two Significant Revisions and one Minor Revision and was reissued on March 29, 2004, October 3, 2005, and May 18, 2006. This application is for a permit renewal. All changes to the most recent version of the permit are clearly shown in strikeout/underline format.

The Air Pollution Control Officer invites written comment on the above proposed permit renewal. Comments must be received by February 20, 2007. Any interested person may also request a public hearing for this permit.

Major Facility Review Permits are also subject to review and approval by US EPA. If US EPA has not objected to a proposed permit and District has not addressed a public comment in a satisfactory manner, the public may petition US EPA, Region IX, Operating Permits Section at 75 Hawthorne Street, San Francisco, CA 94105, within 60 days after the end of US EPA's review, to reconsider the decision to not object to the permit.
