The main purpose of the reopening is to incorporate the MSW Landfill NESHAP requirements into the permit. The District is also proposing to make a number of updates and corrections to improve consistency with other similar permits. The purposes of the significant revision are: to add a new flare to the permit, to revise several limits for the Keller Canyon Landfill and flares; and to expand the landfill gas collection system for the landfill. This significant revision will result in the following emission increases:

If US EPA has not objected to a proposed reopening or significant revision and District has not addressed a public comment in a satisfactory manner, the public may petition US EPA, Region IX, Operating Permits Section at 75 Hawthorne Street, San Francisco, CA 94105, within 60 days after the end of US EPA's review, to reconsider the issuance of the permit.
