The District proposed a minor permit revision for this facility on December 11, 2006. The main purpose of this minor permit revision was to incorporate modifications of the landfill gas collection system description into the MFR Permit for Site # A4618. The District also proposed to identify additional individual wells that will be subject to this site's alternative wellhead oxygen standard. In addition, the District proposed changes to the Responsible Official and Plant Contact and added a missing approval date to the Revision History. The proposed revisions did not result in any emission increases.

The EPA comment period ended on January 27, 2007. No comments on this proposed minor revision were received from EPA or the facility.
