The facility above received its initial Title V permit on December 1, 2003. This reopening of the Title V permit addresses permit concerns identified by the EPA on October 8, 2004. The reopening also incorporates changes in applicable requirements authorized in Authorities to Construct, addresses issues raised in the refinery's appeal to the December 16, 2004 permit, and addresses some refinery comments. These changes have resulted in no significant increase in emissions.

The reopening is limited to changes made to the permit. All changes are clearly shown in "strikeout/underline format" and have been addressed in the permit evaluation/statement of basis. In the permit evaluation/statement of basis, where additional analysis supporting applicability determinations previously made by the District did not result in a permit change, the analysis is provided for information only. The permit is not being reopened with respect to those issues. All comments must be received by May 24, 2005. The public may also request a public hearing for this reopening of the permit.

Reopenings of Major Facility Review Permits are also subject to review and approval by US EPA. If US EPA has not objected to a proposed permit and the District has not addressed a public comment in a satisfactory manner, the public may petition US EPA, Region IX, Operating Permits Section at 75 Hawthorne Street, San Francisco, CA 94105, within 60 days after the end of US EPA's review, to reconsider the decision to not object to the permit.
