NOTICE is hereby given that the Executive Officer/Air Pollution Control Officer of the Bay Area Air Quality Management District invites interested persons to submit written public comments on the proposed Significant Revision to a Major Facility Review Permit for the following Facility:

The main purpose of the proposed significant revision (Application # 11002) is to change permit conditions that have been revised under NSR application 11003. The proposed permit condition changes include the following:

Amend the definition of "hour" to "clock hour" since the facility's continuous emission monitors operate on a clock hour basis.

Condition #20134, part 18.2: Revise the ammonia slip monitoring language to agree with standard language in other Calpine power plant permits. The revised language will allow the use of a District-approved calculation method to monitor ammonia slip. This is not a relaxation of monitoring, but replaces the original calculation method that was inaccurate.

Condition #20134, part 24. Change the required source test frequency for the gas turbine from annual to every 8000 hours of gas turbine operation or once every 3 years, whichever comes first. This is a relaxation of monitoring and therefore is considered a significant revision pursuant to Regulation 2-6-226.3.

The Executive Officer/Air Pollution Control Officer invites written comment on the proposed significant revision to the permit. Comments must be received by December 4, 2006. The public may also request a public hearing for this significant revision.

Significant revisions of Major Facility Review Permits are also subject to review and approval by US EPA. If US EPA has not objected to a proposed significant revision and District has not addressed a public comment in a satisfactory manner, the public may petition US EPA, Region IX, Operating Permits Section at 75 Hawthorne Street, San Francisco, CA 94105, within 60 days after the end of US EPA's review, to reconsider the issuance of the permit.
