NOTICE INVITING WRITTEN PUBLIC COMMENTS

NOTICE is hereby given that the Executive Officer/Air Pollution Control Officer of the Bay Area Air Quality Management District invites interested persons to submit written public comments on the proposed Significant Revision to a Major Facility Review Permit for the following Facility:

The primary purpose of this revision is to institute permit condition changes that were previously approved under permit application 10568. The changes include the following:

Increase the daily facility mass emission limits for NOx and CO to reflect the potential operating scenario of 4 gas turbine start-ups per day.

Revise the ammonia slip monitoring language to agree with standard language in other Calpine power plant permits.

Change the required source test frequency for the gas turbine from annual to once every 8000 hours of gas turbine operation or once every 3 years, whichever comes first.

Delete obsolete permit conditions that apply to the commissioning period only.

The definition of hour will be revised to clock hour since the facility monitors emissions on a clock hour basis.

The facility name will be changed to "Gilroy Energy Center, LLC for the Riverview Energy Center".

There is no increase in annual facility emissions associated with the proposed changes to the permit. However, this proposal constitutes a Significant Permit Revision as defined by Regulation 2-6-226.3 because it includes a relaxation of an applicable monitoring condition.

The Executive Officer/Air Pollution Control Officer invites written comment on the proposed significant revision described above. Comments must be received by April 23, 2006. The public may also request a public hearing for this significant revision.

Significant revisions of Major Facility Review Permits are also subject to review and approval by US EPA. If US EPA has not objected to a proposed significant revision and District has not addressed a public comment in a satisfactory manner, the public may petition US EPA, Region IX, Operating Permits Section at 75 Hawthorne Street, San Francisco, CA 94105, within 60 days after the end of US EPA's review, to reconsider the issuance of the permit.
