#### COMMITTEE REPORTS AND RECOMMENDATIONS

#### 7. Report of the Personnel Committee Meeting of April 4, 2008

Director Brown presented the report and stated that the Personnel Committee met on Friday, April 4, 2008.

The Committee conducted an interview and reviewed applications of candidates to fill the regular and alternate Public member category positions on the Hearing Board.

The Committee recommends Board of Directors' approval of reappointments to the Air District's Hearing Board of: 1) Julio Magalhaes and Terry Trumbull to fill the Regular Public Member positions for a three-year term of office, effective immediately and expiring on April 2, 2011; and 2) Peter Chiu and Richard Grundy to fill the Alternate Public Member positions for a three-year term of office, effective immediately and expiring on April 2, 2011.

The next meeting is at the Call of Chair.

**Board Action:** Director Brown moved that the Board of Directors approve the report of the Personnel Committee; seconded by Director Shimansky carried unanimously without opposition.

#### 8. Report of the Executive Committee Meeting of April 10, 2008

The Committee received the Quarterly Report of the Hearing Board from Hearing Board member, Terry Trumbull; the Hearing Board dealt with 5 dockets over the past quarter and received a total of \$9,447 in hearing board fees. The Committee also received a Quarterly Report from the Advisory Council Chairperson, Dr. Louise Bedsworth. Chairperson Bedsworth provided the Committee with an overview of activities of the Advisory Council and its Standing Committees over the past quarter.

The Committee received an update on the progress made to date on the Production System. The Committee also received a demonstration on the production system. Staff provided a shortened version of the demonstration to the Board of Directors.

Finally, the Committee adjourned the Closed Session to discuss Air District labor negotiations. The Committee provided direction to staff. A report on the Committee's Closed Session discussions was held during Board of Directors' meeting under agenda item #10.

The next meeting of the Committee will be held Monday, May 12, 2008.

**Board Action:** Director Hill moved that the Board of Directors approve the report of the Executive Committee; seconded by Director Brown; carried unanimously without opposition.

Jeff McKay, Deputy Air Pollution Control Officer, provided the Board of Directors with a brief presentation and demonstration of the Production System Project.

Mr. John Chiladakis, Information Systems Manager provided the Board of Directors a demonstration of IRIS and Databank.

Mr. Chiladakis stated that the new system will allow searches to be conducted for each facility and the actual permit. Another feature will allow employees to view the location of the facility. In addition, the program will allow employees to view surrounding facilities and their permits.

Mr. Chiladakis concluded his presentation.

Director Bates inquired about the next phase. Mr. Chiladakis responded to Director Bates stating the next phase will include detailed design and development work. The target date of deployment for the entire project is 2010. Mr. Broadbent acknowledged that the Air District is proud of the work that has been done and recognized both Mr. McKay and Mr. Chiladakis and their team for their work.

Chair Hill commented the system is on schedule as proposed and less than the budget initially proposed. Chair Hill thanked both Mr. McKay and Mr. Chiladakis.

#### **Public Hearing**

9. Public Hearing to Consider Testimony on Proposed Amendments to the Air District's Regulation 3: Fees

Brian Bateman, Director of Engineering provided the Board of Directors' with the presentation. Mr. Bateman stated that there were 5 topics for discussion.

Background information included:

- Air District legal authority to assess fees to fully recover the direct and indirect costs of implementing and enforcing a program for control of air pollution from stationary sources.
- Fee revenue falls far short of program costs
  - For FYE 2007, fee revenue covered 58 percent of program costs resulting in a revenue gap of \$16.5 million
  - Revenue gap is filled by property tax revenue from the counties
- Cost recovery gap should be reduced
  - Fees must be increased by more than annual cost of living adjustments to narrow the cost recovery gap
- Under State law, permit fee increases are limited to 15 percent in any calendar year

Rule development schedule included:

- Draft fee regulation amendments issued
  - January 31, 2008
- Public Workshop (40 attendees)
  - February 25, 2008

- Committee Briefings
  - Budget & Finance: February 27, 2008
  - Climate Protection: March 13, 2008
- Public Hearings
  - April 16 and May 21, 2008
  - Amendments would be effective July 1, 2008

Details of proposed fee amendments include:

- Similar to fee amendments adopted last year, with the addition of a new Greenhouse Gas (GHG) fee schedule
- Would increase overall fee revenue by 13.9 percent from fee revenue projected for the current fiscal year

Revenue from amendments to existing fee schedules:

Revenue from new GHG fee schedule:

Overall increase in fee revenue:

\$2.3 million

\$1.1 million

\$3.4 million

- Increase in CPI for Bay Area was 3.2 percent
- Would target the Fee Schedules with the most significant cost recovery gaps for the largest fee increases

Mr. Bateman continued his presentation with an outline of the proposed amendments to the existing fee schedule.

Summary of public comments include:

- 20 comment letters received
- Concerns of opponents to GHG fee schedule:
  - GHGs should be regulated only at the State-level by CARB under the AB 32 program
  - Regional/local agency GHG standards of differing detail and stringency may result in:
    - o Inconsistencies
    - o Duplication
    - o Conflicts
  - Air districts lack the legal authority to regulate GHGs
  - CARB may be developing GHG fees to recover AB 32 program costs
- Revisions made to initial draft GHG Fee Schedule in response to comments received:
  - Use same GHG compounds, Global Warming Potential values, that CARB uses
  - Exempt biogenic CO2 emissions from GHG fees
  - Clarify that GHG fees apply only to permitted sources

Mr. Bateman concluded his presentation.

Director Ross requested that Air District collaborate with CARB.

Director Silva requested a further breakdown of the fee schedule.

#### **Audit of 2006-07 Financial Statements:**

The audit report for the District's 2006-07 financial statements was issued on February 19, 2008, in compliance with the *U.S. Office of Management and Budget (OMB)*Circular A-133 Compliance Supplement, and Government Auditing Standards. There were no audit findings or adjustments in the 2006-07 audit report. The audit report was presented by Gary Caporicci of Caporicci & Larson, Certified Public Accountants, at the February 27, 2008 Budget & Finance Committee meeting.

#### **PERP Fund Receipt:**

The Air District received \$148,084 from ARB the first payment for Portable Equipment Registration Program.

#### **Budget Development for Fiscal Year 2008-09**

The first draft of the 2008-09 Proposed Budget was mailed to the Board of Directors (Board) on March 12, 2008, and referred by the Board to the Budget and Finance Committee for its March 19, 2008 meeting; there will be a brief staff presentation at the Budget and Finance Committee on March 26, 2008.

Scheduling of a recycling brown bag presentation for Air District staff—hosted by the SF Dept. of the Environment. This session should take place in April.

#### **California Goods Movement Bond**

The ARB issued their draft staff report for the California Goods Movement Bond on January 3, 2008. As part of the report, the ARB is recommending the Bay Area receive \$3 million for truck retrofits and grid based shore power.

Additionally, based on further recommendations in the staff report, the Bay Area is slated to receive up to \$140 million (\$35 million per year) over the next four years.

#### **Outreach**

• Staff attended and spoke at a Port of Oakland workshop to discuss upcoming grant opportunities for drayage trucks.

#### **Program Development**

• Staff participated in workshops with the ARB to develop guidelines for the Goods Movement program.

Staff participated in Local Agency Consultation Conference call to assist ARB in development of Goods Movement Bond Guidelines, February 21, 2008.

Staff participated in Shore Side Power workgroup meeting, February 22, 2008.

Staff attended an ARB Board meeting at which the Goods Movement Guidelines were adopted, February 28, 2008. As part of this meeting, the Bay Area secured a 14% share in the overall Goods Movement Bond funding equaling \$35 million in the first fiscal year of the program and \$140 million in total over four years.

Staff submitted a grant request for \$40 million to replace goods movement trucks to MTC through the RTP 2035 on March 5, 2008.

The District received Biowatch and PM2.5 grant funds in the amount of approximately \$218,000 and \$186,000, respectively.

#### COMPLIANCE AND ENFORCEMENT - K. WEE, DIRECTOR

#### **Enforcement Program**

Staff issued public nuisance violations to Evergreen Oil Company in Newark for March 3, 5, & 6, 2008. The Air District received over 48 air pollution complaints and traced the odors to a thermal oxidizer that shut down on March 3, 2008. This unit abates the storage tank emissions.

On March 20, 2008, the Air District obtained a conditional abatement order from the Air District's Hearing Board against Livermore Beacon gas station for failure to pay \$5,360 in permit fees. Subsequently all outstanding fees were paid.

Staff met with representatives of Hanson Permanente Cement On January 8, 2008 and March 12, 2008 to discuss compliance issues at the plant. On February 1, 2008, California Air Resources Board (CARB) staff completed an applicability determination and concluded that Hanson is not subject to the ATCM for Naturally Occurring Asbestos.

Staff attended the CAPCOA Vapor Recovery Committee meeting in Sacramento on January 15, 16, and 17. On February 5, 2008, CARB informed districts that all Healy 900 vapor recovery nozzles manufactured in 2007 are considered defective. CARB advised districts of the agreement it had reached with the manufacturer to repair all nozzles by mid-April. District staff observed repairs at several of the gas stations.

#### **Compliance Assistance Program**

On February 26, 2008 staff presented information on the requirements of Regulation 5, Open Burning, to the Knightsen Town Council, Contra Costa County.

Inspection staff met with Contra Costa County Building Department staff to explain what requires a demolition asbestos notification.

Staff produced two Compliance Advisories on controlling Nitrogen Oxides emissions: Regulation 9, Rule 6, Natural Gas-Fired Water Heaters and Boilers, and Regulation 9, Rule 9, Stationary Gas Turbines.

Staff participated in the monthly Truck Work Group Meeting at the Port of Oakland. On March 18, 2008 staff met with representatives of Bayview Hunters Point to answer questions about the Lennar BVHP Parcel A project and the Naturally Occurring Asbestos Dust Mitigation Plan.

Translation from the Hindi, Korean, Punjabi and Spanish languages was provided for Division activities during the period.

#### **Compliance Assurance Program**

On February 14, 2008 staff attended the Contra Costa County Hazardous Materials Interagency Task Force meeting.

Staff has under evaluation two project-specific Flare Minimization Plan Updates from Chevron associated with their Renewal Project permit and has approved one for the Tesoro Coker Modification Project. In addition staff approved reporting procedures for Valero's Acid Gas Flare. Staff updated and posted to the Air District website flare data and graphs through December 2007.

#### **Operations**

Staff revised draft Regulation 6 Rule 3, Wood Burning Devices, and created Rule Summary and Frequently Asked Questions documents, which were posted on the Air District's website and mailed in advance of nine (9) public information meetings. The meetings, beginning April 14, 2008 running through April 30, 2008 will be held in the following locations: Concord, Livermore, Napa, Novato, Oakland, Redwood City, San Jose, Santa Rosa and Vallejo. Staff also completed a survey of firewood vendors within the Air District to establish the typical moisture content of firewood sold and the amount of wood sold annually as part of research in support of Reg. 6-3 rule development.

The 1<sup>st</sup> quarter In-Service Training sessions were conducted in January. HAZWOPER 8 hour refresher training was conducted in February. New inspectors completed the CARB Fundamentals of Enforcement (FOE) classes in February. VEE re-certifications were conducted in February and March.

#### **ENGINEERING DIVISION – B. BATEMAN, DIRECTOR**

#### **Permit Activity Summary**

In the 1st quarter of 2008, 616 new permit applications were received: 309 standard New Source Review applications, 260 Gasoline Dispensing Facility applications, 35 Title V applications, and 12 Banking applications. During this period, the Division issued 305 Authorities to Construct and 346 Permits to Operate.

#### **Toxics Program**

A total of 97 Health Risk Screening Analyses (HRSAs) were completed in the 1st quarter of 2008. The majority of these HRSAs were for diesel engine emergency generators, but HRSAs were also completed for soil remediation projects, gasoline stations, landfills, and petroleum refinery projects. Staff is continuing work on an HRSA for a major modification to the Chevron Refinery in Richmond.

Pacific Steel Casting (PSC) Company in Berkeley submitted a Health Risk Assessment (HRA) for the Air Toxics Hot Spots (ATHS) Program on September 24, 2007. District staff and the Office of Environmental Health Hazard Assessment (OEHHA) have reviewed the document and provided preliminary comments to PSC. The HRA triggers ATHS public notification requirements, but not mandatory risk reduction requirements. Air District staff conducted a community meeting in conjunction with PSC and OEHHA to discuss the HRA in Berkeley on January 9, 2008. Staff is currently reviewing public comments received regarding the HRA, and will soon be notifying PSC of several deficiencies that need to be addressed.

Staff participated in meetings of the CAPCOA TARMAC (Toxics and Risk Management) Committee. TARMAC has been active reviewing ATCMs (e.g., diesel engines), AERMOD and HARP modeling issues, and developing new health risk assessment guidelines for CEQA and Air Toxics Hot Spots Programs.

#### Title V Program

In the 1<sup>st</sup> quarter of 2008, Engineering Division staff completed various Title V permit revisions and renewals. Significant progress was made in preparing for the five-year Title V renewal applications for the five Bay Area petroleum refineries, which are due to be submitted by May 31, 2008. Several Title V permit revisions for the refineries were acted on in the 1<sup>st</sup> quarter of 2008; these revisions are intended to update and improve the permits prior to submittal of the renewal applications. Staff also held several meetings with refinery industry representatives to discuss issues associated with the upcoming renewal applications.

#### **Permit Evaluation Program**

Air District staff and EPA Region IX amended the Prevention of Significant Deterioration (PSD) Delegation agreement between the Air District and EPA. The amended PSD Delegation agreement was signed on February 4, 2008. Under the amended delegation agreement, the District is now primarily responsible for issuing and modifying PSD permits in the Bay Area.

Air District staff have identified six Bay Area facilities that are potentially subject to the federal Regional Haze standard in 40 CFR 51, Subpart P: Chevron Richmond Refinery, ConocoPhillips Refinery, Rhodia, Shell Martinez Refinery, Tesoro Refinery, and Valero Refinery. Modeling and applicability determinations are underway for these facilities; if these analyses indicate that sources at these facilities are subject to the standard, the Air District will have to include control measures in the State Implementation Plan.

Staff continued its review of the permit application submitted for Chevron's Energy and Hydrogen Renewal Project at the Richmond Refinery. Staff completed an update of the criteria and HAP emissions estimate for the project. The HRSA has also been re-run several times over the past quarter as emissions calculations are updated and refined. Air District staff is finalizing the BACT determinations, permit conditions, and the statement of compliance for the draft Engineering Evaluation. The Air District held a Community Meeting in Richmond on February 13, 2008, to discuss the permit evaluation for the project. The meeting was well attended and helped the public better understand both the proposed project and the Air District's permitting process. The Authority to Construct for the project cannot be issued until the EIR is certified by the City of Richmond, which is not expected to occur until June 2008 at the earliest.

A Hayward resident filed an appeal to the Air District's Hearing Board for the Authority to Construct issued for the Russell City Energy Center project in Hayward. A jurisdictional hearing was held on March 6, 2008. The Hearing Board dismissed the Appeal.

The Air District has issued a Final Determination of Compliance for the Eastshore Energy Center project in Hayward. The California Energy Commission Evidentiary Hearing for this project continued in January 2008. The CEC Presiding Member has not yet made a proposed decision on whether this project will receive a license.

In November 2006, PG&E acquired from Mirant, equipment, permits, and contracts to a partially completed 530 MW power plant in Antioch named the Gateway Generating Station (GGS). The Air District received an application from PG&E for modifications to switch from wet to dry cooling, and to include more shutdown/startup operations. The resulting increase in CO emissions requires new PSD modeling and issuance of a modified PSD permit. PG&E plans to start-up the GGS power plant in 2008 or early 2009.

Staff met with representatives of Mirant to discuss permitting issues for a proposed new power plant to be located adjacent to their existing Contra Costa Plant (and the partially built GGS) in Antioch. The proposed plant would have a capacity of 830 MW from two combined-cycle turbines and two simple-cycle turbines. The Air District has not yet received a permit application for this project.

Staff attended the San Francisco Board of Supervisor's Land Use Committee meeting on January 28, 2008. The Committee asked staff questions relating to the emissions and efficiency characteristics of the proposed San Francisco Electric Reliability Project (SFERP) compared to the existing Potrero Power Plant. The SFERP withstood a legal challenge filed by a public interest group in U.S. District Court to prohibit the issuance of the Authority to Construct. The Court dismissed the group's motion on March 28, 2007. The City of San Francisco recently surrendered the required emissions offset credits to the Air District, and the Authority to Construct for the SFERP is being prepared for issuance.

On February 25, 2008, the Air District sent EPA a proposed minor Title V modification for the Hanson Permanente Cement Plant in Cupertino. The minor revision incorporates the conditions of two NSR permits, one of which allows Hanson to increase the burning of coke from 8 tons/hr to 20 tons/hr. Staff is following up on a request from EPA regarding criteria pollutant emissions changes resulting from the increased petroleum coke usage. The required data analysis associated with this request is expected to be completed in May 2008.

Staff continues to handle its Responsible Agency responsibilities under CEQA for several proposed projects. Staff has provided assistance to the City of Richmond, the CEQA Lead Agency for the Chevron Renewal Project, and attended public hearings held to consider EIR certification. The public hearing for consideration of EIR certification for this project has been continued to June 5, 2008. Staff prepared comments on an Administrative Draft EIR prepared by Contra Costa County for a proposed Praxair hydrogen pipeline. Work is also underway in preparing comments to the City of Benicia on amendments to the EIR for the Valero VIP project.

Staff continues work to implement the CARB stationary diesel engine ATCM and portable diesel engine ATCM. The Division continues to receive many diesel engine permit applications. The District's Diesel Engine Workgroup met several times during the 1<sup>st</sup> quarter of 2008 to discuss and resolve issues.

Staff continued to participate in the District's Flare Workgroup. The Flare Workgroup is currently reviewing three Interim FMP updates (Chevron Renewal Project, Tesoro Coker Modification Project, and the Chevron/Praxair Project).

#### **Engineering Projects Program**

Staff continues to actively participate in the Air District's Production System project. Staff is developing policies, process, procedures and use cases for Engineering and Compliance & Enforcement work plans. Technical input was provided on the Authority to Construct/Permit to Operate process, the Title V Permit process, the Flare Report Inspection/Review process, and the Permit Renewal process.

The following new/revised BACT determinations were posted on the Air District website during the 1st quarter 2008: (1) CO emissions from IC engines at wastewater treatment plants, (2) coffee roasters between 110,000 and 3.5 MM BTU/hr, and (3) NOx and CO from refinery process heaters > 50 MM BTU/hr.

A number of existing Division policy documents have been updated and reformatted. These policies will be made available to the public via the Policy and Procedure Manual on the Air District website.

The majority of the Engineering Division staff attended a training course in February on Effective Permit Writing. The course was held at a nearby off-site location.

#### LEGAL DIVISION – B. BUNGER, DISTRICT COUNSEL

The District Counsel's Office received 222 Violations reflected in Notices of Violation ("NOVs") for processing.

Mutual Settlement Program staff initiated settlement discussions regarding civil penalties for 113 Violations reflected in NOVs. In addition, Mutual Settlement Program staff sent 10 Final 30 Day Letters regarding civil penalties for 14 Violations reflected in NOVs. Finally, Settlement negotiations by Mutual Settlement Program staff resulted in collection of \$64,820 in civil penalties for 66 Violations reflected in NOVs.

Counsel in the District Counsel's Office initiated settlement discussions regarding civil penalties for 27 Violations reflected in NOVs. Settlement negotiations by counsel in the District Counsel's Office resulted in collection of \$377,013 in civil penalties for 58 violations. Additionally, the District received \$97,500 in penalties from ConAgra Foods in connection with a settlement. The District also received \$308 from Kelly Engineer in connection with a secured judgment. Furthermore, \$55 was received from Tesoro in connection with resolution of Application for Variance #3543.

The District Counsel's Office represented the Executive Officer/APCO in successfully obtaining an Order for Abatement against Livermore Beacon for failure to maintain required permits to operate a retail gasoline dispensing facility. Livermore Beacon subsequently obtained valid current permits to operate.

#### **OUTREACH AND INCENTIVES - L. FASANO**

Spare the Air Summertime – For 2008, the Spare the Air program is being expanded to a year-round campaign. Staff is working to integrate climate protection messages and include partners to sponsor a broad range of incentives such as free transit, teleconferencing, discounts on bike rentals and rewards to schools.

**Spare the Air Tonight** – The close of the wintertime 2007/2008 *Spare the Air Tonight* campaign was announced in a press release on February 11, 2008. The 2007/2008 STAT campaign resulted in more than 300 TV, radio and print stories, 35,000,000 media impressions and an advertising value of more than \$600,000 regarding the District's comprehensive strategy to reduce particulate matter through the public education campaign, draft residential wood smoke rule, and proposed commercial cooking rule. This is an increase in media impressions and advertising value from last year; despite the issuance of only six STAT advisories this season - compared to 30 advisories issued last year.

Behavior change and recognition of the STAT campaign also improved in the 2007/2008 season:

- 18 percent of households with at least one wood-burning device reported not burning wood this winter or a reduction in wood burning for reasons that can be attributed to the campaign. (slightly higher than the 17.6 percent in 2007)
- 62 percent recalled hearing, reading or seeing Spare the Air related news, stories and/or advertisements (also higher than the 56 percent reported in 2007)

Media coverage of the 2007/2008 *Spare the Air Tonight* program and the Air District's wood smoke reduction efforts received an average of 25 media articles per week - *equal to the average amount of media coverage received during the 2007 Spare the Air summer campaign*.

#### **Public Information and Media**

During the quarter, 246 print stories were published, and more than 52 radio and television stories aired on a variety of topics concerning the Air District, including: the draft residential wood smoke reduction rule, *Spare the Air Tonight*, the Climate Change grant program, health impacts of wildfires, and emissions from the Port of Oakland. During this period, 64 media calls were fielded, and more than 1,100 inquiries and requests for information were answered.

During the quarter, the Air District issued 11 press releases. Topics included *Spare the Air Tonight*, the fireplace and woodstove change out program, announcement of open burn season, Carl Moyer Program call for projects, landmark settlement with Tesoro Refinery, \$3.4 million award to the Port of Oakland for air quality projects, and draft wood smoke regulation.

The Air District sponsored the Golden State Warriors game against the Chicago Bulls, at Oracle Arena in Oakland on February 7, 2008 to promote the 2007/2008 STAT campaign. Staff conducted public outreach at the Annual KCBS Health Etc. event on February 2, 2008. The Air District's Executive Officer introduced the keynote speaker author Dr. Mehmet Oz. He also presented in a panel discussion with Dr. Gerber, Associate Professor at UCSF, on effects of particulate pollution on health.

Staff presented recommendations for the extension of four public outreach contracts to the Public Outreach Committee on Thursday, February 14, 2008. These contracts are for Advertising Design & Production, Media Relations & Employer Program, Community Outreach Services, and Public Opinion Research. The contract extensions were approved by the Board of Directors on Wednesday, February 20, 2008 to provide continuity in the 2008 season and improve timing of issuance of future Request for Proposals (RFP).

Staff coordinated communications in response to the release of the ARB's West Oakland Health Risk Assessment (HRA) on March 19, 2008.

#### **Community Outreach**

**Bay Area Environmental Health Collaborative (BAEHC)** - The Air District's Executive Officer Jack P. Broadbent, along with several staff members met with members of the BAEHC on January 29, 2008 to discuss the goals and priorities of their collaborative as it relates to the Air District. Items discussed include cumulative impacts, pollution reduction, public participation, and collaboration. Both the Air District and the BAEHC agreed to continue a dialogue about goals of both organizations.

Chevron Energy and Hydrogen Renewal Project Community Meeting – Staff coordinated the public outreach for the Chevron Energy community meeting. This included notification to Bay Area Environmental Health Collaborative, Communities for a better Environment, West County Toxics Coalition, the District's Resource Teams, the Contra Costa Times, West County Times, and the Globe. Staff created ground rules, set up, and assisted community members who spoke. Over 120 people participated including Air District staff, Chevron representatives, the City of Richmond, and community members.

Carl Moyer Informational Workshop/San Francisco Clean Construction Ordinance This joint Carl Moyer and San Francisco Clean Construction Ordinance (CCO) workshop was held to advise San Francisco Construction companies, City Staff and interested parties the requirements of the SF CCO which will be implemented in June 2008. Grants staff presented an overview of the Carl Moyer application process and the City of San Francisco provided an overview of their Clean Construction Ordinance which will require city contractors performing major projects (longer than 20 days) to start using cleaner equipment and biodiesel fuel near sensitive sites like schools and hospitals.

**CARE Task Force** –Community Outreach staff arranged and staffed six community meetings in support of the Task Force's six "priority" areas. These meetings included an overview of the CARE Program, the District's Grant and Incentive Funds, and allowed time for community feedback and participation. Other presentations included a status update on the CARE Program and an overview of the CARE Mitigation Action Plan.

Faster Freight for Cleaner Air – Community Outreach and Planning staff attended the Faster Freight for Cleaner Air Conference in Los Angeles. Staff networked with freight movement operators, Port officials and private and public businesses to promote the Air District's Grant and Incentive Funds. The Air District distributed community outreach materials, Spare the Air information, and overview information on the Carl Moyer Program to conference participates.

West Oakland Health Risk Assessment (HRA) Meeting – Staff coordinated the public outreach and logistics for the West Oakland HRA meeting. Outreach consisted of notification to Bay Area Environmental Health Collaborative, Communities for a Better Environment, West County Toxics Coalition, and the District's Resource Teams. Staff facilitated meeting reservation logistics, provided logistical support during the meeting, and was on-hand to address any questions and concerns.

**Carl Moyer Informational Workshop Meeting** – Staff assisted with the outreach and approved all outreach materials produced by the grant staff, assisted the grant staff at seven Carl Moyer Informational Workshops held throughout the District.

Goods Movement Program Community Meeting (I-Bond) – Staff assisted with the outreach and meeting logistics for the community meeting in West Oakland. Approximately fifty members of the community, truck owners and operators and business representatives were in attendance.

**Proposed Wood-burning Device Rule Outreach** – Staff coordinated outreach for the nine informational meetings on the proposed wood-burning device rule scheduled to be held during the month of April. Staff notified approximately 1,000 individuals, 200 civic, environmental, and health organizations in the Bay Area. In addition, staff efforts resulted in seventeen cities and one county posting the notice of the community meetings on their websites. This included the cities of Calistoga, Gilroy, Hercules, Livermore, Los Gatos, Martinez, Mill Valley, Moraga, Napa, Piedmont, Rohnert Park, Sebastopol, Sonoma, Sunnyvale, South San Francisco and Vallejo. Seven newspapers posted notice of the meetings in their community calendars.

#### PLANNING DIVISION – H. HILKEN, DIRECTOR

#### **Community Air Risk Evaluation (CARE) Program**

Staff identified six impacted communities – based on air toxics emissions and vulnerable populations – warranting focused risk reduction activities through the CARE Mitigation Action Plan: Richmond, Concord, Eastern San Francisco, West Oakland, East Oakland/San Leandro, and San Jose. Maps were prepared to direct Carl Moyer funds to these communities. On March 4, 2008, staff convened a CARE Task Force meeting that focused on the Air District's CARE Mitigation Action Plan, including the Air District's incentive programs, community outreach meetings for the six impacted communities, and the development of land use guidance for cities and counties. On March 19, 2008, staff participated in a community meeting with ARB and the Port of Oakland to present a draft summary of the West Oakland Health Risk Assessment (HRA) at the West Oakland Senior Center. The draft HRA revealed that residents of West Oakland have about three times the cancer risk from diesel PM emissions than the Bay Area average. Most of the risk was shown to be due to on-road trucks on local streets and freeways. The final HRA is expected to be completed in June 2008. Staff met with San Jose City Council members, City staff, staff from the San Jose Airport and staff from Supervisor Liz Kniss' office to present background on the CARE program and discuss air quality around the airport. During this quarter, staff participated in the first two of six community meetings in the impacted areas, meeting with community members and local officials in the Cities of Richmond and San Leandro.

#### **Air Quality Planning Program**

Staff continued processing contracts for the 53 grant awards under the Climate Protection Grant Program. Staff participated in AB 32 Scoping Plan workshops and related AB 32 implementation work group meetings. Staff is a member of ARB's Local Government Operations Emission Inventory Protocol Development Workgroup for AB32

implementation. Staff co-convened, along with the San Francisco Foundation, a second meeting of private foundation funders to discuss regional needs and opportunities for funding of climate protection in the Bay Area. Staff hosted a one day community-wide GHG emission inventory development workshop for local governments in Marin County. The Air District co-sponsored and staff participated in the Local Government Commission/Attorney General's CEQA and Climate Change Workshop. Staff oversaw implementation of the pilot phase of the Air District's 4<sup>th</sup> and 5<sup>th</sup> grade climate protection curriculum and developed an RFP for implementation of the climate protection curriculum for the 2008 - 2009 school year. CAPCOA released a white paper on CEQA & Climate Change: Evaluating and Addressing Greenhouse Gas Emissions from Projects Subject to the California Environmental Quality Act; development of the white paper was led by Air District staff.

Staff continued to collaborate with MTC on preparation of the T-2035 RTP update, including participating in the Partnership Ad Hoc Committee on developing performance measure to evaluate projects submitted to MTC for funding. Staff continued to participate in the FOCUS (Focusing our Vision) regional smart growth initiative in collaboration with ABAG, MTC, and BCDC, including serving on the FOCUS Station Area Planning Grant review committee. Staff met with staff of the San Francisco Department of Public Health to discuss the Department's draft land use guidance document on local air quality impacts from roadways. Staff continued participation in the Alameda County Public Health Department General Plan Workgroup. Staff participated in the Port of Oakland Maritime Air Quality Improvement Plan Task Force.

#### **Rule Development Program**

Staff updated the Stationary Source Committee on proposed amendments to Regulation 9, Rule 7: Nitrogen Oxides and Carbon Monoxide from Industrial, Institutional, and Commercial Boilers, Steam Generators and Process Heaters and Regulation 8, Rule 20: Graphic Arts Printing and Coating Operations. Staff scheduled a public workshop on proposed amendments to Regulation 9-7. Staff spoke at the Multiunit Foodservice Equipment Symposium in Austin, Texas regarding District rule development processes. Staff visited the Shell and Conoco-Phillips refineries to review coking and coke cutting operations as development of further study measure FS-13: Wastewater from Cokecutting Operations. Staff developed an RFP, and received and considered bids for hiring a socioeconomic contractor.

#### **Research and Modeling Program**

Staff continued working on modeling and data analysis to estimate the impact of PM emissions from wood-burning and diesel engines as well as the effects of transported PM from the Central Valley on the Bay Area's ambient PM levels. Staff performed analyses to determine meteorological conditions conducive to 24-hr PM2.5 exceedances in the Bay Area. Staff presented results obtained from the recent PM2.5 data analysis and modeling to the Advisory Council Technical Advisory Committee. Staff participated in several Central California Ozone Study and California Regional Particulate Air Quality Study Technical Committee meetings to discuss the status of on-going projects and the development of new projects. Staff supported the CARE Program, including improved estimation of toxicity levels assigned to the CARE emissions inventory based upon ambient measurements in the Bay Area, preparation of emissions and demographic maps

used for the CARE Mitigation Action Plan, and preparation of materials for a CARE Task Force meeting.

#### **Special Projects**

Staff continued preparation of the Base Year 2005 emission inventory and responded to requests on emissions data. The 2006 point sources detailed emission report was completed and sent to ARB. Staff continued working on updating the Greenhouse Gas emission inventory for the Bay Area. Staff refined the point source GHG emissions data for use in developing the proposed GHG fee schedule. The District's 2006 GHG inventory was approved by the California Climate Action Registry. Staff supported the CARE Program, including analysis of Bay Area construction emissions and review and comment of the Port of Oakland Health Risk Assessment Summary Report.

#### TECHNICAL DIVISION – G. KENDALL, DIRECTOR

#### **Air Quality**

During the first quarter of 2008, Bay Area  $PM_{2.5}$  levels exceeded the 35  $\mu$ g/m3 24-hour national standard on three days. The first exceedance of the year was at San Jose on January 1, 2008. After a period of stormy weather, the next dry period produced exceedances at San Jose on January 15, 2008 and at Vallejo on January 19, 2008. Thereafter,  $PM_{2.5}$  levels remained low as another rainy period lasted into early February, followed by unsettled weather the remainder of the quarter. Typically there are no  $PM_{2.5}$  exceedances after the first week in February.

The winter Spare the Air Tonight program began on November 13, 2007 and ended on February 11, 2008. Air District filter-based  $PM_{2.5}$  monitors recorded 7 days when the 24-hour national  $PM_{2.5}$  standard was exceeded during the 2007-2008 winter season compared to 20 days during the 2006-2007 winter season. The decrease was due to frequent weather systems moving across northern California with breezy conditions which kept the air well mixed.

#### **Air Monitoring**

31 air monitoring stations were operational from January through March 2008, with all equipment operating on routine, EPA-mandated schedules. The increased wintertime sampling schedule for  $PM_{2.5}$  began at designated stations on October 1, 2007 and ended on March 31, 2008. Ozone monitors at six satellite stations were shut down during the low ozone season on December 1, 2007, as allowed under a waiver granted by the EPA. Those six ozone monitors resumed operation on April 1, 2008.

#### **Meteorology and Forecasting**

The 4<sup>th</sup> quarter 2007 air quality data were quality assured and entered into the EPA Air Quality System (AQS) database. Staff continued to make daily air quality, Spare the Air Tonight, open burn, and marsh burn forecasts. The final draft Technical Services Division Quality Management Plan (QMP) and Quality Assurance Project Plan (QAPP) were completed and submitted to EPA Region IX for review. Quarterly calibrations of the Air District meteorological network were completed.

#### **Quality Assurance**

The Quality Assurance (Q/A) Group conducted regular, mandated performance audits on 81 analyzers at 27 Air District monitoring stations. Staff also participated in ARB audits at 15 Air District monitoring stations.

The Q/A staff also audited the Hydrogen Sulfide (H<sub>2</sub>S) and Sulfur Dioxide (SO<sub>2)</sub> monitors at the Tesoro Refinery, the Valero Refinery, and the Chevron Refinery Ground Level Monitoring (GLM) networks. All of the GLM monitors passed the audit.

Q/A staff assisted EPA Region IX staff and contractors with the testing of their transportable audit system at the Benicia and San Rafael air monitoring stations.

#### Laboratory

In addition to routine ongoing analyses, the laboratory performed an extensive microscopic analysis of a used filter taken from the ventilation system of a building in the  $4^{th}$  and Berry area of San Francisco.

The laboratory analyzed one gaseous sample taken from the vapor stream of a tank at Conoco Phillips Refinery for hydrocarbons and reduced sulfur gases.

The laboratory began analyzing samples from the new west Berkeley Air Monitoring station for toxic and carbonyl compounds.

The laboratory also upgraded instrumentation and updated analytical methods to improved detection limits for all toxic compounds.

The laboratory began analyzing samples from the San Jose National Air Toxics Trends Study (NATTS) site for acrolein as well as acrylonitrile, acetonitrile, and ethanol.

#### **Source Test**

Ongoing Source Test activities during January, February, and March of 2008 included Continuous Emissions Monitoring (CEM) Field Accuracy Tests, source tests, gasoline cargo tank testing, and evaluations of tests conducted by outside contractors. The ConocoPhillips Rodeo Refinery's open path monitor monthly reports for December, January, and February were reviewed. The Source Test Section participated in the District's Rule Development efforts and Business System Analysis for the new production system.

Re: Consideration of New Bills and Corresponding Agency Positions

#### RECOMMENDED ACTION:

Review bills and recommend positions for full Board of Directors consideration.

#### **DISCUSSION**

Staff are bringing a number of bills to the Committee for consideration. Generally, fewer bills were introduced this year that would address air quality issues. Here are brief analyses and staff's recommended positions on some significant air quality measures. Copies of the bills are attached.

#### AB 2094 (Mark DeSaulnier, D-Martinez); staff recommendation: Support

This two-part bill would formally add the Bay Conservation and Development Commission (BCDC) to the existing Joint Policy Committee (JPC), and would also authorize BCDC to develop regional strategies to address sea-level rise. Staff recommends a "support" position on the bill based on its plan to include BCDC with the District, MTC, and ABAG on the JPC. In March of 2007, the JPC voted to seek legislation to formally add BCDC to the Committee. At the time of this writing, the author knows of no opposition to the bill, and it is supported by BCDC, MTC, and ABAG.

#### AB 2241 (Lori Saldana, D-San Diego); staff recommendation: Support if amended

This bill is ostensibly designed to close a loophole that allows motorists to register their cars but delay or even avoid getting them smogged. Last year, the Committee discussed and the District supported another bill authored by Assembly member Saldana on the same topic. That measure, AB 218, took the straightforward approach of requiring a completed, passing smog check by the date the registration fees are due. If the smog check was completed after that date, the existing late fee structure that currently applies to motorists late paying their registration fee would also apply for a late smog check. The Department of Motor Vehicles (DMV) waited until 10 days before the end of the 2007 legislative year to express their opposition to the bill. In the face of that opposition, the author decided to hold AB 218 and work with the DMV in 2008 on a strategy to close the loophole.

AB 2241 is the result of this work, and the measure is sponsored by the DMV. The bill would allow motorists who are late completing their smog check to instead pay a \$35 fee to the DMV, which would allow them to operate their unsmogged or failing vehicle legally for another month or two. Unfortunately, they could repeat this process indefinitely under the bill. Thus staff believes that this year's bill does not close the loophole, and should be strengthened. The author's office has signaled support for the District's involvement, and welcomes a stronger bill.

Thus staff recommends a "support if amended" position. Recommended amendments would both increase fees over time for motorists who are late smogging their vehicles and a cap on the amount of time that the non-compliant vehicle can be driven.

#### AB 2922 (Mark DeSaulnier, D-Martinez); Staff recommendation: Support

This bill updates the section of state law that provides penalty authority to the Air Resources Board (ARB) to clarify its authority over more than just on-road motor vehicles. It is sponsored by the ARB. In 1976, ARB was given authority to impose penalties for violations of its regulations governing emissions from motor vehicles. However, under the California Clean Air Act of 1988, ARB gained substantial new authority over sources of pollution other than vehicles. For example, ARB regulations now cover such sources as small off-road equipment such as chain saws and leaf blowers, off-road diesel engines used in construction, industry, and agriculture, portable gas cans, and spark-ignition engines used in forklifts, airport ground support equipment, and elsewhere. For all of these categories of equipment, ARB mandates through regulation the amount of emissions that each is allowed. If manufacturers violate those emissions limits, or if vendors sell equipment that does not meet the California standards, air quality suffers.

ARB has imposed penalties for violations of its regulations on these pollution sources, despite the fact that the 1976 statutory language has not been upgraded to reflect ARB's increased authority. ARB believes that if the language is upgraded, it will avoid any legal challenges to its ability to impose non-vehicle penalties. AB 2922 simply adds to the existing penalty authority violations of ARB regulations to other sorts of equipment. ARB Chair Mary Nichols has requested the District support this measure, and staff recommend a "support" position.

#### AB 2991 (Speaker Fabian Nunez, D-Los Angeles); Staff recommendation: Support

Like the previous bill, AB 2991 is also sponsored by the ARB, and Mary Nichols has also requested the District support this second bill. The bill would add two new members with climate change expertise to ARB's Research Screening Committee (RSC). ARB currently funds a wide variety of research into a wide range of topics, from health impacts to technology advancing work to economic impacts of air pollution. State law establishes the RSC to advise ARB on which proposals are worthy of funding, and specifies that this committee shall consist of 'physicians, scientist, biologists, chemists, engineers, meteorologists' and others with expertise in traditional air pollution fields. Given the passage of AB 32, and ARB's increased responsibilities and research around climate protection, it wants to add climate change expertise to the RSC. Staff recommends a "support" position, and knows of no opposition to the measure.

#### AB 2522 (Juan Arambula, D- Fresno); Staff recommendation: Oppose unless amended

Currently, when a motor vehicle is registered in the Central Valley, a \$7 annual registration fee surcharge for clean air programs is addressed. This generates \$18 million annually for the San Joaquin Valley Air Quality Management District (SJVUAQMD) to use for a wide range of programs. If AB 2522 were to pass, the SJVUAQMD would be authorized to collect up to \$37 per vehicle to expedite their attainment of federal and state clean air standards. This would generate up to \$94 million annually.

While the majority of the bill language focuses on the increased fee on vehicles registered in the SJVUAQMD area, the bill also contains a section on fees on vehicles that are registered elsewhere in the state that travel through the Central Valley. Effectively, this section of the bill requires a study, to be done by the SJVUAQMD, on 'the manner in which vehicle license fees or other types of fees could be imposed on' vehicles from other parts of the state that drive in the Central Valley. At some point, almost all vehicles in the state drive in air basins other than where they are registered, including in the Central Valley. Similarly, Central Valley vehicles routinely drive other places as well. Staff recommend a position of "oppose unless amended" on this bill.

While staff sees no problem with SJVUAQMD attempting to raise fees on vehicles registered in its jurisdiction to help address their serious emission problems, efforts by one district to raise funding from vehicles in other basins heightens tensions between regions and should be discouraged. Staff recommends that the bill be amended to eliminate this section. The bill is opposed by the South Coast Air District (for the same reasons) and is also opposed by the California Automobile Association, and roughly 50 business, trade, and anti-tax organizations. It is supported by some environmental organizations, and the SJVUAQMD.

#### SB 375 (Darrell Steinberg, D-Sacramento); Staff recommendation: Support

This measure attempts to cut greenhouse gas emissions by influencing transportation and land use planning to reduce vehicle miles traveled, and was discussed by the Committee at length at its last meeting. Both the League of Cities (League) and the California State Association of Counties (CSAC) then had "oppose unless amended" positions on the bill. Since that meeting, CSAC has formally adopted a "support if amended" position, and detailed requested amendments both in writing and in a series of subsequent meetings with the author and sponsors of the bill. Both the author's office and CSAC staff have indicated that they expect to be able to address CSAC's concerns. A number of organizations have taken positions on the measure since the Committee's last meeting. Staff will provide the Committee a current list of both supporters and opponents at the meeting on April 21st. Staff recommends a "support" position on the bill.

Lastly, staff have attached a much longer list of bills with air quality impacts, and are prepared to answer questions from the Committee on any of these measures. Some measures are still being amended from very brief, place-holder language into full blown bills at the time of this writing. Thus, staff may present a few additional bills to the Committee on April 21<sup>st</sup> with recommended positions.

#### RECOMMENDED ACTION:

Consider recommending that the Board of Directors: (1) authorize the Executive Officer/APCO to solicit bids and execute agreements for the Production System project not to exceed \$1,250,000; (2) transfer a corresponding amount from the Designated Reserve for this purpose, and adjust the Air Districts' FY 2007/08 Information Systems budget accordingly and; (3) approve staff's recommendation to transfer \$2,800,000 from the Undesignated Reserve into the Reserve for Production System.

#### **DISCUSSION**

After a careful phase of scoping work, Air District staff presented a detailed Production System project plan which was approved by the Board in December of 2006. Execution of the plan has been accompanied by detailed reports on the status of actual costs as compared to projected costs, and by detailed reports on the status of actual accomplishments as compared to projected accomplishments.

The Project is composed of nine phases. The cost of the first four phases is firmly targeted at \$2.8M in total. The cost of the remaining five phases is expected to total an equal amount (\$2.8M) bringing the total estimated project cost to \$5.6M. As originally proposed, further refinement of the cost target for the final five phases will be facilitated by completion of the first four phases.

The Board has appropriated \$1,550,000 from the Designated Reserve. Staff now recommends that the remaining \$1,250,000 be appropriated from the original \$2,800,000 Designated Reserve, and that authorization be granted to issue purchase orders not to exceed the \$1,250,000.

Staff also recommends that additional Designated Reserves of \$2,800,000 be set aside by transfers from the Undesignated Reserve to bring the total transfers (expended and unexpended) to the \$5.6M originally projected.

### BUDGET CONSIDERATION/FINANCIAL IMPACT

Staff's recommendation would result in a transfer of \$1,250,000 from the Designated Reserve and a corresponding increase in the Air Districts' FY 2007/08 Information Systems budget. #### **BACKGROUND**

Since 1991, the *Spare the Air* campaign has worked to persuade the public to adopt practices that promote long-term behavior change to protect air quality. Historically, the *Spare the Air* program has been an episodic public outreach campaign with advisories being issued to the media, individuals, employers, schools and public agencies whenever air quality was forecast to be unhealthy. The 2008 summertime ozone season runs from Monday, June 2 – Friday, October 3, 2008.

#### **DISCUSSION**

For 2008, the *Spare the Air* program has been expanded to a year-round campaign and will include partners, climate protection messages and a broad range of incentives such as free transit, teleconferencing, discounts on bike rentals and rewards to schools. The extensive advertising such as commercials on television, radio, internet, in theater and community outreach that have made the *Spare the Air* campaign so successful will continue. As in previous years, the Air District will conduct telephone surveys to collect data regarding public behavior on all *Spare the Air* days and on "normal", or, non-*Spare the Air* days.

The incorporation of a climate protection focus into the Spare the Air campaign is a natural progression due to the strong connection between air quality and climate. The campaign will inform the public about the causational link between air quality and climate change and persuade them to modify their behavior not just during poor air quality days, but every day.

### BUDGET CONSIDERATION/FINANCIAL IMPACT:

Funding for the *Spare the Air* Program comes from three sources: Congestion Mitigation Air Quality (CMAQ) funding, the Transportation Fund for Clean Air (TFCA) program, and General Revenues.

#### RECOMMENDED ACTION:

#### **BACKGROUND**

Staff will present a summary of public outreach conducted to increase public understanding and awareness of the Air District's comprehensive Wood Smoke Reduction Strategy which includes: the Wood Smoke Reduction Rebate Program, the proposed Regulation 6, Rule 3; Wood-Burning Devices, and the Spare the Air Tonight Program.

#### **DISCUSSION**

In December of 2006, the US EPA adopted more stringent Particulate Matter (PM2.5) standards, increasing the health protectiveness of the national 24-hour standard from 65 micrograms/m3 to 35 micrograms/m3. The Air District has developed a comprehensive Wood Smoke Reduction Strategy to reduce PM 2.5 to meet the EPA standard and protect public health.

#### WOOD SMOKE REDUCTION REBATE PROGRAM

For fiscal year 2007/2008, the Air District committed \$500,000 in incentives for Bay Area residents to switch their wood-burning home heating devices to cleaner-burning alternatives. The first phase of the program began on January 15, 2008, with \$100,000 distributed in partnership with the Hearth, Patio & Barbecue Association and associated retailers. The remaining \$400,000 was disbursed through a District rebate program which opened on April 7, 2008.

#### Rebate Program Highlights:

- Issued press releases announcing the beginning and end of this program.
- Feature stories in television and print media.
- Approximately 850 rebates and discounts issued through these offers.

#### Regulation 6, Rule 3; Wood-Burning Devices

Last fall, the Air District began conducting outreach to support the rule development process of Regulation 6, Rule 3, to reduce Particulate Matter (PM) emissions from wood-burning devices. The Air District's public education efforts are focused on informing the public of the adverse health effects of particulate matter in wood smoke, and how to comply with Regulation 6, Rule 3.

#### Rule Outreach Highlights:

- Assisted Enforcement in coordinating, advertising, and staffing seven public informational meetings during Fall 2007, and nine additional meetings during April 2008.
- Issued press releases announcing the beginning and end of this program.
- Feature stories in television and print media.
- Prepared and distributed PM tip cards, bookmarks, and other educational materials.

#### SPARE THE AIR TONIGHT

Staff is currently developing the outreach campaign for the winter 2008/2009 Spare the Air Tonight program. The upcoming program will include the following elements:

- Emphasis on health consequences from exposure to PM.
- Advertisements and public service announcements on television, radio, web, and in-theatre.
- Community and employer event boothing throughout the region.
- Media advisories for Spare the Air Nights, and press releases on key dates.
- Distribution of "Spare the Air Tonight" marketing materials to employers, health clinics, and public agencies.
- Translation of materials for Spanish and Chinese language speakers.
- Op-ed and editorial board meeting with the Executive Officer.
- Surveys conducted on Spare the Air Nights.

#### BUDGET CONSIDERATIONS/FINANCIAL IMPACT

Funding for the campaign was included in the 2007-08 budget, and proposed 2008-09 budget.

Re: Overview of the West Oakland Health Risk Assessment

#### RECOMMENDED ACTION:

Informational report; receive and file.

#### BACKGROUND

The Air Resources Board (ARB), in cooperation with the Air District, the Port of Oakland, and the Union Pacific (UP) Railroad, conducted a modeling study to estimate the health risks from diesel exhaust in West Oakland. Draft summary results were released on March 19, 2008. Final results are expected in June 2008.

The study was designed to evaluate the health impacts of current and future diesel particulate matter (PM) emissions from sources within three geographic areas in West Oakland: the Port (Part I), the UP Railyard (Part II), and local freeways and other sources near the West Oakland community (Part III). This information will assist in efforts to reduce diesel PM emissions by helping to identify the sources that have the greatest impact on potential health risks to nearby residents and by providing a tool to evaluate impacts of measures adopted, planned, and under development to reduce diesel PM emissions. In addition, information from this study is being used to satisfy UP Railroad and ARB's commitment under the Statewide Railroad Memorandum of Understanding, wherein health risk assessments are required for each major railyard. This study follows a number of previous health risk assessments of major sources of diesel PM within California, such as those at the Roseville railyard and the Ports of Long Beach and Los Angeles.

The study evaluates impacts of diesel PM emissions in 2005 from the following sources: trucks at the Port and on local roads and freeways, Port and non-Port ships, locomotives, harbor craft, cargo-handling equipment, truck-related businesses, and stationary sources.

#### **FINDINGS**

The impacts from diesel PM emissions on the West Oakland community as well as on the broader regional San Francisco Bay Area were evaluated in this study and the following key findings were made.

- The West Oakland community is exposed to diesel PM ambient concentrations that are almost three times the average background diesel PM concentrations in the Bay Area.
- The estimated lifetime potential cancer risk for residents of West Oakland from exposure to diesel PM emissions is about 1,200 excess cancers per million.
- Diesel PM emissions increase lifetime potential cancer risk in West Oakland by about 200 excess cancers per million from Port operations, about 40 excess cancers per million from the UP Railyard, and about 950 excess cancers per million from non-Port and non-UP sources.
- The emissions from on-road heavy-duty trucks result in the largest contribution to the overall potential cancer risks levels in the West Oakland community, followed by ocean going vessels, harbor craft, locomotives, and cargo handling equipment.
- On a regional basis, diesel PM emissions from Port operations impact a very large area, about 550,000 acres with more than 3 million people. Overall, the Port emissions result in a regional population-weighted potential cancer risk of about 27 in a million. Emissions from ocean going vessels emissions are the largest contributor to the regional risk due to Port-related activities.
- On a regional basis, diesel PM emissions also result in non-cancer health impacts. Due to diesel PM from Port operations, there are an estimated 18 premature deaths per year, 8 hospital admissions for respiratory and cardiovascular problems, about 290 cases of asthma-related and other lower respiratory symptoms, and 15,000 minor restricted activity days.
- Diesel PM emissions and the associated health risk may be reduced by up to 80 percent by 2015 in the West Oakland community if ARB's regulatory actions, including adopted and proposed regulations are fully implemented.

#### **DISCUSSION**

The study found that people living in the West Oakland community are exposed to unhealthy levels of diesel PM emissions. These emissions are expected to decline as adopted and planned regulatory programs are implemented.

In the draft summary report ARB recommends maximizing emission reductions, leveraging existing funding sources, fully implementing ARB regulations, and undertaking additional studies of truck operations in West Oakland. Of particular importance are the adoption and full implementation by ARB of regulations to be considered later this year for on-road trucks and ship main engines.

The Air District has been, and continues to be, a very active participant in the study. The Air District assisted in developing the emission inventory used in the HRA modeling. The Air District has co-hosted community meetings at key phases of the study. The Air District has the modeling system used to conduct the HRA running on Air District computers. The Air District also co-chairs the Port of Oakland Maritime Air Quality Improvement Plan process, whereby the Port has recently announced that they would seek 85 percent reduction in diesel PM emissions by 2020.

The Air District has also prepared the CARE Mitigation Action Plan. The CARE action plan includes the following major elements:

- Identify priority communities where toxic air emissions are highest and risk reduction measures are most needed.
- Focus grant funding in impacted communities, such as West Oakland, to accelerate the reduction of diesel emissions.
- Conduct community outreach meetings, such as those recently held in each of the six communities identified by the CARE program, to understand local community concerns with respect to sources of toxic air contaminants and to help identify emission-reduction priorities within the community.
- Develop local land-use guidance to identify incompatible land uses, develop set-back recommendations, and develop other risk reduction recommendations.
- Update CEQA guidelines related to air toxics.
- Increase collaboration with public health officials.

The Air District is working with consultants and the Port of Oakland to design a measurement study that will help to evaluate the HRA modeling and help track trends in particulate matter in West Oakland. Finally, the Air District is working with the West Oakland Indicators Project and other community members to survey diesel truck activity to provide a refined estimate of on-road truck activity in West Oakland and to provide an improved apportionment of Port versus non-Port truck emissions.
