Re: Conduct Interviews of Candidates to Fill the Regular and Alternate Member  
Positions for the Public Member Category on the Air District's Hearing Board

RECOMMENDED ACTION:

Conduct interviews and consider recommending Board of Directors approval of appointments of candidates to fill the regular and alternate positions in the Public Member category on the Air District's Hearing Board.

BACKGROUND

Pursuant to Section 40800 of the California Health and Safety Code the Air District is required to maintain a Hearing Board consisting of five members. Section 40801 (d) requires that two public members be appointed and appoint one alternate member for each of the positions, provided that the alternate has the qualifications specified in Section 40801.

DISCUSSION

The terms of office for the two public members and their alternates will expire on April 2, 2008. Of the four positions with terms expiring, all four incumbents have expressed an interest in re-appointment. Six non-incumbents applied and were screened to determine their qualifications for the position. One of the six possessed the qualifications required.

The interview of the non-incumbent candidate will take place on Friday, April 4, 2008 and will begin at 9:40 am. The length of the interview will be approximately fifteen minutes. The application materials of the candidate is included for your review. Incumbent candidates (those seeking re-appointment) will not be scheduled for an interview, but information on their attendance are included for your review.
