Summary of Board of Directors  
Personnel Committee Meeting

- 1. Call to Order:** Chairperson Harold Brown called the meeting to order at 10:00 a.m.

Chair Brown requested a brief discussion with Brian Bunger, Legal Counsel on the subject of process for the meetings and past practices. Chair Brown asked if incumbents are serving well, and have few absences could those incumbents be reappointed. Mr. Bunger responded to Chair Brown, that he is correct. Chair Brown asked if this is the case today with the incumbents. Mr. Bunger further stated that the Members are more active than in the past. RECOMMENDED ACTION:

Conduct interviews and consider recommending Board of Directors approval of appointments of candidates to fill the Public Health Agency Member position on the Air District's Advisory Council Board.

BACKGROUND

Pursuant to Section 40262 of the California Health and Safety Code the Air District shall maintain an Advisory Council that consists of 20 members who preferably are skilled and experienced in the field of air pollution, including at least three representatives of public health agencies, at least four representatives of private organizations active in conservation or protection of the environment within the bay district, and at least one representative of colleges or universities in the state and at least one representative of each of the following groups within the bay district: regional park district, park and recreation commissions or equivalent agencies of any city, public mass transportation system, agriculture, industry, community planning, transportation, registered professional engineers, general contractors, architects, and organized labor.

DISCUSSION

A Public Health Agency member resigned effective April 16, 2008. One applicant applied, was screened, and qualifications determined for the position. The applicant possessed the necessary qualifications required for the position.

The interview of the applicant will take place on Friday, May 2, 2008 and will begin at 9:40 am. The length of the interview will be approximately fifteen minutes. The application materials of the candidate is included for your review.
