**ATTENTION: ASBESTOS DEMOLITION & RENOVATION CONTRACTORS**  
**SUBJECT: OPERATION FEES INCREASE**

On June 6, 2007, the Air District Board of Directors approved a new fee schedule for asbestos operations (demolitions and renovations). The new fees apply to notifications postmarked on or after July 1, 2007. Full payment of fees is required at the time of notification submittal. The fee schedule for Asbestos operations is published in Schedule L of Regulation 3 (see reverse).

**SCHEDULE L**  
**ASBESTOS OPERATIONS**  
(Adopted July 6, 1988)

1. Asbestos Operations conducted at single family dwellings are subject to the following fees:
  - a. OPERATION FEE: \$93 for amounts 100 to 500 square feet or linear feet.  
\$343 for amounts 501 square feet or linear feet to 1000 square feet or linear feet.  
\$499 for amounts 1001 square feet or liner feet to 2000 square feet or linear feet.  
\$686 for amounts greater than 2000 square feet or linear feet.
  - b. Cancellation: \$45 of above amounts non-refundable, for notification processing.
  
2. Asbestos Operations, other than those conducted at single family dwellings, are subject to the following fees:
  - a. OPERATION FEE: \$264 for amounts 100 to 159 square feet or 100 to 259 linear feet or 35 cubic feet  
\$382 for amounts 160 square feet or 260 linear feet to 500 square or linear feet or greater than 35 cubic feet.  
\$555 for amounts 501 square feet or linear feet to 1000 square feet or linear feet.  
\$818 for amounts 1001 square feet or liner feet to 2500 square feet or linear feet.  
\$1,167 for amounts 2501 square feet or linear feet to 5000 square feet or linear feet.  
\$1,602 for amounts 5001 square feet or linear feet to 10000 square feet or linear feet.  
\$2,038 for amounts greater than 10000 square feet or linear feet.
  - b. Cancellation: \$126 of above amounts non-refundable for notification processing.
  
3. Demolitions (including zero asbestos demolitions) conducted at a single-family dwelling are subject to the following fee:
  - a. OPERATION FEE: \$45
  - b. Cancellation: \$45 (100% of fee) non-refundable, for notification processing.
  
4. Demolitions (including zero asbestos demolitions) other than those conducted at a single family dwelling are subject to the following fee:
  - a. OPERATION FEE: \$188
  - b. Cancellation: \$126 of above amount non-refundable for notification processing.
  
5. Asbestos operations with less than 10 days prior notice (excluding emergencies) are subject to the following additional fee:
  - a. OPERATION FEE: \$312
  
6. Asbestos demolition operations for the purpose of fire training are exempt from fees.
  
7. Floor mastic removal using mechanical buffers and solvent is subject to the following fee:
  - a. OPERATION FEE: \$188
  - b. Cancellation: \$126 of above amount non-refundable for notification processing.
