CLASSIFICATION OF NEW INN PRODUCTS (WHO LIST 80)

(Item V.5 on Agenda)

Reference documents:

42.825 (SSC/14) 42.850 Annex A/3 (SSC/14 - Report)

I. BACKGROUND

- 1. The Scientific Sub-Committee, at its 14th Session (February 1999), discussed the classification of certain INN products and pharmaceutical intermediates (see Annex A/3 to Doc. 42.850, Report SSC/14).
- 2. Concerning the classification of new INN products (WHO List 80), the Sub-Committee decided to follow the same review procedure that it had applied to WHO List 78, since the working document (Doc. 42.825) had only been published immediately prior to the meeting. Therefore, delegates to the Scientific Sub-Committee were requested to submit their comments on the proposed classifications mentioned in the Annex to Doc. 42.825 to the Secretariat. The agreed classifications, after receiving the approval of the Chairman of Scientific Sub-Committee, would be submitted to the 23rd Session of the Harmonized System Committee.

II. SECRETARIAT COMMENTS

3. As of 24 March 1999, the Secretariat has received comments from Canada, Japan, Switzerland and the United Kingdom. Taking into account the comments received, the Secretariat has prepared a list of INNs on which there appears to be a consensus as to classification. This list is identified in the Annex to this document as "Agreed classification" in the Remarks column. The classifications considered to be agreed by delegates to the Scientific Sub-Committee and the corresponding INNs (49 cases) are indicated in **bold** type. The Annex also incorporates the list of products on which there were different views as to classification (27 cases). The proposed classifications in these cases have been placed in square brackets.

- 4. The Secretariat forwarded the proposed classifications to the Chairman of the Scientific Sub-Committee for approval. On 1 April 1999, the Secretariat received a reply from the Chairman of the Scientific Sub-Committee, conveying his approval of the agreed classifications indicated in **bold** type in the Annex.
- 5. Based on the comments received from administrations and the Chairman of the Scientific Sub-Committee, the Committee is invited to approve the proposed classifications of these 49 INN products.
- 6. The classification of the remaining INN products (27 cases for which the proposed classification have been placed in square brackets in the Annex) will be submitted to the next (15th) Session of the Scientific Sub-Committee in January 2000.

III. CONCLUSION

7. The Committee is invited to approve the classifications of 49 INN products indicated in **bold** type in the Annex.
