SURVEY ON FREE TRADE AGREEMENTS

(Item II. 9 on Agenda)

I. INTRODUCTION

- 1. The Secretariat's annual survey "to determine the percentage of national revenues represented by Customs duties" shows that Customs tariffs continue to play an important role in the economies of many countries including developing countries even though the importance is gradually decreasing (see Agenda Item II.8). According to this survey, the average of percentages of national revenues represented by Customs duties for 146 countries, territories and economic unions using the Harmonized System for whom published data were available decreased from 19.78 % in 1994 to 16.89 % in 1998.
- 2. Such a rapid reduction in the average of percentages of national revenues represented by Customs duties can be explained by two types of efforts to reduce or eliminate tariff barriers and to increase trade. The first type of effort involves the rapidly increasing use of regional free trade agreements (hereinafter referred to as "FTAs") and second involves the multilateral trade system administered by the WTO. These efforts have steadily decreased duty rates and, consequently the shares of Customs duties in terms of national revenues in almost all nations.
- 3. All WTO Members are bound to notify the WTO of the regional trade agreements (hereinafter referred to as "RTAs") in which they participate. It should be noted that RTAs consist of FTAs as mentioned above plus preferential trade arrangements between developing countries and agreements in the area of trade in services. According to the WTO, during the period 1948-1994, the GATT received 124 notifications of RTAs relating to trade in goods and since the creation of the WTO in 1995, 90 additional arrangements covering trade in goods and services have been notified. Out of the total of 214 agreements so far notified to the GATT/WTO, 134 are currently in force. Most of the discontinued RTAs have been superseded by redesigned agreements among the same signatories.

4. To provide accurate information to all member administrations about FTAs, the Secretariat decided to undertake a survey.

II. SECRETARIAT SURVEY

- 5. This survey is based on information obtained mainly from the websites which are provided by multinational organizations such as the WTO, World Bank, and IMF. Because the WTO has 140 Members and all WTO Members are bound to notify RTAs in which they participate, this survey has largely relied on information from the WTO. Some information was added to cover non-WTO Member information and the survey was limited only to trade in goods.
- 6. For the purposes of this survey, a <u>Customs or economic union</u> (hereinafter referred to as "Customs union") was understood to mean an entity within which duties and other restrictive regulations of commerce were eliminated with respect to substantially all the trade between the constituent countries and/or territories (hereinafter referred to as "countries") of the union, or at least with respect to substantially all the trade in products originating in such countries, and that substantially the same duties and other regulations of commerce were applied by each of the members of the union to the trade of countries not included in the union. A <u>free trade area</u> was understood to mean a group of two or more countries in which the duties and other restrictive regulations of commerce were eliminated on substantially all the trade between the constituent countries in products originating in such countries but that each member would set its own duty rates on imports from non-members.
- 7. Annex I to this document provides some information on FTAs such as the number of members of the FTA, names of the member countries, date of entry into force, etc. Among the 104 FTAs listed most (85.6 %) were established among or with European countries including the EC and/or EFTA countries. Except for seven Customs unions, all of the other agreements cover free trade areas.
- 8. Annex II sets out trade information for 1998 for all countries which had FTAs at the end of the year 2000. It includes total import value, import value from FTA member countries and shares of imports from FTA member countries for each country. The EC, EFTA and CEFTA countries, have established FTAs with 30 countries or more and more than 70 % of total imports come from FTA member countries.
- 9. Annexes III and IV show the distribution of country groups with different levels of the shares of imports from FTA member countries in terms of total import value in 1998. In the case of 26 countries, more than 70 % of the total import value came from FTA member countries. For more than one-third (46 countries) of the 126 FTA member countries, over 50 % of total imports came from FTA member countries. The average of all shares of imports from FTA member countries in terms of total import value was 56.97 % and almost half (2,416.3 US billion dollars (42.9 %)) of total world trade of goods (5,635.9 US billion dollars) was traded among FTA member countries.

III. SECRETARIAT COMMENTS

- 10. In view of the foregoing, it can be seen that FTAs play a very important role in world trade. 126 countries are involved in one or more FTAs and almost half (42.9 %) of world trade occurs between FTA member countries. Moreover, as the number of FTAs increases, the share of imports subject to free rates of duty will increase.
- 11. This trend raises two considerations in respect of the Harmonized System :
 - Since FTAs eliminate Customs duties between members as against non-members, the HS is essential for that purpose. Trade statistics based on the HS will also be essential to that end. Therefore, the Harmonized System plays an important role in the development and implementation of FTAs.
 - Since FTAs allow duty free entry for all goods originating in FTA member countries as against non-members, preferential rules of origin are essential and the HS is crucial to FTAs whose rule of origin is based on change in tariff classification.

IV. CONCLUSION

12. The Committee is requested to take note of the results of the Secretariat's survey and to suggest ways in which we might improve this survey in the future.


