- 3. With respect to the list with e-mail addresses of Harmonized System officials in Customs administrations, the Secretariat would like to invite administrations to verify the data contained in the list (which is reproduced in the Annex to this document), and, if necessary, to inform the Secretariat about any data that needs to be updated. In addition, officers of Customs administrations having e-mail connections but not listed, are invited to inform the Secretariat whether they wish to be included in this publication.
- 4. In February 2003, the Secretariat launched the documentation database. This database provides access to the historical documentation (working documents and reports) of the Harmonized System Committee of the WCO and will be updated periodically with the working documents and reports of the latest meetings of the Harmonized System Committee and its Sub-Committees. Historical documents from earlier sessions of the Committee will also be added as resources allow. The database does not contain current working documents relating to questions which are still under examination by the Harmonized System Committee. Working documents and reports of the HS Working Parties (Groups) and Sub-Committees are included in this database until the Harmonized System Committee and/or the Council have concluded their examination of the questions. Furthermore, this database does not contain WCO publications relating to the Harmonized System, which are offered for sale to the public, and/or are made available on the WCO Web site to paying subscribers.
