Scientific Program

The main program will comprise a mix of *platform and poster presentations* and *topical discussions*. The scientific focus of the meeting will be on *in situ* passive samplers for environmental monitoring and risk assessment. Other subjects may include the use of passive samplers to carry out surveillance, operational, and investigative monitoring that are necessary to meet the needs of regulatory agencies. With the continued maturation of passive sampling tools, this upcoming meeting will also offer more 'hands-on' discussions to tackle specific practical applications of these tools.

This meeting will be beneficial to *scientists* (experts to first-time users), *policy makers* (regulatory authorities, accreditation bodies), and *end users* (companies, laboratories, and municipalities) that have a need for monitoring environmental pollution.
